We have performed an audit of the accompanying financial statements of Hannibal Clinic Operations, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of September 30, 2023 (in liquidation), and the related statement of changes in net assets available for benefits (in liquidation) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hannibal Clinic Operations, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

As a result, the Plan changed its basis of accounting to the liquidation basis. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

**A. Description of Plan**

The following description of Hannibal Clinic Operations, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering all full-time employees of Hannibal Clinic Operations, LLC (the Company) who have at least one (1) hour of service during the first three (3) months of employment or credited with a year of service (1,000 hours) and are age eighteen (18) or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by EPIC Advisors, Inc., and is advised by a board of trustees. The assets of the Plan are managed by Moneta Group Investment Advisors.

On December 29, 2021, the Plan sponsor adopted a resolution to terminate the Plan effective December 31, 2021. All participants were fully vested in their account balances as of December 31, 2021, and the account balances were liquidated and distributed to participants as soon as administratively practicable after that time. The Company adopted amendments to the Plan discontinuing all contributions as of December 31, 2021, and terminated the Plan as of that date. As a result of this decision, management determined liquidation was imminent and the Plan adopted the liquidation basis of accounting. Management expects there to be little to no effect on the financial statements.

On May 18, 2023, the Plan received a favorable determination letter from the IRS finding that the termination of the Plan does not affect its qualification for federal tax purposes. As a result, Plan participants' investment account balances were liquidated as of September 30, 2023.

**2. Eligible Employees**

Employees are considered eligible and may participate in the Plan once they meet the eligibility requirements. Excluded employees include members of a collective bargaining unit, non-resident aliens, leased employees, and PRN employees.

**3. Contributions to the Plan**

Contributions to the Plan consist of the following:

- (a) Employee Contributions - The total amount of the salary reduction elected to defer by employees. There are two types of salary deferrals available to employees, pre-tax 401(k) deferrals and Roth 401(k) deferrals. The maximum salary reduction for the 2023 calendar year is \$22,500. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions of \$7,500 for the year ending September 30, 2023. There were no deferrals for the Plan year ended September 30, 2023.
- (b) Employer Profit Sharing Contribution - The Employer may make a discretionary profit-sharing contribution to the Plan. Employees are eligible to receive this contribution if the employee is employed on the last day of the Plan year regardless of the amount of service completed during the Plan year. There was not a profit sharing contribution for the Plan year ended September 30, 2023.
- (c) Employer Safe Harbor Matching Contribution - The Employer may commit to making a Safe Harbor non-elective contribution to the Plan. A matching contribution equal to 100% of a participant's salary deferral, limited to a maximum of 4% of eligible compensation. There was not a safe harbor match contribution for the Plan year ended September 30, 2023.

**A. Description of Plan (Concluded)**

**4. Transfers from Qualified Plans (Rollovers)**

At the discretion of the Administrator, employees may be permitted to deposit into the Plan distributions employees have received from other plans. There were no rollovers into the Plan for the year ending September 30, 2023. Rollovers will be placed in a separate account called a "participant's rollover account". Employees are 100% vested in their "rollover account".

**5. Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's contribution, Plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Investments**

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

**7. Vesting**

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participant accounts is based on years of continuous service. Employees vest 20 percent per year after completing two years of service until becoming 100 percent vested after six years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of the age of 65. However due to the termination of the plan, participants became 100 percent vested in the Company's contribution portion of participant accounts regardless of service.

**8. Notes Receivable from Participants**

The Plan permits participants to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions and notes must be fully repaid within five years. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest.

**9. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various forms of annuities, as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**10. Forfeited Accounts**

During the year ended September 30, 2023, there were no forfeited non-vested accounts.

**B. Summary of Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Estimates***

The preparation of financial statements in conformity with the liquidation basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2023.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**C. Investments**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Fidelity Personal Trust Company, the custodian of the plan, and furnished to the Plan's management. The Plan's management has obtained certifications from the custodian that the information is complete and accurate as of and for the years ended September 30, 2023.

1. Total investments as shown in the accompanying statements of net assets (in liquidation) available for plan benefits of \$0 as of September 30, 2023.
2. Net investment earnings (loss) as shown in the accompanying statements of changes in net assets (in liquidation) available for benefits of \$5,110,745 for the year ended September 30, 2023.
3. All investment-related information in the accompanying supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) is as of September 30, 2023.

**D. Tax Status and Uncertain Tax Positions**

The Company has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated June 30, 2020, that the Plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**E. Party-In-Interest Transactions**

Investment fees paid to the custodian amounted to \$79,623 for the year ended September 30, 2023. Additional investment fees paid to the investment custodian are netted against investment returns.

**F. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets (in liquidation) available for benefits.

**G. Subsequent Events**

The Plan administrator has evaluated events and transactions subsequent to the statement of net assets (in liquidation) available for benefits date through the date of the independent auditor's report (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements.
