Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cregger Company, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 9, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period ended January 9, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution, Ascensus Trust Company ("Trustee"), as of January 9, 2023 and December 31, 2022, and for the period ended January 9, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the management of Cregger Company, Inc. 401(k) Plan approved a transfer of Plan assets to the plan of an acquired company on January 9, 2023. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Cregger Company, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. In late 2021, Cregger Company, Inc. acquired Rampart Supply, Inc. Effective January 9, 2023, Cregger Company, Inc. transferred the Plan assets to Principal Financial Group and merged Cregger Company’s Plan into Rampart Supply’s Plan.

General – The Plan was a defined contribution plan established on December 31, 1982 and was offered to employees of Cregger Company, Inc. (the “Company”), the Plan Sponsor. The Company is a plumbing, heating, ventilation, and air conditioning distributor operating primarily in the southeastern United States.

Trustee and Administration of the Plan – The trustee of the Plan was Ascensus Trust Company (the “Trustee”). The recordkeeper of the Plan was Ascensus, LLC (“Recordkeeper”). The administrator of the Plan was the Company. The Trustee held all assets of the Plan in accordance with the service provider contract with the Company. The Board of Directors of the Company was responsible for oversight of the Plan.

Eligibility – All employees who are at least 21 years of age and have completed one year of service were eligible to participate in the Plan.

Participant Accounts – Each participant’s account was credited with the participant’s contributions, rollover contributions, and allocations of the Company’s contributions, as applicable, and Plan earnings and then charged with Plan losses and an allocation of Plan expenses. Allocations were based on participant earnings and account balances, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting Participant contributions were fully vested and nonforfeitable at all times. Vesting in the Company’s safe harbor matching contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after 5 years of credited service.

Notes Receivable from Participants A participant could borrow from the Plan, subject to the approval of the Plan administrator. A participant may have only one outstanding loan at a time. A participant with an existing loan could not apply for another until the outstanding loan is repaid. A participant could not refinance an existing loan, apply for more than one loan during each calendar year, or apply for an additional loan for the purpose of paying off an existing loan. The minimum borrowing was \$1,000. The IRS limited the maximum amount a participant can borrow at the lesser of \$50,000 or half the amount the participant has vested in the Plan.

The loans were secured by the balance in the participants’ accounts and bore interest at a rate comparable to similar loans from commercial lending institutions. Interest rates on outstanding loans were fixed and ranged from 3.25% to 7.00%. Principal and interest were collected through payroll deductions.

Note 1. Description of the Plan (continued)

Forfeited Accounts – Forfeiture balances were \$0 at January 9, 2023 and December 31, 2022, respectively. Non-vested participant account balances of terminated participants were forfeited in the subsequent Plan year and allocated to the remaining participants as an employer contribution. Forfeitures were also used to reduce future employer contributions to the Plan. No forfeitures were used in 2023 or 2022 to reduce employer contributions.

Funding – The Company’s policy was to fund the Company match of participant deferrals within the Department of Labor’s required timeframes.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates – The preparation of the financial statements in conformity with GAAP requires Plan Management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates. The most significant estimate affecting the Plan was the fair value of the investments.

Concentrations of Credit Risk - All Plan assets were invested with the Trustee. Such investments were subject to credit and market risk associated with (1) the credit worthiness of the Trustee, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions.

Investment Valuation and Income Recognition – Purchases and sales of funds were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and were not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Earnings on investments are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances.

Notes Receivable from Participants The notes receivable were measured at carrying value, which was the remaining unpaid balance, and were considered delinquent and written off as a deemed distribution when 90 days past due. No allowance for loss on receivables from participants was provided based on loans being secured by the participants’ balance.

Note 3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of January 9, 2023 and December 31, 2022;
- Net appreciation in fair value of investments as shown in the statement of changes in net assets available for benefits for the period ended January 9, 2023.

Note 4. Fair Value Measurements

During the period ended January 9, 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated by approximately \$181,000. Gains and losses (realized and unrealized) included in the accompanying statement of changes in net assets available for benefits for the period ended January 9, 2023 are reported in net appreciation (depreciation) in fair value of investments, and changes in fair value as reported in the accompanying statement of changes in net assets available for benefits primarily relate to mutual fund activity.

Fair Value Measurements - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date.

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 9, 2023.

Mutual Funds - These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Interest-bearing cash: Valued at actual cash value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan invested in various investment securities. Investments in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6. Plan Termination

As previously described, in late 2021, Cregger Company, Inc. acquired Rampart Supply, Inc. Effective January 9, 2023, Cregger Company, Inc. transferred the Plan assets to Principal Financial Group and merged Cregger Company's Plan into Rampart Supply's Plan.

Note 7. Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of January 9, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of January 9, 2023, for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through December 12, 2023, the date these financial statements were available to be issued, there were no subsequent events that required disclosure in these financial statements.
