## **INDEPENDENT AUDITOR'S REPORT**

To the Participants and Plan Administrator of  
INOC, LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of INOC, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 31, 2023 (in liquidation) and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended May 31, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of INOC, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2023 and December 31, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of INOC, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As discussed in Note A to the financial statements, the Plan administrator approved a plan of liquidation in December 2022 and the Plan was terminated on May 31, 2023. As a result, the Plan changed its basis of accounting from the accrual basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about INOC, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

A. Description of Plan

The following description of the INOC, LLC 401(k) Plan (“Plan”) of INOC, LLC (“Company”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. *General.* The Plan was a defined contribution plan covering employees of the Company who had six months of service, had attained age 21, and were not excluded employees. Excluded employees were employees who became employees as a result of Code §410(b)(6)(C) transaction until the end of the transition period. It was subject to the provisions of the Employee Retirement Income and Security Act (ERISA) of 1974.

INOC, LLC, the Plan sponsor, was sold on February 1, 2023. The Plan notified the participants of its intent to terminate the Plan in December 2022. No further contributions were accepted after March 17, 2023, and final distributions from the Plan were made May 31, 2023. As a result, the Plan changed its basis of accounting from the accrual basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the financial statements for the period ending May 31, 2023.

2. *Contributions.* Each year, participants could contribute up to 100% of their pretax annual compensation, up to a maximum of \$22,500 in 2023 and \$20,500 in 2022, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The company could make a discretionary matching contribution equal to a uniform percentage of each tier of the employee’s salary deferrals. During the five-month period ended May 31, 2023 and for the year ended December 31, 2022, the Company matched 50 percent of each participant’s first 6 percent of contributions for the Plan year for eligible employees. In addition, the Company could also make a discretionary profit-sharing contribution during any Plan year. There were no discretionary profit-sharing contributions made to the Plan for the Plan years ending May 31, 2023 and December 31, 2023. The Plan also provided that participants who were age 50 or older, and who were making contributions to the Plan could also make a catch-up contribution (not previously made) of up to \$7,500 in 2023 and \$6,500 in 2022. Contributions were subject to certain IRS limitations.
3. *Participant Accounts.* Each participant’s account was credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s profit sharing contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account balance.
4. *Vesting.* Participants were immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon was based on years of continuous service. A participant was 100 percent vested after five years of credit service.

5. *Notes Receivable from Participants.* Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50 percent of the vested portion of their account balance, not to exceed \$50,000. The notes were secured by the balance in the participant's account and bore interest at a reasonable rate determined by the Plan administrator. The note was required to be paid (principal and interest) in amortized level payments, not less frequently than quarterly, over a period not extending beyond five years from the date of the note; provided, however, that if the proceeds of the note would be used to purchase a principal residence of the participant, the Plan administrator could permit a longer repayment term.
6. *Payments of Benefits.* On termination of service due to death (beneficiary), disability or retirement, a participant could elect to receive an amount equal to the value of the participant's vested interest (100 percent upon death) in his or her account in either a lump sum amount, annuity, or installments. Alternatively, participants could choose to defer receipt of their distribution until, by law, minimum distributions were required. However, if the participant's vested account balance was \$5,000 or less, the balance would be distributed in a lump-sum payment. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her accounts as a lump sum distribution.
7. *Forfeited Accounts.* Forfeitures were retained in the Plan and could be used to pay administrative expenses or could be used to reduce future Company contributions payable under the Plan. As of May 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0. For the period ended May 31, 2023, the amount used as employer contributions totaled \$8,397.

B. Summary of Accounting Policies

*Basis of Accounting*

The financial statements of the Plan for the period ending May 31, 2023 were prepared using the liquidation basis of accounting. The 2022 financial statements were prepared using the accrual basis of accounting.

*Investment Valuation and Income Recognition*

There were no investments remaining at May 31, 2023. At December 31, 2022, investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

*Fully Benefit-responsive Investment Contracts*

As part of its investment mix, the Plan had a general account-backed, stable value group annuity contract. Benefit payments were made at book value (i.e., no termination or surrender charge) for plan benefit events and investment transfers initiated by plan participants. Thus, these contracts were considered benefit responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As required by the applicable accounting guidance, the Statements of Net Assets Available for Benefits and Statement of Changes in Net Assets Available for Benefits are prepared on a contract value basis for fully benefit-responsive investment contracts.

*Notes receivable from participants*

Notes receivable from participants were measured at their unpaid principal balance. Interest income was recorded when received. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded for the year ending May 31, 2023. If a participant ceased to make loan repayments and the plan administrator deemed the participant to be in default, the participant loan was reduced and a benefit payment was recorded.

*Payment of Benefits*

Benefits were recorded when paid.

*Risks and Uncertainties*

The Plan provided for various investment options in a combination of mutual funds. Investment securities were exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

*Estimates*

Management used estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts and disclosures. Actual results could differ from those estimates.

*Expenses*

Fees related to the administration of notes receivable and distributions from participants were charged directly to the participant's account and were included in administrative expenses. Fees for services to the Plan were paid through forfeitures. Investment related expenses were included in net appreciation of fair value of investments.

C. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at May 31, 2023 and December 31, 2022, and net appreciation fair value of investments, interest and dividends, and interest income on notes receivable from participants for the five-month period ended May 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company, the trustee of the plan.

D. Plan Termination

The Company terminated the Plan on May 31, 2023, the date all Plan assets were fully distributed. In accordance with the Plan provisions, participants became fully vested in their account balances at the time the Plan was terminated. See Note A for more information.

E. Tax Status

The Internal Revenue Service had determined and informed the Company that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax exempt.

Accounting principles in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator had analyzed tax positions taken by the Plan, and had concluded that as of May 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Related-Party and Party-In-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. The Plan investments were shares of mutual funds managed by American United Life Insurance Company. American Life Insurance Company was the trustee as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the plan for the investment management services were included in net appreciation in fair value of the investments on the statement of changes in net assets held for benefits. The Plan made a direct payment to the third-party administrator for the period ended May 31, 2023, of \$13,797 for administrative expenses.

G. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, if fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). An exit price valuation will include margins for risk even if they were not observable. As the Plan was released from risk, the margins for risk would also be released through net realized capital gains (losses) in changes in net assets. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

G. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in inactive markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of the three valuation techniques:

- Market approach – Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities.
- Cost approach – Amount that would be required to replace the service capacity of an asset (replacement cost).
- Income approach – Techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option pricing models, and lattice models).

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

There had been no changes in the methodologies used at May 31, 2023.

Interest bearing cash: Valued at quoted market prices.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Guaranteed investment contract: The fair value of the guaranteed investment contract has been determined to approximate contract value. Contract value was based upon a cost approach, which was equal to principal plus accrued interest.

The preceding methods described may produce a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

H. Investment Contract with Insurance Company

The Plan had a group annuity contract with American United Life Insurance Company (AUL). AUL maintained the contributions in a general account. The contract was benefit-responsive, in that the full contract value was accessible, but not all at once in the case of certain transfers. The methodology for calculating the interest crediting rate was based on expected returns on investments made and held within the General Account, it would always equal or exceed the contractually guaranteed rate. The interest crediting rate was reset annually. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the plan.

Participant-initiated transfers between funds always occur at contract value, but the full amount could not be accessible from the General Account at one time. No more than 20% of the participant's General Account Value as of the first day of that Contract Year could be transferred during the Contract Year, unless such General Account Value was less than \$2,500 on the first day of that Contract Year in which case the participant could transfer any amount from the General Account during the Contract Year.

I. Subsequent Events

The Plan had evaluated subsequent events through December 13, 2023, the date the financial statements were available to be issued. No additional subsequent events require disclosure.
