Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the accompanying financial statements of **Pear Therapeutics (US) 401(k) Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. All Plan assets were distributed by November 7, 2023. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Notes to Financial Statements

Note 1: Description of the Plan

The following description of the Pear Therapeutics (US) 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was a voluntary defined contribution plan established on January 1, 2018, to provide retirement and other related benefits to eligible employees of Pear Therapeutics (US), Inc. (the "Company"). All eligible employees became participants unless they elected not to participate. An employee who was age 21 or older became eligible to participate for purposes of salary reduction contributions upon hiring. Pear Therapeutics (US), Inc. was the Plan Sponsor, Ascensus Trust Company was the Trustee and Custodian, and the Vanguard Group served as the recordkeeper for the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, referred to as ERISA.

Plan Termination: The Company had the right under the Plan to terminate the Plan subject to the provisions of ERISA. On May 26, 2023, the Plan was amended to freeze and terminate, and no further contributions were permitted after that date. Participants were notified that all assets would be transferred out of the plan through a participant directed distribution or by the Plan to an Individual Retirement Account ("IRA") by November, 2023.

Participant Contributions: Each year participants could contribute a portion of their pretax annual compensation, as defined in the Plan, up to certain limitations under the Internal Revenue Code ("IRC"). Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan also allowed contributions to be designated as after-tax Roth deferral contributions. Participants, with the consent of the Plan Administrator, could deposit amounts received from any other retirement plan which satisfied the tax rules for rollovers. The Plan provided for automatic enrollment for all newly eligible employees. Unless the employee elected otherwise, 6% of the employee's eligible earnings were deferred in the Plan.

Employer Contributions: The Plan allowed for Qualified Non-Elective Contributions. During the period from January 1, 2023 through November 7, 2023, the Company did not make a qualified non-elective contribution.

Participant Accounts: Each participant's account was credited with the participant's contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Investment Options: Participants directed the investment of contributions into various investment options offered by the Plan.

Vesting: Participants were immediately 100% vested in their voluntary contributions, qualified non-elective contributions and rollover contributions, plus the investment earnings that arose from these contributions.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant could have received a lump sum amount equal to the value of the participant's vested interest in his or her account. In addition, a participant could have received an in-service distribution after attainment of age 59.5, or if they had suffered a hardship.

Note 1: Description of the Plan (continued)

Notes Receivable from Participants: Participants could have borrowed from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balances or \$50,000. Loan transactions were treated as a transfer to (from) the investment fund from (to) the participant notes receivable fund. Notes receivable terms could not exceed five years unless for the purchase of a primary residence, which could not exceed thirty years. Loans were secured by the balances in the participants' accounts and were supported by a promissory note. A participant could only have one loan outstanding at any time. Loans bore interest at a set rate of the prime interest rate plus 1.00%. Principal and interest were paid ratably, usually through payroll deductions. If the participant terminated employment or retired, the outstanding loan balance was due.

The Plan Administrator considered a loan in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which the loan was initially considered past due. In the event of default, death, disability, or termination of employment, the entire outstanding principal and accrued interest was immediately due and payable. If the loan balance was unpaid, the unpaid principal portion was deemed a taxable distribution from the Plan.

Forfeited Accounts: At December 31, 2022, forfeited non-vested accounts totaled \$49,343. These funds were used to cover administrative fees associated with the Plan. There were no forfeited accounts as of November 7, 2023.

Note 2: Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan were prepared under the accrual method of accounting in accordance with US generally accepted accounting principles ("GAAP").

Use of Estimates: The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments were reported at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See *Note 4 - Fair Value Measurements*.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in the fair value of the Plan's investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of the fair value of investments.

Risks and Uncertainties: The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could have materially affected the amounts reported in the financial statements.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of November 7, 2023 or December 31, 2022.

Payment of Benefits: Benefit payments to participants were recorded when paid.

Note 3: Tax Status

On September 21, 2017, the IRS stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan had not received a determination letter specific to the Plan itself; however, the Plan Administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and the Plan, and was exempt from federal income taxes under the provisions of Section 401(a) of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 7, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 4: Fair Value Measurements

The fair value of assets and liabilities was determined by using a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity, and the reporting entity's own assumptions about market participant assumptions based on the best information available in the circumstances. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, essentially an exit price. The three levels of the fair value hierarchy are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable and reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4: Fair Value Measurements (continued)

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at November 7, 2023 and December 31, 2022.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date. For the period from January 1, 2023 through November 7, 2023 and the year ended December 31, 2022, there were no transfers of assets into or out of Level 1 and Level 2 of the fair value hierarchy described below.
