## Notes to Financial Statements

November 18, 2022

### **1. Description of the Plan**

The following brief description of the NextStep for Life, Inc. Progress Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### **General**

The Plan was a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective January 1, 1992, and restated most recently on December 1, 2021. The Plan sponsor is NextStep for Life, Inc. (the Company). On July 1, 2022, the Plan sponsor merged with Pony Bird, Inc. The Plan covers all employees of the Plan sponsor who have one year of service and are age twenty-one or older. One thousand hours must be worked during a year for it to count as a year of service. Employee participation in the Plan is voluntary.

#### **Plan Merger**

Effective November 18, 2022, the Plan merged into the Pony Bird Retirement Plan. All assets were transferred to the Pony Bird Retirement Plan effective with the plan merger.

#### **Contributions**

Employees may contribute up to the amount permitted by Internal Revenue Service (IRS) regulations, which was \$20,500 in 2022. Employees who meet certain age requirements are also permitted to make catch up contributions. The Plan also permits rollover contributions. The Company may make discretionary matching contributions as outlined by the Plan agreement and as determined on an annual basis by the Company's board of directors. During 2022, the Company made matching contributions of one hundred percent of employee deferrals up to four percent of eligible compensation. All contributions are subject to maximum amounts as permitted by the Internal Revenue Service (the IRS).

#### **Participant Accounts**

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of investment options as offered by the Plan. Each

participant's account is credited with the participant's contributions, and allocations of the Company's contributions and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

Under the provisions of the Plan, participants are immediately 100 percent vested in their contributions plus actual earnings thereon. Employer contributions vest at 20 percent each year beginning after their second year of service, with full vesting after six years of service as defined by the plan document. The Plan merger did not impact vesting.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account or a partial distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits in-service and hardship withdrawals under certain conditions.

#### **Administrative Expenses**

Substantially all the costs of administering the Plan are paid by the Company. Certain costs such as distribution fees are paid by participants. Plan expenses may be paid by income generated under a revenue sharing arrangement.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

##### **Valuation of Investments and Income Recognition**

Investments are reported at fair value, except for the fixed account which is presented at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability

in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The fixed income account is valued at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value approximates fair value, which is calculated at liquidation value based on an actuarial formula as defined under the terms of the contract. There are no unobservable inputs. There is a one year restriction on redemption of the entire investment in this fund, although there are no restrictions on participant directed investments.

Purchases and sales of securities are accounted for on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest from investments is recorded on the accrual basis. Capital gains received and reinvested are included in investment income (loss). Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### **Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net depreciation of fair value of investments.

##### **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **3. Investment Information Certified by Insurance Company and Trust Company**

All investment information disclosed in the accompanying financial statements and schedule, including investments held at November 18, 2022 and December 31, 2021, and net depreciation in fair value of investments, and interest and dividends for the plan year ended November 18, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Talcott Resolution Life Insurance Company and Great-West Trust Company, LLC, the insurance company and the trust company. All investments are participant directed.

#### **4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**4. Fair Value Measurements (continued)**

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts invest directly in the underlying mutual funds (as indicated by the name of the pooled separate accounts which mirror the names of the underlying mutual funds). The pooled separate accounts with underlying mutual fund investments are valued based on the observable NAV of the underlying investment. There are no restrictions on the redemption of these investments.

There were no assets at November 18, 2022.

#### **5. Group Annuity Contract**

In 2010, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company (TRLIC) (formerly Hartford Life Insurance Company) totaling \$326,674 for 2021. TRLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TRLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material

misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

#### **6. Income Tax Status**

On June 30, 2020, the Internal Revenue Service informed the Company by letter that the Plan is designed in accordance with and qualifies under Internal Revenue Code (IRC) Section 401(a). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position more likely than not, would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 18, 2022 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Administration of Plan Assets**

The Plan's assets are held by the insurance company of the Plan. Employee contributions are held and managed by the insurance company, which invests cash received, interest, and dividend income and makes distributions to participants. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

#### **8. Related Party Transactions**

As noted in Notes 1 and 7, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
