### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Nassau County AHRC Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 22, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through December 22, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 22, 2022 and December 31, 2021, and for the period from January 1, 2022 through December 22, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of the Plan

The following description of the Nassau County AHRC Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document or Summary Plan Description for a complete description of the Plan's provisions.

#### *General*

The Plan was a noncontributory defined contribution pension plan sponsored by NYSARC, Inc. - Nassau County Chapter (the Chapter) and was adopted on January 1, 1991. The Plan covered substantially all personnel who have completed six months of service, are at least age 20½ as of the beginning of the Plan year, and must have completed 1,000 or more hours of service by the end of the Plan year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective December 22, 2022, the Plan was merged into The Arc New York Affiliated Employers 401(k) Plan (the Arc New York Plan). All assets and participant accounts were transferred into the Arc New York Plan on December 22, 2022, and the Chapter became a participating employer of the Arc New York Plan, with their employees being eligible to participate.

#### *Contributions*

The Plan did not allow employee contributions. The Chapter could have made discretionary profit-sharing contributions at the amounts to be determined annually by the Chapter to employees who met the eligibility requirements of the Plan.

#### *Participant Accounts*

Each participant's account was credited with the allocations of the Chapter's contributions and the related net earnings and losses thereon and was charged for withdrawals and certain administrative expenses. Investments of participant accounts were invested in accordance with the default investment alternatives established under the Plan unless a participant made a change in their investment election. The benefit to which a participant was entitled was the vested portion of their account.

#### *Vesting*

Vesting in contributions and any income or loss thereon was based on years of continuous service. Participants were 100% vested after three years of credited service and 0% vested until they reached three years of credited service.

### ***Notes Receivable from Participants***

Participants could have borrowed from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans were secured by the vested balance in the participant's account. Loans were secured by the participant's account and bore interest at the prime rate plus 1%. A participant could have had a maximum of one loan outstanding at any time. Principal and interest repayments were made through direct payments from the participant in accordance with an amortization schedule. Upon termination of employment, a participant was required to pay off the balance of the loan. Otherwise, the unpaid balance would be treated as a deemed distribution to the participant and taxable income in the year the deemed distribution occurred.

### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant could have elected to receive either a lump-sum amount equal to the value of the participant's vested account balance or installments over a period of time, determined in accordance with the Plan agreement.

### ***Normal Retirement Benefits***

Under the terms of the Plan, participants were eligible for normal retirement upon reaching age 65 and early retirement upon reaching age 60, provided that they had completed ten years of service. Payments of benefits were in the form of a lump-sum distribution or a purchased-annuity contract. The distribution method was selected by the participant upon reaching normal retirement age or early retirement. The amount of benefits was based upon the participant's vested balance in his or her account.

### ***Forfeitures***

At December 22, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$6,275, respectively. Forfeitures could have been used to pay Plan administrative expenses or offset employer contributions. Approximately \$9,571 of forfeited funds were used to offset employer contributions in 2022.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Investment Valuation and Income Recognition***

The Plan's investments were stated at fair value, with the exception of the fully benefit-responsive investment contract, which was stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fully benefit-responsive investment contract (see Note 4) was valued at contract value.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### ***Payment of Benefits***

Benefits were recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Chapter. Expenses that were paid by the Chapter were excluded from these financial statements. Fees related to participant-initiated transactions were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net depreciation in fair value of investments.

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, as well as disclosures of contingent assets and liabilities. Actual results could have differed from those estimates.

### ***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses was recorded as of December 22, 2022 and December 31, 2021, respectively. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 22, 2022 or 2021. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Guaranteed Investment Contract* - Guaranteed investment contract was stated at contract value, which approximates fair value. The contract value equaled the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers.

*Pooled Separate Accounts (PSA)* - Pooled separate accounts were valued at the NAV of the units held. The NAV was based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, was determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by TIAA was used as a practical expedient to estimate fair value. NAV was not used if it was probable that the investment would not be traded at NAV. The PSAs provided for daily redemptions by the Plan at reported NAV with no advance notice. There were no unfunded commitments related to these investments. These are direct filing entities.

#### 4. Fully Benefit-Responsive Investment Contract

The Plan had a benefit-responsive investment contract with Empower Life & Annuity Insurance Company of New York (Empower). Empower maintained the contributions in a guaranteed investment account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would have limited the Plan's ability to transact at contract value with participants has not occurred.

### 5. Certified Financial Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 22, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1 to December 22, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, Empower Trust Company, LLC (Empower Trust), Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF), qualified institutions.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

### 6. Party-in-Interest Transactions

Certain Plan investments were managed by Empower, Empower Trust, TIAA, and CREF; therefore, these transactions qualified as party-in-interest transactions. Purchases and sales of these funds were open-market transactions at fair market value. Such transactions were permitted under the provisions of the Plan and were exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder.

Notes receivable from participants also qualified as party-in-interest transactions.

### 7. Tax Status

The Plan obtained its latest determination letter in January 2016, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRS. The Plan has since been amended and restated; however, the Plan administrator believed the Plan was designed and was operated in compliance with the applicable requirements of the Internal Revenue Code and qualified for tax-exempt status.

Under GAAP, a plan must recognize the tax benefit associated with tax positions taken for tax return purposes when it is more likely than not that the position will not be sustained upon examination by a taxing authority. The Plan did not believe there were any material uncertain tax positions taken and, accordingly, did not recognize any liability for unrecognized tax benefits under GAAP. The Plan filed Form 5500 as required. For the period from January 1, 2022 through December 22, 2022, there was no interest or penalties recorded or included in the financial statements. The Plan was subject to routine audits by a taxing authority. As of December 22, 2022, the Plan was not subject to any examination by a taxing authority.

### **8. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the financial statements.

### **9. Plan Termination**

The Chapter had the right under the Plan terms to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balances. The Chapter did not exercise its right to terminate the Plan and, as noted in Note 1, the Plan was merged into the Arc New York Plan effective December 22, 2022.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through January 4, 2024, the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments to the financial statements or disclosures stated therein.
