INDEPENDENT AUDITORS' REPORT

To the Participants and Health Plan Trustees of the
F & M Mafco Employee Health Plan Trust

Opinion

We have audited the financial statements of F & M Mafco Employee Health Plan Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and the statements of plan benefit obligations as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of F & M Mafco Employee Health Plan Trust as of December 31, 2022 and 2021, and the changes in its net assets available for benefits and the changes in plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. DESCRIPTION OF PLAN:

The following description of the F & M Mafco (Sponsor, Employer and Administrator) Employee Health Plan Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Termination

On May 2, 2022, the Plan Sponsor was purchased by American Equipment Co, Inc. (AMECO). The Board of Directors of the Plan subsequently unanimously consented to terminate the Plan and its Trust effective December 31, 2022.

General

The Plan provides medical, dental, long-term disability and life insurance benefits covering substantially all employees of the Sponsor. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All benefits are fully-insured, with the exception of medical and prescription benefits.

Eligibility

The Plan provides benefits to participating full-time employees of the Sponsor who have satisfied an eligibility period of 30 consecutive days from date of employment. The Plan was frozen for new enrollments as of May 2, 2022 when the Plan Sponsor finalized its' sale.

Contributions

The Plan agreement provides that the Sponsor make contributions to the Plan whenever necessary to cover claim payments per notification from the claims administrator. Employees contribute specified amounts, determined by the Sponsor, based on their level of participation.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Payment of benefits

Claims are recorded when paid.

Estimates

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events

The Plan has evaluated subsequent events through January 3, 2024, the date the financial statements were available to be issued.

3. INCOME TAX STATUS:

The Plan has received a favorable letter of determination from the Internal Revenue Service indicating that on the basis of the facts supplied, the Plan is exempt from Federal income tax under Section 501(c)(9) of the Internal Revenue Code.

4. DESCRIPTION OF TRUST:

The F & M Mafco Employee Health Plan Trust established a trust for the benefit of participating employees. The Trust holds all the assets of the Plan and is funded by F & M Mafco, Inc. and its participating employees. Anthem Blue Cross and Blue Shield administers payment of claims.

5. INSURANCE PREMIUMS:

Payments for insurance premiums primarily represent amounts paid to the insurance carrier for a reinsurance policy. The reinsurance policy limits the amount of claims to be paid by the Plan per participant on an annual basis. The stop loss limit was \$100,000 for the years ended December 31, 2022 and 2021.

6. SIGNIFICANT ESTIMATE - PLAN BENEFIT OBLIGATIONS:

In accordance with professional standards, the Plan has recognized, in the current year, the estimated costs of continuing health care expected to be incurred in future periods. As permitted by professional standards, these amounts are based on estimates developed by management of the Plan by analyzing claim lag studies. Such amounts are reported at an undiscounted amount because amounts typically are payable within one year. Any differences in amounts estimated and actual amounts will be reported in future years. It is reasonably possible that this estimate will change during the next year.

7. ADMINISTRATIVE EXPENSES:

The Plan pays administrative expenses that consist primarily of administrative fees to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Sponsor on behalf of the Plan and are excluded from these financial statements.
