### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bryan Heart Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2023 and December 31, 2022, the related statements of changes in net assets available for the period from January 1, 2023 to March 31, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

### 1. Plan Description

---

The following description of the Bryan Heart Retirement Savings Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provided retirement benefits for the employees of Integrated Cardiology Group, LLC dba Bryan Heart (the Employer).

In December 2022, the Board of Directors of the Employer voted to merge the Plan into the Bryan Health Retirement Savings Plan (Bryan Health Plan). Union Bank & Trust Company is the custodian of the Bryan Health Plan. The merger into the Bryan Health Plan initiated a "black out" period which initiated on December 31, 2022 and went through the date of the transfer. During the black out period, funds could not be applied to the employee selected funds or withdrawn from the Plan or the Bryan Health Plan until Union Bank & Trust Company had time to accurately complete the merger. Plan assets totaling \$31,413,168 were transferred into the Bryan Health Plan in March 2023. Also, participants began making payroll contributions to the Bryan Health Plan in January 2023.

#### ***Eligibility***

The Plan was available to all covered employees who were at least 21 years of age. Employees were eligible to participate with respect to contributions on the first payroll date following their date of hire.

Non-physician employees were eligible to receive qualified matching contributions (the Matching Contributions) as of the first day of the month following the attainment of age 21, properly electing to make contributions, and completing one year of service with 1,000 hours. For physician employees, they were eligible as of the first day of the month following the 30-day anniversary of their hire date.

Employees were also eligible to receive discretionary employer contributions (the Employer Contributions) as of the first day of the month following one year of their hire date only if they completed 1,000 hours of service during the Plan year and were employed on the last day of the Plan year.

#### ***Contributions***

Each year, participants could contribute up to 80% of eligible compensation, in connection with the 401(k) or Roth provisions of the Plan. Employees were automatically enrolled at a 4% pre-tax deferral rate upon becoming eligible to participate in the Plan and they could elect to change or discontinue deferrals at any time. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans.

Each pay period, the Employer made Matching Contributions of 100% of the first 5% of compensation contributed to the Plan by non-physician participants and 50% of the first 5% of compensation contributed to the Plan by physician participants. In addition, the Employer could make Employer Contributions to the Plan. There were no Matching Contributions or Employer Contributions made in 2023. The Employer made an Employer Contribution which equaled 2% of the eligible compensation for 2022. Contributions were subject to certain limitations.

### ***Participant Accounts***

Each participant's account was credited with the participant's contribution and allocations of a) the Employer's Matching Contributions and Employer Contributions, b) Plan earnings or losses, and c) charged with his or her withdrawals and an allocation of administrative expenses. The Matching Contributions were allocated among participants based upon the participant's elected salary deferral. The Employer Contributions were allocated among participants based upon a percentage of eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments selected by eligible participant. Investments were maintained in individual member accounts managed by MG Trust Company dba Matrix Trust Company (Matrix).

### ***Vesting***

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Matching Contributions was based on years of continuous service. A participant was 20% vested after one year of credited service and vesting increased 20% per year until a participant was 100% vested after five years of service. Vesting in the Employer Contributions was based on years of continuous service. A participant was 20% vested after two years of credited service and vesting increased 20% per year until a participant was 100% vested after six years of service.

### ***Notes Receivable from Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or one-half of the value of the vested portion of the participant's account balance. The notes were secured by the balance in the participant's account and bear interest at rates that commensurate with local prevailing rates. The term of notes receivable from participants was limited to five years and all principal and interest payments had to be made monthly through payroll deductions.

### ***Payment of Benefits***

Upon termination of service, retirement, death, or disability, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan required that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise. Benefit amounts under \$1,000 would be paid out to the participant in the event the participant did not elect a payout option. For in-service hardship withdrawals, a participant could receive an amount up to the value of the vested interest in his or her account as a lump-sum distribution; this amount would not include earnings on pre-tax deferrals, and the participant had to meet the requirements for a hardship withdrawal as discussed in the Plan document. The Plan

allowed earnings to be available for hardship withdrawals. For qualified in-service withdrawals, a participant could receive an amount up to the value of the vested interest in his or her account as a lump-sum distribution. Benefit payments were recorded when paid.

### ***Forfeitures***

Forfeitures could be applied to reduce Matching Contributions or Employer Contributions or to pay administrative expenses. As of March 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$327, respectively. During the period from January 1, 2023 to March 31, 2023 and year ended December 31, 2022, forfeitures of \$0 and \$29,215, respectively, were applied to offset Matching and Employer Contributions or used to pay administrative expenses.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Risks and Uncertainties***

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Expenses***

Audit fees were paid by the Employer and were excluded from these financial statements. Recordkeeping expenses and other expenses specifically incurred or attributable to individual participants were paid from the applicable participants' accounts. Investment management fees were paid by the Plan and are included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

### ***Notes Receivable from Participants***

Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest were received through payroll deductions and the notes were collateralized by the participants' account balances. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through January 4, 2024, noting no items requiring disclosure.

## **3. Information Certified by Matrix**

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2023 and December 31, 2022.

*Mutual Funds and Money Market Fund:* Valued at the daily closing price as reported by the funds. Mutual funds and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan was qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
