To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Elite Transit Solutions, LLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) [“ERISA Section 103(a)(3)(C) audit”]. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

General. The following description of the Elite Transit Solutions, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of its provisions.

The Plan is sponsored by Elite Transit Solutions, LLC (“Elite”), as defined in the Plan. The Plan is a defined contribution plan that covers all employees of Elite and the employees of the adopting employers, Chameleon Software, LLC and Connect Capital, LLC (collectively with Elite, the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Employer controls and manages the operation and administration of the Plan. Principal Life Insurance Company (the “Trustee”) serves as the trustee and record keeper of the Plan.

All employees over the age of 21 who are legal residents and not represented under a bargaining agreement are eligible to participate in the Plan. Once an employee has met the enrollment requirements, the employee can enroll into the Plan on the first day of the month following 30 days of service.

Participant Contributions. Participants may elect to defer up to 100% of their eligible pretax earnings and after-tax earnings subject to amounts established by the Internal Revenue Code (the “Code”), with no minimum deferral. Eligible pretax earnings consist of total cash compensation paid during the Plan year excluding post-severance compensation. Participants may also contribute “catch-up” contributions and amounts representing rollovers from other qualified benefit or defined contribution plans.

Employer Contributions. The Employer elected to make safe-harbor matching contributions equal to 100% of participant deferrals up to 3% of eligible compensation and 50% of the participant’s deferral of the next 2% of eligible compensation for a maximum Employer safe-harbor matching contribution of 4% per participant. Effective January 1, 2022 and effective February 19, 2022, Employer discretionary contributions and matching contributions, respectively, were removed from the Plan and the participants became 100% immediately vested in such Employer contributions.

Participant Accounts. Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution and allocations of the Employer contributions, Plan earnings and administrative fees. Allocations are based on participant earnings or account balances, as defined in the Plan.

Investment Options. Participants may direct their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to Plan provisions.

Vesting. Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Employer contributions is based upon years of continuous service. A participant will be 100% vested after two years of service. A year of service is defined by the Plan to be a minimum of 1,000 hours of credited service during the Plan year. Effective January 1, 2022 and effective February 19, 2022, the participants became 100% vested in Employer discretionary contributions and matching contributions, respectively.

Forfeited Accounts. Forfeitures shall be applied to offset administrative expenses of the Plan or to reduce Employer contributions made after the forfeitures are determined. There were no forfeitures applied against administrative expenses or Employer contributions for the year ended December 31, 2022. The forfeited non-vested accounts were \$4,050 and \$-0- as of December 31, 2022 and 2021, respectively.

Payment of Benefits. Benefit payments are generally made in a lump-sum upon termination or as defined in the Plan agreement. Early voluntary withdrawals are paid based on financial hardship with approval of the Plan’s administrator (“Plan Administrator”).

NOTE 1 – DESCRIPTION OF PLAN (Concluded)

Party-In-Interest Transactions. Administrative expenses of the Plan are paid by the Employer except for the trustee and recordkeeping fees, which are paid by the Plan. Additionally, various administrative, legal, and accounting services are performed by the Employer's personnel on behalf of the Plan for which no charges are made to the Plan. Investment expenses, however, are charged against the Plan's investment income.

Recent Legislation. The SECURE Act 2.0 was signed into law on December 23, 2022. The SECURE Act 2.0 allows more part-time workers to participate, increases the age for required minimum distributions and reduces the penalty for missed minimum distributions, permits plan participants to elect to receive vested Employer contributions on an after-tax basis, and allows penalty free withdrawal for terminal illness, effective January 1, 2023. Additionally, it will allow for higher catch-up contributions, allow for matching contributions on student loan payments, permit plan sponsors to add an emergency savings account to their retirement plans, increase the availability of penalty-free withdrawals, and add automatic enrollment error relief provisions, effective January 1, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates and Assumptions. The preparation of financial statements requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements, supplementary schedules, and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Concentration of Credit Risk. Substantially all investments were held by the Trustee. The Trustee executes all investment transactions and is a qualified institution pursuant to ERISA.

Recent Accounting Pronouncements. In June 2016, Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") 2016-13, *Financial Instruments-Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, to revise the criteria for the measurement, recognition, and reporting of credit losses on financial instruments to be recognized when expected. This update is effective for fiscal years beginning after December 15, 2022, with early adoption permitted. Management is currently evaluating this standard.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedules that were prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2022.
- Net depreciation in fair value of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Note 4: All investment balances.
- Investments, as shown in the schedule of assets held at end of year as of December 31, 2022, as shown on Form 5500, Schedule H, Part IV, Line 4i.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

Pooled Separate Accounts. Valued at net asset value of the underlying funds at year end ("NAV"). The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the accounts, the issuer reserves the right to require 1-day notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments Measured Using the Net Asset Value per Share Practical Expedient. The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2022 and 2021, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6 – TAX STATUS

The Plan uses a prototype plan document sponsored by Principal Life Insurance Company. The Trustee received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

NOTE 7 – DELINQUENT REMITTANCES

The Employer remitted certain 2019, 2021 and 2022 participant contributions to the Trustee later than required by the Department of Labor (“DOL”) Regulation 2510.3–102, totaling \$192,429. The Employer will correct these late remittances including crediting participant accounts with the amount of investment income which would have been earned had the participant deferrals been remitted on a timely basis.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 9 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, the Plan Sponsor, and certain others. Party-in-interest transactions consisted of certain Plan investments that are managed by the Trustee.
