Independent Auditor's Report

To the Plan Administrator and Management of the Fircroft, Inc. 401(K) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of *Fircroft Inc. 401(k) Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the *Fircroft Inc. 401(k) Plan*, financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the *Fircroft Inc. 401(k) Plan's* ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 – Description of Plan

The following description of the Fircroft, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established September 1, 2005 and restated January 1, 2022. The Plan covers all employees, excluding leased employees of Fircroft, Inc. (the Company), who are age 21 or older. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan.

Contributions

Each year, a participant may contribute up to 85% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The service requirement for matching contributions is one year of service. Upon meeting this requirement, the Company contributed 100% of the first 3% of compensation that a participant contributes to the Plan in 2021. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Effective January 1, 2022, the Company amended the plan to freeze benefits accrual and eligibility. Participants were eligible to participate in the parent company plan. Participant and employer contributions were frozen for plan year 2022.

Participants Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollovers, plus actual earnings on these accounts. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants who enter the plan on or after June 1, 2020, are awarded 20% on year two of service and are fully vested after six years of service. Participants entering the plan prior to June 1, 2020, are immediately vested in their matching contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of \$ 50,000 or 50% of their vested account balance and are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate and principal and interest are paid ratably through payroll deductions. Effective, March 10, 2022 the plan was amended to eliminate the ability to take any new participant loans.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$ 5,000, the amount may be automatically distributed in the form of lump sum cash payment or IRA rollover depending upon the balance.

Forfeitures Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$ 5,533 and \$ 3,837, respectively. No amounts were used to reduce future employer contributions or pay Plan expenses during 2022 and 2021. Prior to June 1, 2020, all accounts were immediately vested, and no forfeitures existed.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian, as applicable. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included as administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through December 29, 2023, the date the financial statements were available to be issued. The plan sponsor of Fircroft, Inc 401(k) Plan was merged into the *NES Global, LLC 401(k) Profit Sharing Plan and Trust* with ADP Retirement Services effective September 1, 2023.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 *Fair Value Measurement* are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities within active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 – Information Certified by the Trustee

The plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, Charles Schwab Bank, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2022, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the years ended December 31, 2022 and 2021.

Note 5 – Related-Party Transactions and Party-in-Interest Transactions

The known parties-in-interest that have provided services to the plan for 2022 and 2021 are as follows:

- The Company provides administrative services and absorbs administrative costs for the plan. The Plan Sponsor also serves as Trustee of the Plan.
- Charles Schwab Bank serves as custodian and recordkeeper of the Plan.
- BOK Financial Asset Management, Inc. serves as investment advisor of the Plan.
- Calvin Martin & Company, PLLC serves as the Plan auditor.

- The Plan has notes receivables from participants.

All of the above transactions are exempt party-in-interest transactions.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 – Tax Status

The Plan is a Pre-approved Profit-Sharing Plan with CODA by BOKF NA. The Plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Contingencies: Timely Remittance of Contributions

Participant contributions totaling \$ 100,382 were withheld from participants' wages during 2021, but through oversight, were not remitted to the Plan within the time frame required by the Department of Labor under the Plan asset rules. This resulted in an estimated lost earnings calculation of \$ 113 for 2021 and a total amount from all years of \$319. Untimely participant contributions of \$212,203, \$118,988, and \$410,994 from 2020, 2019 and 2018, respectively were uncorrected as of December 31, 2022.

Note 10 – ERISA Bond

The Plan's ERISA bond coverage had a lapse in coverage effective January 1, 2021, through May 17, 2022. The Company became aware of the coverage lapse on May 17, 2022, and obtained coverage.
