INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees,
St. Mary's Dominican High School 401(k) Plan,
New Orleans, Louisiana.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of St. Mary's Dominican High School 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2023 and 2022, and for the year ended June 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

the financial statements. NOTES TO FINANCIAL STATEMENTS**St. Mary's Dominican High School 401(k) Plan**

June 30, 2023 and 2022

Note 1 - DESCRIPTION OF PLAN

The following description of St. Mary's Dominican High School 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a single employer defined contribution retirement plan covering all eligible lay employees of St. Mary's Dominican High School. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was restated effective July 1, 2022 to comply with current laws and regulations.

b. Contributions

Each year, participants may contribute by a combination of deferral and/or Roth contributions, pursuant to Section 401(k) of the Internal Revenue Code (the "Code"), up to 100% of pretax annual compensation as defined by the Plan, not to exceed statutory limits. Participants who have attained the age of 50 before the end of the plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing eligible rollover distributions from other qualified plans.

For any plan year, the Employer may make discretionary matching and profit sharing contributions limited to the amount deductible under applicable provisions of the Code. The Employer made discretionary profit sharing contributions of \$321,278 equal to 5% of eligible compensation for all participants for the year ended June 30, 2023. The Employer made no discretionary matching contributions for the year ended June 30, 2023.

Note 1 - DESCRIPTION OF PLAN (Continued)

c. Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions and plan earnings and charged with allocations of plan losses and administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their 401(k) deferral contributions and rollover contributions, plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contributions portion of their accounts plus actual earnings thereon is as follows:

e. Investment Options

The Plan provides a participant-directed investment program whereby participants select the investments for their accounts. The Plan currently offers several mutual funds and a money market fund as investment options to the participants, which allow participants to make individual selections of investments. These investment options represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

f. Notes Receivable from Participants

The Plan does not allow participants to borrow from their accounts.

Note 1 - DESCRIPTION OF PLAN (Continued)

g. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive benefits in the form of either a lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments. For termination of service due to other reasons and for vested account balances less than \$5,000, a participant will receive the value of the vested interest in his or her account as a rollover distribution to an Individual Retirement Account (IRA). Benefit payments are distributed to participants or their beneficiaries as soon as practicable following the distribution request. Participants who are age 59½ may elect in-service distributions. In addition, hardship withdrawals are allowed for specific financial hardships.

h. Forfeited Accounts

Forfeitures of terminated participant's nonvested accounts are applied to reduce administrative expenses of the Plan, then any remaining forfeitures are used to reduce employer contributions. As of June 30, 2023 and 2022, forfeited nonvested accounts totaled \$737 and \$12,878, respectively. Forfeitures of \$7,566 were used to reduce employer contributions for the year ended June 30, 2023.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

a. Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

c. Investment Valuation and Income Recognition

The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian. The Plan's investments are stated at fair value based on information provided by The Standard Insurance Company, the Plan's custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of Benefits

Benefits are recorded when paid.

e. Expenses

Certain administrative expenses of the Plan are paid directly by the sponsor and are excluded from these financial statements. Fees related to the administration of participant distributions are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

f. Reclassifications

Certain amounts in the 2022 Statement of Net Assets Available for Benefits have been reclassified to conform to the 2023 financial statement presentation.

g. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through January 5, 2024, which is the date the financial statements were available to be issued.

Note 3 - CERTIFIED INVESTMENTS

Information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments as of June 30, 2023 and 2022, and net appreciation in fair value of investments, dividends, and interest for the year ended June 30, 2023, was obtained and derived from information provided to the plan administrator and certified as complete and accurate by The Standard Insurance Company, the custodian as of June 30, 2023 and 2022 and for the year ended June 30, 2023.

Note 3 - CERTIFIED INVESTMENTS (Continued)

The information presented below summarizes the Plan’s investment information that is included in the financial statements based on the information certified by The Standard Insurance Company as complete and accurate in accordance with Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Information included in the supplemental schedule of assets (held at end of year) has also been certified by The Standard Insurance Company.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2023 and 2022.

- *Pooled Separate Accounts:* Valued at the net asset value (NAV) of the units of the pooled separate account. The NAV, as provided by The Standard Insurance Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported fair value.
- *Stable Value Fund:* Valued at the NAV of the units of the stable value account. The NAV, as provided by The Standard Insurance Company, is used as a practical expedient to estimate fair value. The NAV is based on the contract value of the amounts contributed or transferred into the account; less any withdrawals or transfers out plus accrued interest. Earnings are determined by the daily crediting of interest which is subject to minimum contractual guarantees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value of measurement at the reporting date.

Investments in the Standard Stable Asset Fund are subject to certain potential limitations on the transfer to other investment options and on the timing of withdrawals.

Note 5 - CONTRACTS WITH INSURANCE COMPANIES

The Plan maintains a fully benefit-responsive group annuity contract with The Standard Insurance Company. Certain of the Plan's assets are invested in The Standard Insurance Company Stable Asset Fund A. The Standard maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The Standard Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is declared in advance and is reset quarterly. The Standard Insurance Company may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard Insurance Company, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The contract described above meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

Note 6 - INVESTMENTS

Assets of the Plan are invested in a group annuity contract with The Standard Insurance Company. The Standard Insurance Company maintains contributions in pooled separate accounts and a stable value option. The accounts are credited with earnings on the underlying investments and charged for participants' withdrawals and investment management and administrative fees assessed by The Standard Insurance Company. The investment contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by The Standard Insurance Company, represents contributions made under the contract, plus earnings, less plan withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with The Standard Insurance Company such as amendments to the plan document and failure of the trust to qualify for exemption from federal income taxes. The plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6 - INVESTMENTS (Continued)

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. In the event of contract discontinuance, no surrender charges will apply to the investment contract. The Standard Insurance Company has represented to management that fair values were necessary to report on the investments contract value as of June 30, 2023 and 2022.

The Standard Insurance Company guarantees the interest rate earned on funds in The Standard Stable Asset Value Fund A. The guaranteed rates on The Standard Stable Asset Value Fund A are declared quarterly (2.00% and 1.67% annualized rate for the years ended June 30, 2023 and 2022, respectively) and an actual interest earned approximates the quarterly rate.

The average yield on The Standard Stable Asset Value Fund A was approximately 2.00% and 1.67% for the years ended June 30, 2023 and 2022, respectively. The interest rate is based on a formula agreed upon with the issuer.

During 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) in pooled separate accounts appreciated in value by \$1,193,885. The stable value fund earned interest income of \$31,707 during the year ended June 30, 2023.

Note 7 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are managed by The Standard Insurance Company, the custodian of the Plan. The Standard Insurance Company provides recordkeeping services to the Plan, therefore, these transactions qualify as party in interest transactions.

Note 8 - PLAN TERMINATION

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 9 - TAX STATUS

The Internal Revenue Service has informed the sponsor of the non-standardized pre-approved plan by the Employer, by an opinion letter dated June 30, 2020, that the non-standardized pre-approved plan, as then designed, was in compliance with the applicable provisions of Section 401(a) of the Internal Revenue Code. The plan administrator believes that the Plan is correctly designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to June 30, 2020.

Note 10 - RISKS AND UNCERTAINTIES

The Plan provides for various investments in mutual funds and money market funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
