Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Note 1. Plan Description**

The Pyromation, Inc. 401(k) Plan (the Plan) is a defined contribution plan covering employees of Pyromation, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

#### Eligibility

All employees not hired on a temporary basis are eligible to participate in the Plan following six months of service and having attained 18 years of age. Employees hired on a temporary basis are eligible to participate in the Plan following 1,000 hours of service and having attained 21 years of age.

#### Contributions

Participants may elect to contribute between 1% and 100% of eligible pre-tax compensation up to the statutory dollar limit established by the Internal Revenue Code. Participants may also elect to make Roth deferral contributions. The Company match contribution is 50% up to 6% of the participant's compensation. The Company may also make a discretionary contribution as determined by the board of directors. There was no discretionary contribution in 2023.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants have the option of investing in a variety of mutual funds, a stable value fund, and a money market fund offered through Fidelity Management Trust Company. All amounts in participant accounts are participant-directed; however, if a participant does not choose an investment allocation, the Plan provides for a default investment option.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

### **Note 1. Plan Description (Continued)**

#### Benefit Payments

Benefits under the Plan are payable in the form of installments, partial withdrawals or as a lump sum. Benefits are payable when a participant retires, dies, or otherwise ceases to be an employee. Participants who are still active may also receive lump sum benefit payments upon attaining age 59 1/2 or for hardships. Additionally, after-tax contributions and rollover contributions are available for distribution at any time.

#### Forfeitures

If a participant terminates employment before being fully vested, a portion of the Company contributions will be forfeited. Forfeitures are used to pay Plan expenses, reduce future Company contributions or reallocated among eligible participants. At April 1, 2023 and December 31, 2022, no forfeitures were available to pay Plan expenses, reduce future Company contributions or reallocate among eligible participants. During the Plan year ended April 1, 2023, there were no forfeitures reallocated among eligible participants.

### **Note 2. Significant Accounting Policies**

#### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Stable value funds held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

#### Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Payment of benefits to participants are recorded when paid.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Subsequent Events

The plan administrator has evaluated events and transactions for possible recognition or disclosure through December 15, 2023, the date the financial statements were available to be issued.

### **Note 3. Information Certified by the Plan's Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Fidelity Management Trust Company, the trustee, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net investment earnings as shown in the accompanying statement of changes in net assets available for benefits, including interest income and dividends and net realized and unrealized appreciation (depreciation) in fair value of investments.

### **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

### Note 4. Fair Value Measurements (Continued)

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Money market funds and mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

*Stable value fund:* Composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6. Transactions with Parties-In-Interest

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Plan invests in money market funds and mutual funds affiliated with the trustee. Investment related expenses are included in net appreciation of fair value of investments.

### Note 7. Income Tax Status

The Plan, which is a prototype plan of Fidelity Management and Research Company, obtained its latest opinion letter on June 30, 2020, stating that the Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan sponsor and plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

**Note 7. Income Tax Status** (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 01, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**Note 8. Plan Termination**

The Plan Sponsor was acquired by TASI Holdings, Inc. during 2022. As a result, there were no contributions to the Plan during 2023. Additionally, during January 2023, the Plan Trustees approved a merger of the Plan assets into the TASI Holdings 401(k) Retirement Plan, effective April 1, 2023. As a result, the Plan terminated and all assets were transferred.
