## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Natural Gas Solutions Savings Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Natural Gas Solutions Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022, and 2021 and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Plan management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying Financial Statements related to assets held by and certified to by a qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).



## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Emphasis of Matter – Plan Merger and Transfer of Assets***

As discussed in Note 1 to the financial statements, the Plan merged into the Aon Pooled Employer Plan (Aon PEP). As a result of the merger, all assets were transferred out of the Plan on December 30, 2022 and received by the Aon PEP on January 3, 2023. Our opinion is not modified with respect to this matter.

## ***Responsibilities of Plan Management for the Financial Statements***

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Plan management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Natural Gas Solutions Savings Plan (the Plan) provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan's provisions, which is available from Plan management.

#### *General*

The Plan is a defined contribution plan established on December 1, 2018 by Natural Gas Solutions North America, LLC (NGS or the Company) for the union population of hourly workers in the Bradford, PA location.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Plan Merger and Transfer of Assets*

Effective January 1, 2023, the Plan merged into the Aon Pooled Employer Plan (Aon PEP). As a result of the merger, all assets were transferred from Empower Trust Company, LLC (formerly Great-West Trust Company, LLC), the trustee of the Plan (Empower or Trustee) on December 30, 2022 to Voya Institutional Trust Company (Voya), the trustee of the Aon PEP. Voya received all the assets on January 3, 2023.

#### *Contributions*

Employees may participate in the Plan on the first date of each month after completing 3 months of probationary service following the date of hire. The Plan has an automatic enrollment feature whereby new employees are automatically enrolled in the Plan with a contribution rate of 2% of eligible compensation unless the new employee affirmatively makes an election not to participate or to participate at a different contribution rate. The automatic deferral rate will increase on each April 1 by 1% until a deferral rate of 4% is reached.

Participants may elect to defer pre-tax and/or Roth contribution up to 75% of eligible compensation or a flat dollar amount, not to exceed the Internal Revenue Service (IRS) limits as defined in the Plan. Participants age of 50 or over may contribute an additional pre-tax and/or Roth contribution not to exceed the IRS limits (\$6,500 for 2022). Contributions are subject to certain IRS limitations, or the limits set forth in the Plan document. In addition, participants may contribute amounts representing distributions from a qualified trust, individual retirement account or annuity, as defined in the Plan. Participants are allowed to invest in a variety of investment choices offered by the Plan.

Every pay period, the Company matches 1% up to 2% employee contribution for those employees with less than 5 years of service and 1% up to 4% employee contribution for those employees with more than 5 years of services.

#### *Participant Accounts*

Each participant account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are fully vested in their deferral contributions, catch-up contributions, rollover contributions and the earnings thereon. Participants' employer matching contributions and any earnings thereon will be vested in accordance with the following schedule:

1 year	0%
After 2 years	25%
After 3 years	50%

After 5 years	100%

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding balance of any loan from the Plan to the participant during the one-year period ending on the day before the date such loan is made minus the loan balance on the date a new loan is made or 50% of their vested account balance and all earnings thereon, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by Plan management. Principal and interest is paid ratably through weekly payroll deductions.

#### *Payment of Benefits*

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments.

#### *Forfeited Accounts*

The non-vested balance in a participant's account is forfeited upon termination of service. Forfeitures may be used to reduce matching contribution or pay reasonable plan expenses. As of December 31, 2022 and 2021, the forfeiture balance was \$0 and \$25, respectively. The amount utilized for the year ended December 31, 2022 was \$0.

#### *Administrative Expenses*

Certain administrative expenses of the Plan are paid by the Company. There is no guarantee that the Company will continue to pay such expenses. The Plan paid for certain investment transactions and management fees which totaled \$4,812 for the year ended December 31, 2022. The fees for participant requested services are charged to the accounts of participants requesting the transaction. Investment management fees are allocated to participants' accounts based on a specified basis point per investment through the investments' earnings.

#### *Plan Termination*

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

##### *Use of Estimates*

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

##### *Payment of Benefits*

Benefits paid directly to participants are recorded when paid.

##### *Plan Management's Review of Subsequent Events*

In preparing the accompanying financial statements, Plan management has reviewed all known events that have occurred after December 31, 2022, and through December 20, 2023, which is the date the financial statements were available to be issued, for inclusion in the financial statements and footnotes.

#### **NOTE 3: INVESTMENTS AND RELATED INVESTMENT INCOME (CERTIFIED BY TRUSTEE)**

Information presented in the accompanying financial statements and supplementary information, including investments held as of December 31, 2022 and 2021, and the related investment income (losses) for the year ended December 31, 2022 was obtained or derived from information certified to be complete and accurate by Empower, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### **NOTE 4: FAIR VALUE MEASUREMENT**

FASB ASC 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1 -** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 -** Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3 -** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Registered investment companies (mutual funds):* Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

*Collective trust funds (CTF)*: Valued using the NAV practical expedient of the CTF as reported by the CTF managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTF, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CTF is calculated based on a compilation of primarily observable market information. Participant and plan level redemptions are generally allowed daily.

*Stable value fund (SVF)*: Valued at the closing NAV determined by the Trustee based upon the fair value of the underlying securities held by a fund less its liabilities. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner. The SVF provides for daily redemptions by the Plan at reported NAV per share, with no restrictions or advance notice requirement.

The preceding methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5: PARTY-IN-INTEREST TRANSACTIONS**

The Plan may invest in securities managed by the Trustee or its affiliates. The transactions with parties in interest include the payment of the Trustee's fees and purchases and sales of assets through the Trustee. The Company paid fees during the year for accounting, legal, and other services, while the Trustee's fees were paid by the Plan.

#### **NOTE 6: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and current market volatility, it is at least reasonably possible that changes in the values of investment securities will continue to occur in the near term and that such change could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

#### **NOTE 7: PLAN TAX STATUS**

The Plan uses a prototype plan document sponsored by Empower. Empower received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
