## **Notes to Financial Statements**

### **1. Description of Plan**

The following description of the Sportsmed Orthopaedic Specialists, P.C. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan was a defined contribution plan covering certain employees of the Sportsmed Orthopaedic Specialists, P.C. (the “Company”), who had 90 days of service and were age nineteen or older. Additionally, participants were eligible to receive safe harbor and nonelective profit-sharing contributions after one year of service and age twenty-one or older. The Trustee of the Company controlled and managed the operation and administration of the Plan. Newport Group, Inc. and Newport Trust Company served as the custodians of the Plan (“Custodians”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### ***Termination of plan***

On April 29, 2022, Sportsmed Orthopaedic Specialists, P.C. terminated the 401(k) plan. All participants became fully vested in their accounts maintained under the 401(k) plan and all contributions to the plan ceased. All participant balances were distributed by November 30, 2023. As a result, the Plan changed its basis of accounting to the liquidation basis in 2022 and will use the same basis in presenting the financial statements for the period ended November 30, 2023.

#### ***Contributions***

Prior to the Plan termination, each year, participants could have contributed compensation, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Additionally, the elected deferrals automatically increased 1 percent each year up to a maximum of 10 percent. The Company made safe-harbor contributions to eligible participants 3% of eligible compensation. Further, the Company could have made discretionary profit-sharing contributions. There were no contributions to the Plan during the period ended November 30, 2023. Contributions were subject to certain limitations.

#### ***Investment options***

Prior to Plan termination, participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered mutual funds, stable value fund, and common stock as investment options for participants. In addition, participants could have utilized an individual self-directed brokerage option, through which participants were able to invest in a variety of securities including stocks, bonds, mutual funds and government securities in accordance with the Plan document.

***Participant accounts***

Each participant's account was credited with the participant's contribution and allocations of the Company's contributions, and Plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

***Vesting***

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor contributions plus actual earnings thereon was based on years of service. Participants were vested after 2 years of credited service. Vesting in the Company's discretionary or profit-sharing contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. Participants vested at a rate of 20% for each year of service after 2 years of service and 100% vested after 6 years of credited service.

***Notes receivable from participants***

Participants could have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at the prime rate plus 2%. Prior to November 30, 2023, outstanding loans bore interest rates of 5.25%. Principal and interest were paid ratably through payroll deductions.

***Payment of benefits***

Upon termination of service, death, disability or retirement, a participant could have elected to receive an amount equal to the value of the participant's vested interest in his or her account as provided by the Plan. Amounts contributed on a before-tax basis could have only been withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59.5 years.

***Forfeitures***

At November 30, 2023 and December 31, 2022, there were no forfeited non-vested accounts. These accounts could have been used to reduce Company contributions.

**2. Summary of Significant Accounting Policies**

***Basis of accounting***

The financial statements of the Plan are prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment valuation and income recognition***

Investments were reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants***

Notes receivable from participants were measured at their unpaid principal balance. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document.

***Payment of benefits***

Benefits were recorded upon distribution.

***Administrative expenses***

The Plan's administrative expenses were paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions were performed by employees of the Company. No such employee received compensation from the Plan. Expenses relating to specific participant transactions (distributions) were charged directly to the participant's account.

***Subsequent events***

The Plan has evaluated subsequent events through January 8, 2024, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at November 30, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual funds***

Mutual funds were publicly traded investments and were valued daily at the closing price reported on the active market on which the funds are traded.

***Common stocks***

Common stocks in the Plan were publicly traded investments and were valued daily at the closing price reported on the active market on which the individual securities are traded.

***Self-directed brokerage accounts***

Accounts primarily consist of mutual funds and common stocks that were valued on the basis of readily determinable market prices.

**4. Exempt Party-in-Interest Transactions**

Newport Group, Inc. was one of the custodians as defined by the Plan and, therefore, certain transactions qualified as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the Custodians by the Plan for administrative services were \$11,912 for the period ended November 30, 2023.

**5. Tax Status**

The Plan had not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan was relying on the IRS approval of the pre-approved plan that it was utilizing. The IRS determined and informed the document sponsor by a letter dated November 30, 2020, that the pre-approved plan document was designed in accordance with applicable sections of the IRC. The plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believed that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator analyzed the tax positions taken by the Plan, and concluded that, as of November 30, 2023 and December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
