

**1. DESCRIPTION OF THE PLAN**

The following description of the Pretzels, Inc. 401(k) & Profit Sharing Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. As further discussed in Note 11, the Plan was merged into Hershey 401(k) Plan on April 1, 2023.

**General**

The Plan is a Profit Sharing 401(k) Salary Reduction plan covering all employees of Pretzels, Inc. (Company) not covered by a collective bargaining agreement. Participants must have two months of service and have attained 21 years of age. New participants may enter the Plan immediately upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions**

The Company contributes 100 percent of the first three percent of deferred compensation and 50 percent of the next two percent of deferred compensation for each participant. The Company may also make a discretionary profit-sharing contribution each year. Participants must have completed at least 1,000 hours of service during the plan year and be employed on the last day of the plan year to share in the profit-sharing contribution. The Company may also make a discretionary contribution each year. Additionally, the employer absorbs certain costs of plan administration.

**Participant's Accounts**

Each participant's account is (a) credited with the participant's contribution; an allocation of the Company's contribution, plan earnings, and forfeitures of terminated participants' nonvested employer discretionary contribution accounts; and (b) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

## 1. DESCRIPTION OF THE PLAN (continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Participants are also immediately vested in the Company's non-elective matching contributions.

Vesting in the Company's discretionary profit-sharing contribution portions of the participants' accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

### **Payment of Benefits**

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments.

### **Participant Loans**

Participants are permitted a maximum of one loan per participant at a time from their vested account balance. Stipulations state loans must be for a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000. Loans will not be permitted from Roth deferrals. Loan transactions are treated as a transfer to (from) the Investment fund from (to) the Participant Loan fund. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one half percent.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct all contributions into various investment options offered by the Plan. The plan assets are invested in various accounts offered by Ascensus Trust Company.

## 2. SUMMARY OF ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

## 2. SUMMARY OF ACCOUNTING POLICIES (continued)

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Minimum Funding Requirements**

Contributions to the Plan have been funded in accordance with the minimum funding standards of ERISA.

### **Use of Estimates**

The process of preparing financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, upon settlement, actual results may differ from estimated amounts.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Notes Receivable – Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### **Subsequent Events**

The Plan's management has evaluated subsequent events through January 9, 2024, the date the financial statements were available to be issued.

## 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at March 31, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, dividends and interest income on notes receivable from participants for the periods then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the custodian of the Plan).

#### 4. TAX STATUS

The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

#### 5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## 5. FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 1, 2023 and December 31, 2022.

*Mutual funds:* Valued at the net asset value (NAV) provided by the transfer agents for the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at April 1, 2023 and December 31, 2022. There were unallocated forfeitures of employer matching of \$-0- at April 1, 2023 and \$-0- at December 31, 2022. Forfeitures of employer matching will be used to pay Plan administrative costs or reduce employer contribution.

**7. REPORTABLE TRANSACTIONS**

There were no reportable transactions within the plan year that exceeded five percent of the beginning of year plan assets.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. PARTY-IN-INTEREST TRANSACTIONS**

The Plan paid investment advisor expenses of \$-0- for the period ended April 1, 2023 and \$39,254 for the period ended December 31, 2022. Additionally, the plan paid The Vanguard Group investment fees of \$300 for the period ended April 1, 2023 and \$32,048 for the period ended December 31, 2022.

**10. PLAN MERGER**

On April 1, 2023, the Plan was acquired into the Hershey 401(k) Plan. In addition, the Plan changed its custodian to Fidelity Investments. As a result of the merger, participants of the Plan were allowed to participate in the Hershey 401(k) Plan, effective April 1, 2023.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Pretzels, Inc. 401(k) & Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Pretzels, Inc. 401(k) & Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.
