The financial statements comprise the statements of net assets available for benefits as of March 31, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period ended March 31, 2023, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of March 31, 2023 and December 31, 2022 and for the period ended March 31, 2023 and year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

The following brief description of the Waddell & Reed Financial, Inc. 401(k) Plan, as amended and restated (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

(a) General

The Plan was a defined contribution plan covering substantially all employees of Waddell & Reed Financial, Inc. (the “Company”) and its subsidiaries who had one calendar month of service for the Company or a subsidiary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Plan administration was accomplished through an administrative committee (the “Committee”).

On April 30, 2021, pursuant to the terms and conditions of the Agreement and Plan of Merger dated as of December 2, 2020, by and among Macquarie Management Holdings, Inc., a Delaware corporation (“Parent”), Merry Merger Sub, Inc., a Delaware corporation and wholly owned subsidiary of Parent, the Company, and (solely for purposes of Section 9.15 of the Merger Agreement) Macquarie Financial Holdings Pty Ltd, an Australian proprietary company formed under the laws of the Commonwealth of Australia, Merger Sub merged with and into the Company (the “Merger”), with the Company continuing as the surviving corporation. As a result of the Merger, the Company became a wholly owned subsidiary of Parent.

Effective April 14, 2022, the Plan was restated in accordance with the Internal Revenue Service (“IRS”) Cycle 3 restatement requirements for pre-approved plans. In conjunction with the restatement, the Plan was also amended to comply with the provisions adopted under the CARES Act. The IRS has determined that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and informed Schwab Retirement Plan Services of such in a letter dated September 21, 2020. The Plan adopted the pre-approved plan and believes that the Plan was being operated in compliance with the applicable requirements of the IRC.

Effective March 23, 2023, the Plan merged into the Macquarie Management Holdings Inc. Employees Savings and 401(k) Plan as discussed in Note 7.

(b) Contributions

All eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Unless a different percentage is elected, automatically enrolled participants had their deferral rate set at 5% of eligible compensation as defined in the Plan. This contribution percentage increased automatically by 1% per year up to a maximum of 10% unless an alternative election was made.

Participants were allowed to make pre-tax and Roth contributions not to exceed eligible compensation less required social security tax withholdings, subject to IRC annual limitations of \$22,500 for 2023 and \$20,500 for 2022; \$30,000 for 2023 and \$27,000 for 2022 if the participant was 50 years of age or older. Prior to January 1, 2023, the Plan provided for safe harbor matching contributions of 100% of the first 3% of compensation and 50% of the next 2% of compensation that the participant contributed. Safe harbor matching contributions began immediately upon participation. Participants directed the investment of participant and safe harbor matching contributions among investment options available under the Plan. The Plan was amended effective January 1, 2023, to remove the safe harbor matching provision from the Plan. Safe harbor matching contributions made during the period ended March 31, 2023 related to 2022 compensation paid to employees in 2023.

The Plan permitted employer discretionary nonelective contributions to eligible participants. No such contributions were approved for the period ended March 31, 2023 or year ended December 31, 2022.

(c) *Participant Accounts and Vesting*

Each participant's account was credited with any participant contributions, safe harbor matching and discretionary nonelective contributions (if any) and earnings/losses on participant account balances. Participants vest immediately in their contributions and earnings. Safe harbor matching and discretionary nonelective contributions and earnings vested after the participants completed 1,000 hours of service within a 12-month period and also upon reaching normal retirement age, death or disability prior to termination of employment.

Effective April 30, 2021, the Plan was amended to fully vest all participants' Safe Harbor Matching Contribution Account and Non-Safe Harbor Non-Elective Contribution Account. Additionally, the Plan was amended whereby participants who were involuntarily or voluntarily terminated during the period from December 2, 2020 to April 30, 2021 due to the partial plan termination pursuant to the acquisition of the Company by Macquarie Management Holdings, Inc. became fully vested in their Safe Harbor Matching Contribution Account and Non-Safe Harbor Non-Elective Contribution Account.

(d) *Participant Loans*

Participant loans were not permitted.

(e) *Payment of Benefits*

Upon termination of service for any reason, a participant was paid a lump-sum distribution if their vested account balance was equal to or less than \$5,000. Former employees with a vested account balance greater than \$5,000 at the time of termination could elect to remain a participant in the Plan until death but could not continue to make contributions to the Plan. However, minimum distributions must begin by the later of April 1 following the calendar year in which the participant attains age 72 or terminates employment.

(f) Forfeitures

Forfeitures under the Plan were used to restore previously forfeited amounts, reduce safe harbor matching contributions and nonelective contributions and to pay reasonable Plan expenses, in that order, until exhausted. Forfeitures were allocated as of the last day of the Plan year in which they occurred or in appropriate situations, such as where no safe harbor matching contributions or nonelective contributions were made for the Plan year or no Plan expenses were incurred, no later than the immediately succeeding Plan year. No forfeitures were used during the period ended March 31, 2023.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared in conformity with U.S. generally accepted accounting principles (“GAAP”) and present the Plan’s net assets available for benefits and changes in those net assets using the accrual method of accounting.

The Plan allowed contributions to be invested in the Federated Investors Government Obligations Fund (a money market mutual fund), certain units of common, collective or pooled trust funds (“CITs”) and mutual fund shares of certain registered investment companies, including, but not limited to CITs and mutual funds affiliated with the Company. Delaware Management Company (“DMC”) managed the Delaware Ivy Funds and the Ivy Investments Collective Investment Trusts. SEI Trust Company served as the trustee for the Ivy Investments Collective Investment Trusts. Charles Schwab Trust Bank served as the trustee and Schwab Retirement Plan Services, Inc. provided recordkeeping services to the Plan. DeMarche Associates, Inc. provided consulting services as a co-fiduciary under ERISA Section 3(21) with respect to the Plan.

(b) Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds were valued at the net asset value (“NAV”) reported in the active market where the fund was traded on a daily basis. Collective investment trust funds were valued based on NAV.

Purchases and sales of securities were recorded on a trade-date basis (the date the order to buy or sell is executed). Dividend income was recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the period.

(d) *Payment of Benefits and Administrative Expenses*

Benefits were recorded when paid. A portion of administrative expenses were paid by the participating employers listed in Note 5, and a portion were paid by terminated participants accounts. During 2023, \$17,000 in recordkeeping and trust/custodian fees were paid from Plan accounts.

(3) Fair Value Measures

Accounting standards establish a framework for measuring fair value and a three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of the asset. Inputs may be observable or unobservable and refer broadly to the assumptions that market participants would use in pricing the asset. An individual investment's fair value measurement is assigned a level based upon the observability of the inputs that are significant to the overall valuation. The three-level hierarchy of inputs is summarized as follows:

- Level 1 – Investments are valued using quoted prices in active markets for identical securities.
- Level 2 – Investments are valued using other significant observable inputs, including quoted prices in active markets for similar securities.
- Level 3 – Investments are valued using significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Investments classified as Level 2 can have a variety of observable inputs. These observable inputs are collected and utilized, primarily by an independent pricing service, in different evaluated pricing approaches depending upon the specific investment security to determine a value.

Investments classified as Level 3 are primarily determined through the use of a single quote (or multiple quotes) from dealers in the investment securities using proprietary valuation models. These quotes involve significant unobservable inputs, and thus, the related securities are classified as Level 3 investments.

The collective investment trust funds were valued at fair value using NAV as a practical expedient. As of March 31, 2023, there were no assets held by the Plan as a result of the plan merger as discussed in Notes 1 and 7. As of December 31, 2022, the Plan had \$94.1 million of collective investment trust assets. All of the remaining Plan investments were mutual funds which were Level 1 investments. Participant-directed redemptions from these collective investment trust funds generally could be made daily, subject to a Plan imposed holding period on investments between 5 and 30 days. There were no unfunded commitments as of December 31, 2022.

(4) Information Prepared and Certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan during the year, has certified the investments at fair value, net appreciation in fair value of investments, as well as interest and dividends included in the accompanying financial statements are complete and accurate with respect to investments.

(6) Related-Party Transactions

Plan investments included units of collective investment trusts and shares of mutual funds managed by DMC. DMC is an affiliate of the Parent of the Company following the Merger in April 2021. Plan investments included units of collective investment trusts established by Charles Schwab Trust Bank as trustee with additional services provided by affiliates and shares of mutual funds managed by Charles Schwab Investment Management, Inc. (dba Schwab Asset Management). Charles Schwab Trust Bank served as trustee and Schwab Retirement Plan Services, Inc. served as recordkeeper for the Plan, and therefore, are parties in interest. The Company and its affiliates were the sponsors, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for trustee fees and investment management services are included in net appreciation in fair value of investments and recordkeeper and trust/custodian fees for terminated participants are included in administrative expenses.

(7) Plan Termination and Merger

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. All Plan assets would be distributed in the event of Plan termination.

During 2022, a partial plan termination, as defined under the IRC, occurred following the termination of greater than 20% of plan participants due to the acquisition of the Company by Macquarie Management Holdings, Inc. Accordingly, the affected terminated participants' account balances became 100% vested at the time of termination.

Effective March 23, 2023, the Plan merged into the Macquarie Management Holdings Inc. Employees Savings and 401(k) Plan. As a result of the plan merger, assets of \$127,741,447 were transferred out of the Plan.

(8) Tax Status

Effective December 16, 2019, the Company adopted the Schwab Retirement Plan Services, Inc. Volume Submitter 401(k) Profit Sharing plan document (“Schwab VS Plan”). The IRS determined that the Schwab VS Plan was designed in accordance with the applicable sections of the IRC pursuant to a letter dated April 22, 2016. Although the Plan had been amended since receiving the opinion letter, the Plan administrator believes that the Schwab VS Plan operated in compliance with the applicable requirements of the IRC.

Effective April 14, 2022, the Plan was restated in accordance with the IRS Cycle 3 restatement requirements for pre-approved plans. The IRS determined that the pre-approved plan was designed in accordance with applicable sections of the IRC and informed Schwab Retirement Plan Services of such in a letter dated September 21, 2020. Although the Plan had been amended since receiving the opinion letter, the Plan administrator believes that the Schwab VS Plan operated in compliance with the applicable requirements of the IRC.

In accordance with GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan currently has no audits for any tax periods in progress.

(9) Reconciliation of Financial Statements to the Form 5500

On December 31, 2022, the Plan had \$3 million in benefit payments that had been processed and approved for payment but had not yet been paid by year end. This amount is presented herein as a component of net assets in the accompanying 2022 financial statements but is presented as a liability of the Plan on the Form 5500.
