Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PowerVac of Michigan, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Plan Merger

As discussed in Note 1 to the financial statements, Plan management approved the merger of the Plan assets and participants into the TFO Advantage Pooled Employer Plan. Our opinion is not modified with respect to this matter.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the PowerVac of Michigan, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Termination of Plan

Effective August 28, 2023, PowerVac of Michigan, LLC (the Company) elected to terminate the Plan and to join the TFO Advantage Pooled Employer Plan. As part of the transition, all net assets were transferred to Newport Group, Inc., with certain Plan investment balances transferred to the same investment option via an "in-kind transfer" while other investments were liquidated and reinvested under the new plan's investment options. The following notes to the financial statements describe the Plan's policies that were in effect for the period January 1, 2023, to August 28, 2023.

General

The Plan was a defined contribution plan covering substantially all employees of PowerVac of Michigan, LLC (the Company) and Pipeline Management Co. Inc., who attained eighteen years of age and completed at least three months of eligible service (as defined in the Plan document). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversaw governance of the Plan, determined the appropriateness of the Plan's investment offerings, and monitored investment performance.

Contributions

Each year, participants could make voluntary pre-tax and Roth contributions of up to 92% of eligible compensation, as defined in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan also provided for safe harbor contributions equal to 100% of the first 6% of compensation that a participant contributed to the Plan. Safe harbor contributions totaling \$273,119 were made during the period January 1, 2023, through August 28, 2023. The Company could also authorize discretionary profit sharing contributions to the Plan for the related year. There were no discretionary profit-sharing contributions authorized for the period January 1, 2023, through August 28, 2023. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

A separate account was maintained for each participant. Each participant's account was credited with the participant's contributions, rollover contributions, allocations of the Company's contributions, and Plan earnings or losses as defined by the Plan agreement. If one was made, the Company's profit sharing contribution was allocated on a discretionary basis, and was only to participants who were employed on the last day of the Plan year. Plan earnings or losses were allocated daily based on each participant's account balance. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants were immediately vested in their contributions, the Company's safe harbor and discretionary profit-sharing contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account. The loan interest rate, determined at inception, was set at Prime (7.50% at December 31, 2022) plus 1%, in accordance with the Plan's loan policy. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, participants received either a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic installments over a specified future period, or annuity contracts as described in the Plan agreement. If the participant's account balance was less than \$5,000, the plan administrator directed Mid Atlantic Trust Company (MATC), the custodian, to make a lump-sum distribution. Distributions of a participant's 401(k) account balance could be authorized at any time by the plan administrator under certain hardship conditions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value by MATC, the custodian of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurement.

NOTES TO THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period January 1, 2023, through August 28, 2023.

Assets of the Plan were held in separate accounts of a trust administered by MATC as of December 31, 2022, representing investments in mutual funds and a common/collective trust fund.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2022. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Plan Expenses

The Plan's administrative expenses were paid either by the Plan or the Company as provided by the Plan agreement. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Income Taxes

In accordance with GAAP, the plan administrator was required to evaluate tax positions taken by the Plan and recognize a tax liability for any significant uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2022, and for the period January 1, 2023, through August 28, 2023, the Plan did not have a liability for unrecognized tax benefits. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Subsequent Events

Plan management has evaluated subsequent events through January 4, 2024, the date the financial statements were available to be issued (see Note 8).

NOTES TO THE FINANCIAL STATEMENTS

3. INFORMATION CERTIFIED BY CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements including investments held at December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2023, through August 28, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by MATC, the custodian.

4. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2 Other significant observable inputs including: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 Inputs are significant and unobservable (including the Plan's own assumptions used to determine value)

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

As a result of the plan termination at August 28, 2023 (Note 1), there were no investments held at the end of the period. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTES TO THE FINANCIAL STATEMENTS

4. FAIR VALUE MEASUREMENT (Continued)

Common/collective trust fund: Valued at the NAV of units of the common/collective trust fund. The NAV as provided by the trustee, is used as a practical expedient to estimated fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner, otherwise redemptions are allowable daily with no notice.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan did not hold any Level 3 assets during the period from January 1, 2023, through August 28, 2023.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by MATC, the custodian of the Plan and, therefore, such transactions qualified as party-in-interest transactions.

MATC provided certain administrative services to the plan under a Custodial Agreement between the Company and MATC. MATC received revenue from mutual fund for services MATC provided to the funds. This revenue was used to offset certain amounts owed to MATC for its administrative services to the Plan. Excess amounts were not remitted to the Plan. The Plan or the Company could make a payment to MATC for administrative expenses not covered by revenue sharing.

These party-in-interest transactions were exempt from the prohibited transactions rules of ERISA.

NOTES TO THE FINANCIAL STATEMENTS

6. TAX STATUS

The Plan adopted a pre-approved money purchase pension plan provided by Paychex, Inc. Paychex, Inc. has received an opinion letter dated August 31, 2020, from the IRS stating that the pre-approved money purchase pension plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan document has been amended since receiving the opinion letter, the plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax exempt.
