**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of University Cancer & Blood Center, LLC (the "Company" and the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the nine-month period ended September 30, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of University Cancer & Blood Center, LLC's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2023 and December 31, 2022, and for the periods then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter—Plan Merger and Asset Transfer**

As discussed in Note 8 to the financial statements, the governing body University Cancer & Blood Center, LLC approved a plan merger and asset transfer with OneOncology, LLC on December 29, 2022. As a result, the Plan transferred and assigned all assets of the University Cancer & Blood, LLC to OneOncology, LLC OneRewards Retirement Plan effective December 31, 2022. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS September 30, 2023 and December 31, 2022

### **Note 1: Description of the Plan**

The following description of University Cancer & Blood Center, LLC (the “Company” and the Plan”) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

#### ***General***

The Plan is a defined contribution plan sponsored by University Cancer & Blood Center, LLC for the benefit of its employees and their beneficiaries. The purpose of the Plan is to enable participants and their beneficiaries to share in the Company’s profits and to encourage the loyalty and continuity of service of the participants. An employee becomes eligible to participate in the Plan upon obtaining age 21 and completing two months of service and is then able to enter the Plan on the first day of the following month. Once eligible, a new participant will be automatically enrolled in the Plan with a 4% deferral rate, unless the participant elects not to participate in the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan’s trustee and custodian is Fidelity Management Trust Company and the Plan’s record keeper is Fidelity Workplace Services, LLC.

#### ***Contributions***

Eligible participants may make annual contributions to the Plan through a salary deferral election up to 90% of eligible compensation. Employee rollover contributions are also permitted. The Company may make qualified non-elective contributions and employer non-elective contributions to all eligible participants’ accounts. The Company elected to make such contributions for the nine-month period ended September 30, 2023 and year ended December 31, 2022, in the amount of \$0 and \$1,085,296, respectively. Contributions are subject to certain limitations.

Forfeitures are used to either pay administrative expenses or reduce future Company contributions.

#### ***Participant Investment Account Options***

Investment account options include various types of investment securities offered by the Plan. Each participant has the option of directing his or her contributions into any of these investment securities and may change their allocations daily.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Company’s discretionary contributions (if any) and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### ***Vesting***

Participants are immediately vested in their deferral contributions, rollover contributions, qualified non-elective contributions, safe harbor non-elective employer contributions, plus earnings thereon. Vesting in the Company’s non-elective contributions portion of their accounts plus earnings thereon is based on years of credited service. A participant will become 100% vested in the Company’s non-elective contributions upon completing five years of service, as defined by the Plan.

### Note 1: Description of the Plan (continued)

#### *Notes Receivable from Participants*

The plan document includes provisions authorizing loans from the Plan to active eligible participants. A participant may apply for only one loan each calendar year. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes. Loans must be repaid over a five-year period unless it is used for the purchase of a principal residence in which case the loan repayment period may not extend beyond ten years from the date of the loan. Loan repayments are paid through payroll withholdings.

All loans shall bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. Participants will be deemed to have defaulted on their loan if they fail to remit payments in a timely manner as required under the demand note, breach any of their obligations or duties under the demand note, or terminate employment.

#### *Payment of Benefits*

Hardship withdrawals may be requested for medical expenses, purchase of a principal residence, prevention of eviction from or foreclosure on a principal residence, pay for post-secondary education, payments for burial or funeral expenses, pay expenses for the repair or damage to a principal residence, or any other immediate and heavy financial need as determined based on Internal Revenue Service regulations. Deferral contributions will be suspended for six months after the receipt of the hardship withdrawal. The minimum hardship withdrawal amount is \$500.

Once a participant reaches age 59 ½, the participant may elect to withdraw all or a portion of their entire vested account while they are still employed.

A participant may elect to withdraw their vested account balance after they reach the Plan's normal retirement age, the later of age 55 or the fifth anniversary of their employment commencement date, or delay it until they retire.

Starting in the calendar year in which a participant reaches the age of 70 ½, an election may be made to receive distributions calculated in the same manner as Minimum Required Distributions.

A withdrawal of rollover contributions may be elected in total or partial amounts.

There are withdrawals available for those serving in the Military or been called to active service in the Military Reserves as listed in the Summary Plan Description.

Upon termination of service due to death, disability, or retirement, a participant is entitled to 100% of their account balance. Benefits will be paid in a single distribution or other distribution that they elect. For termination of service due to other reasons, a participant is entitled to the value of their vested account balance.

#### *Forfeited Accounts*

Forfeitures consist of unvested company contributions in participants' accounts at the conclusion of their participation in the Plan. Forfeitures are held in the Plan and are used to either pay administrative expenses or reduce future Company contributions. At September 30, 2023 and December 31, 2022, there were \$0 and \$20,501, respectively, in forfeited non-vested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investments Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

#### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

### Note 4: Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1**      Quoted prices in active markets for identical assets
- Level 2**      Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3**      Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

#### ***Recurring Measurements***

The Plan's investments (including gains and losses on investments purchased and sold, as well as held during the year) appreciated (depreciated) in value by \$945,928 and \$(4,923,818) during the nine-month period ended September 30, 2023 and year ended December 31, 2022, respectively.

The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

#### ***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases, where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

#### ***Common/Collective Trust funds***

The common/collective trust funds generally invest in cash and cash equivalents, equity instruments, government issues, derivatives and other common/collective trusts. The common/collective trusts are valued at the net asset value of the underlying units. The net asset values for all collective trust funds are used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

### **Note 5: Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Participant loans are loans made to employees/participants of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Direct expenses paid to service providers during the nine-month period ended September 30, 2023 and year ended December 31, 2022, were approximately \$59,700 and \$54,100 respectively. Indirect expenses paid to service providers during the nine-month period ended September 30, 2023 and year ended December 31, 2022 were approximately \$85,700 and \$109,900 respectively.

The Plan parties-in-interest included Strategic Advisors, Inc. (investment advisor), Fidelity Investments Institutional (recordkeeper), and Fidelity Management Trust Company (asset custodian) during the nine-month period ended September 30, 2023 and year ended December 31, 2022.

The Company provides certain administrative services at no cost to the Plan.

### **Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for plan benefit.

### **Note 7: Tax Status**

The Plan operates under a Volume Submitter Profit Sharing Plan with CODA document sponsored by Fidelity Management & Research Co. This plan document has been filed with the appropriate agency and has obtained an opinion letter dated March 31, 2014. The Plan has not obtained or requested a determination letter. The plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8: Plan Termination & Merger**

On December 29, 2022 the Plan merged into a successor plan sponsored by OneOncology, LLC, effective December 31, 2022. The remaining assets were transferred to Sentinel Group, the asset custodian during September 2023. Participants received credit for all years of services with University Cancer & Blood Center, LLC in the OneOncology, LLC sponsored plan.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions. Under the plan merger, participants of the Plan received credit for all years of service with University Cancer & Blood Center, LLC.
