Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Benson Hospital 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 11, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period ended February 11, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution for the period ended February 11, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the “Auditor’s Responsibilities for the Audit of the Financial Statements” section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in *Note 1* to the financial statements, the Board of Directors of Benson Hospital Corporation d/b/a Benson Hospital, the Plan’s sponsor, voted on September 21, 2021 to terminate the Plan, and management determined liquidation is imminent. As a result, the 2022 and 2021 financial statements have been prepared on a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the “Scope and Nature of the ERISA Section 103(a)(3)(C) Audit” section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Note 1: Description of the Plan

General

The following description of Benson Hospital 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Benson Hospital Corporation d/b/a Benson Hospital (the Sponsor) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Sponsor. Participants are required to attain age 18 and have one year of service to qualify for discretionary nonelective and discretionary matching contributions.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). American United Life Insurance Company (AUL) is the custodian and record-keeper of the Plan.

The Sponsor's board of directors approved a resolution on September 21, 2021 to terminate the Plan effective December 31, 2021 and ceased contributions to the Plan other than contributions that were corrective in nature. On February 11, 2022, plan assets were liquidated and distributed to the participants. The participants had the option of receiving the liquidation distribution in the form of cash or as a rollover into another qualified plan.

Contributions

Through December 31, 2021, the Plan permitted eligible employees to have the Sponsor make annual pre-tax contributions of up to 100% of eligible compensation through a salary deferral election. Employee rollover contributions were also permitted. Participants were allowed to make elective contributions into a Roth deferral account. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. The Plan also provides for discretionary nonelective and discretionary matching contributions. For the period ended February 11, 2022, there were no discretionary matching contributions; for the year ended December 31, 2021, there was a discretionary contribution of 50% of the employee contribution up to 3% made to the Plan.

Participant Investment Account Options

Investment account options available include a guaranteed investment contract and various investment options through a pooled separate account. Each participant has the option of directing contributions into any of the investment account options selected by the Sponsor and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 4% of eligible compensation unless the participant made an affirmative election

otherwise. The automatic deferral feature does not provide for an annual increase in the percentage deferred.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus earnings thereon. Vesting in the Sponsor's discretionary matching and discretionary nonelective contribution portions of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after four years of continuous service.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or election at age 59½, a participant may elect to receive a lump-sum amount equal to the value of their account. A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Forfeited Accounts

At February 11, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and approximately \$2,500, respectively. These accounts will be used to reduce discretionary contributions or pay plan expenses. Forfeitures totaling approximately \$2,500 were used to reduce plan expenses for the period ended February 11, 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the liquidation basis of accounting as of February 11, 2022 and December 31, 2021 and for the period ended February 11, 2022.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. The pooled separate account is valued at estimated fair value as provided by AUL and is based on quoted redemption values at the last business day of the year. Quoted market prices, if available, are used to value investments.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Sponsor or the Plan at the Sponsor's discretion.

Note 3: Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, a qualified institution, has certified the following information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of February 11, 2022 and December 31, 2021
- Investment loss and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the period ended February 11, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified information except for comparing such certified information to the related investment information included in the financial statements.

Note 4: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan holds certain plan investments that are units of a pooled separate account or a guaranteed investment contract that is sponsored and managed by AUL. Certain fees incurred by the Plan for services provided by AUL to the Plan are included in net depreciation in fair value of investments, as they are paid through revenue-sharing rather than direct payment.

The Plan paid approximately \$8,400 of record-keeping fees and certain other administrative fees to AUL during the period ended February 11, 2022. The Sponsor provides certain administrative services at no cost to the Plan.

Note 5: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified as Level 2 of the valuation hierarchy. The pooled separate account is valued at the net asset value (NAV) of units as determined by AUL based on the market value of the underlying assets, net of an investment management fee. This NAV is a readily determinable fair value and is the basis for current transactions. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan held no Level 1 or Level 3 investments.

Note 6: Investment Contract with AUL

In 2018, the Plan entered into a fully benefit-responsive investment contract with AUL in the form of a guaranteed investment contract. The AUL Stable Value Account is a fixed-dollar annuity and investment product offered by AUL and is maintained in the AUL general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The AUL Stable Value Account is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The guaranteed investment contract does not permit AUL to terminate the agreement prior to the scheduled maturity date.

As discussed in *Note 1*, the Plan terminated effective December 31, 2021; however, the Plan's termination did not limit the Plan's ability to materially transact at contract value with participants.

The carrying value of the guaranteed investment contract, considered a traditional investment contract, is \$0 and \$25,038 at February 11, 2022 and December 31, 2021, respectively.

Note 7: Plan Termination

The Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. As discussed in *Note 1*, the Plan was terminated effective December 31, 2021.

Note 8: Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter, as the IRS does not currently provide that service for 403(b) plans. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 10: Subsequent Events

Subsequent events have been evaluated through January 11, 2024, which is the date the financial statements were available to be issued.
