**Note 1 – Description of the Plan**

The following description of the Haas-Anderson Construction Profit Sharing 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was a defined contribution plan that covered all employees who had completed six months of service, meaning six consecutive calendar months during which the employee had completed at least 500 hours of service. The six consecutive calendar months were computed from the date an employee first performed an hour of service for the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On March 24, 2023, the Plan transferred the assets and merged with the Anderson Columbia Co., Inc. 401(k) Salary Reduction Plan. Until March 24, 2023 (Date of Merger), the assets of the Plan were held with Transamerica Life Insurance Company (“Trustee”).

**Contributions**

Each year, participants could contribute a percentage of their pre-tax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions through the insurance investment contract offered by the Plan. Participants could allocate their contributions between sixteen pooled separate accounts currently offered as investment options through the insurance investment contract. The Company contributed 25% of the first 6% of base compensation that a participant contributed to the Plan. Contributions were subject to certain limitations.

Annually, the Company could make two types of additional contributions on a discretionary basis – matching contributions and non-matching contributions. Matching contributions were made on behalf of all participants who had made elective contributions to the Plan. Non-matching contributions were made on behalf of all eligible employees in a job classification whether or not they had made elective contributions during the plan year.

**Participant accounts**

Each participant’s account was credited with the participant’s contribution and allocations of: (a) the Company’s matching contribution (b) the Company’s non-matching contribution, and (c) Plan earnings, and charged with an allocation of group annuity fees. Allocations were based on participant earnings, participant contributions or account balances, as defined by the Plan. The benefit to which a participant was entitled to would be the benefit that could be provided from the participant’s vested account.

**Participant loans**

No loans were allowed under the plan.

**Vesting**

Participants were immediately vested in their elective salary deferral plus actual earnings or losses thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. A participant was 100% vested after six years of credited service.

**Hardship withdrawals**

Withdrawal of a portion of a participant's account would be permitted due to an immediate and heavy financial need, if it met IRS requirements.

**Payment of benefits**

On termination of service due to death, permanent disability, or retirement, a participant would receive payment in the form of a life annuity for the lifetime of the participant and/or the lifetime of the spouse. Alternate forms of benefit payments were available pending applicable restrictions. On termination of service due to termination of employment, the participant generally had the option to receive a single lump-sum payment.

**Forfeited accounts**

At March 24, 2023 (Date of Merger) and December 31, 2022, forfeited nonvested accounts totaled \$0 (\$13,700 in 2022). Accounts forfeited were applied against administrative expenses as stipulated by a plan amendment dated July 2001.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of presentation**

The accompanying financial statements have been prepared on the modified cash basis, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles and is an acceptable method of reporting under Department of Labor regulations. The modified cash basis utilizes the cash basis of accounting while recording plan contributions on the accrual basis. Investment income is recorded when received rather than when earned. Annuity fees, benefits, and administrative expenses are recognized when paid rather than when the obligations are incurred.

**Note 2 – Summary of Significant Accounting Policies (continued)**

**Payment of benefits**

Benefits are recorded when paid.

**Investment valuation and income recognition**

The Plan's investments consisted of pooled separate accounts ("PSA"). The Plan valued the PSAs at the net asset value ("NAV") or NAV equivalent (PSA unit prices in this case) of each fund. The NAV was equal to the total value of all securities in each fund's portfolio, less any liabilities. The NAV or NAV equivalents, that was the PSA unit prices, were calculated daily using publicly available quotes on the underlying investments. The PSAs were fully benefit responsive and the contract value was the same as the fair value at March 24, 2023 (Date of Merger) and December 31, 2022. See Note 4 for discussion of fair value measurements.

Investment return for the PSAs were reflected by net increases/decreases in investment unit values. Transamerica did not maintain historical cost, and therefore did not report any realized gain/loss amounts separate from unrealized gain/loss amounts. Any dividends in the underlying mutual funds were also accounted for in the daily unit values.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Administrative expenses**

Plan administrative expenses were reduced by the application of forfeited nonvested accounts as agreed upon in the plan contract with Transamerica as amended. Any administrative expenses in excess of the forfeited accounts were recorded and paid by Haas-Anderson Construction, Inc., the plan sponsor.

**Transfers from the plan**

For the period January 1, 2023, to March 24, 2023 (Date of Merger), net transfers from the Plan to the Anderson Columbia Co., Inc. 401(k) Salary Reduction Plan were \$3,495,351.

**Date of management's review**

Subsequent events were evaluated through January 12, 2024, the date the financial statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

**Note 3 – Information Prepared and Certified by Trustee**

The Plan Administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Life Insurance Company Inc. (TLIC), (“the Custodian”), has certified that all investment information disclosed in the accompanying financial statements and supplementary information, included in investments held at March 24, 2023 (Date of Merger) and December 31, 2022, and net appreciation (depreciation) in fair value of investments, investment income (loss), and interest income for the period January 1, 2023 to March 24, 2023 (Date of Merger), and the year ended December 31, 2022, was obtained or derived from information provided to Plan management by TLIC.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**Note 4 – Investments measured at net asset value using the practical expedient**

The Plan’s pooled separate accounts were measured at fair value using the net asset value (“NAV”) per share (or its equivalent) as a practical expedient and had not been classified in the fair value hierarchy in accordance with Subtopic 820-10. The Plan did not have investments as of March 24, 2023 (Date of Merger).

**Note 5 – Plan Termination**

Although it had not expressed any intent to do so, the Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would have become 100% vested in their account balances.

**Note 6 – Income Tax Status**

The Plan was formed as a GUST “Volume Submitter” plan under the umbrella of Transamerica Life Insurance Company (Transamerica). The prototype plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Service (IRS). The prototype plan had been amended since receiving the determination letter. The Plan administrator believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

**Note 7 – Related Party Transactions and Party-in-Interest Transactions**

Plan investments were managed by Transamerica, the custodian and record-keeper for the Plan. Therefore, the transactions qualified as party-in-interest transactions and were covered by an exemption from the “prohibited transactions” provisions of ERISA and the IRC. The Plan did not consider the Company’s contributions to the Plan to be party-in-interest transactions. The Company provided certain accounting, administrative and management services to the Plan for which no fees were charged.

**Note 8 – Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the values of investment securities would occur and that such changes could have materially affected participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits (modified cash basis).
