Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of Gryphon Healthcare 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 27, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through March 27, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. **Description of Plan**

The following brief description of Gryphon Healthcare 401(k) Plan (the "Plan") was provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2009, and restated, effective December 20, 2020, covering substantially all employees of RSDR - RCM Inc. and its wholly owned subsidiaries (collectively, the "Company" or "Plan Administrator"). The Plan, as amended, was subject to the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC").

Effective March 27, 2023, the Plan merged into another qualified plan that is administered by the Company.

Plan Administration

The Plan was administered by the Company and accordingly, certain administration functions were performed by officers or employees of the Company. No officers or employees received compensation from the Plan. Empower (the "Trustee") served as the trustee of the Plan.

Eligibility

The Plan covered all employees of the Company, except union employees, nonresident aliens and leased employees. Employees became eligible for participation on the first day of the plan year quarter coinciding with or next following completing of three consecutive months of employment. Participants might modify investment elections on the first day of each quarter and might transfer existing account balances or obtain information regarding the investments on a daily basis.

Contributions

Each year, participants might contribute a percentage of their pretax annual compensation not to exceed the limitation (\$22,500 for the period from January 1, 2023 through March 27, 2023) set forth in Section 402(g) of the IRC. Participants might make catch-up contributions, pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50th birthday. A participant's total catch-up contribution during the period from January 1, 2023 through March 27, 2023 might not exceed \$7,500.

The Plan allowed for Company safe harbor matching contributions and Company discretionary matching and profit-sharing contributions. The Company made safe harbor matching contributions in the amount of 100% of participant elective deferrals up to 3% of a participant's eligible compensation, and 50% of contributions that exceed 3% of eligible compensation up to 5% of a participant's eligible compensation each pay period. During the period from January 1, 2023 through March 27, 2023, the Company made matching contributions totaling \$14,530. No Company discretionary matching or profit-sharing contributions were made during the period from January 1, 2023 through March 27, 2023.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment Options

The Plan provided for contributions to be invested by the participants among a variety of pooled separate accounts and a guaranteed investment contract, in accordance with participant investment elections and the provisions of the custodial agreement. Participants should refer to the plan website for additional fund information.

1. Description of Plan, continued

Vesting

Participants were immediately vested in rollover contributions, employee contributions and Company safe harbor matching contributions, plus any earnings thereon. Participants vested in Company discretionary matching and profit-sharing contributions at a rate of 20% per year, beginning after two years of service, and are 100% vested after completing six years of qualified service. A participant became fully vested in the event of retirement at age 65, total and permanent disability or death.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts might be used to pay Plan expenses or reduce Company contributions. These amounts were shown as a component of net assets available for benefits. At March 27, 2023 and December 31, 2022, forfeited nonvested accounts available for future use totaled \$0 and \$10,958, respectively. For the period from January 1, 2023 through March 27, 2023, no forfeitures were used to reduce Company contributions or pay Plan expenses.

Notes Receivable from Participants

Participants might borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Each participant was allowed only one outstanding loan at a time. Loan terms ranged from 1 to 5 years or up to 20 years for the purchase of a primary residence. The loans were secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 7.25% at December 31, 2022, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest payments were made by means of payroll withholdings according to the terms of the promissory note.

Payment of Benefits

Upon termination of employment due to death, retirement or attainment of age 59½, a participant (or his or her designated beneficiary in the event of death) might elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or to have the account balance distributed in annual installments. If a participant's account was less than \$5,000, a lump-sum distribution would be made automatically.

In-service withdrawals were allowed by the Plan from the participant's fully vested account balance after the participant had attained age 59 ½. Prior to age 59 ½ and subject to guidelines set forth in the IRC, a participant might request a hardship withdrawal.

Administrative Expenses

The Plan was responsible for payment of the trustee expenses and fees, which include fees incurred by the Plan for investment management or recordkeeping services. However, certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements.

Fees related to the administration of the accounts and notes receivable from participants were charged directly to the participants' accounts as well as fees for initiating benefits payments and were included in administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value except for fully benefit-responsive investments, which were reported at contract value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan invested in a guaranteed interest contract through a group annuity contract with Empower. The fair value of the guaranteed interest contract was calculated based on the liquidation value of the pro-rata share of the underlying investments' fair value. The guaranteed interest contract was a fully benefit-responsive investment contract and was stated at contract value, which was the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of group annuity contract with insurance company.

Net appreciation in fair value of investments, excluding fully benefit-responsive investment contracts, included realized gains or losses on the sale of investments throughout the period, as well as unrealized appreciation or depreciation of investments held at the end of the year. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Notes Receivable from Participants

Participant notes receivable were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was accrued as earned. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent participant notes receivable were reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits were recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement and Disclosures*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following was a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 27, 2023 and December 31, 2022.

Pooled separate accounts were valued at the net asset value ("NAV") of shares held by the Plan at year-end, as determined by the Trustee. The NAV was used to estimate fair value as a practical expedient. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This NAV was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) might occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the Trustee reserved the right to temporarily delay withdrawal from the Plan in order to ensure that securities liquidations would be carried out in an orderly business manner.

For the investments in pooled separate accounts, as of March 27, 2023 and December 31, 2022, there were not any unfunded commitments or redemption notice periods and the redemption frequency was daily. Pooled separate accounts invested primarily in long-term bonds, domestic and international stocks, or single mutual funds. These funds seek both capital and appreciation and include a combination of assets, such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets. The allocation percentage to each asset type might be fixed, bounded by a range, or determined at the discretion of the manager. Managers of these funds reviewed market conditions regularly and refined the asset allocation mixture they believed would achieve the best risk adjusted performance based on the stated objectives and target allocations of the particular fund. The underlying investments held by each pooled separate account were traded on an active market.

Fair Value of Investments in Entities That Use NAV

The method described above may produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believed its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Update No. 2015-07, *Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*, certain investments that were measured using NAV per share (or its equivalent) as a practical expedient had not been classified in the fair value hierarchy. At both March 27, 2023 and December 31, 2022, all investments were either reported at contract value or were in pooled separate accounts and were measured at fair value, using NAV as practical expedient. Accordingly, no fair value hierarchy was presented.

The Plan invested in a guaranteed interest contract with Empower, which was a fully benefit-responsive investment contract. Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

As described in Note 2, because the guaranteed interest contract was fully benefit-responsive, contract value was the relevant measurement attribute for net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants might ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate was based on a formula agreed upon with the issuer, but it might not be less than one percent. Such interest rates are reviewed on a monthly to quarterly basis. During the period from January 1, 2023 through March 27, 2023, the interest rate was 1.35%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include, but might not be limited to the following: 1) the complete or partial termination of the Plan, 2) the establishment of, or material change in, any Plan investment fund, or 3) an amendment to the Plan or a change in the administration or operation of the Plan. The Plan administrator did not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, was probable.

The guaranteed interest contract might be terminated by Empower upon the Plan's establishment, activation, or material change to any Plan investment fund that Empower determined would prevent its ability to continue to operate the contract under the current terms. Termination of the guaranteed interest contract by Empower might result in the settlement of the outstanding balance at an amount that differed from contract value.

5. Information Certified by the Plan's Trustee (Unaudited)

The Plan administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at March 27, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest from notes receivable from participants, and interest and dividends for the period from January 1, 2023 through March 27, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. Federal Income Tax Status

The Plan was based on a non-standardized pre-approved profit-sharing, money purchase, CODA plan developed by Nova 401k Associates, Inc., which received a favorable advisory letter dated June 30, 2020, from the IRS stating that the pre-approved plan constitutes a qualified plan under Section 401 of the IRC. The Plan Administrator believed the Plan, as adopted, and amended, was operating within the guidelines of the IRC and continues to be tax-exempt. Accordingly, no provision for federal income taxes had been provided in the accompanying financial statements.

6. Federal Income Tax Status, continued

U.S. GAAP requires Plan management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the DOL and IRS. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of March 27, 2023 and December 31, 2022, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

On March 27, 2023, the Plan was merged into another qualified plan, an existing plan administered by the Company. The accounts of all of the Company's employees were transferred out of the Plan to this existing plan, and there were no remaining balances in the Plan.

8. Party-in-Interest Transactions

Certain Plan investments were in accounts managed by the Trustee. In addition, the Plan issued notes receivable from participants and paid expense to the Trustee. These transactions qualify as party-in-interest transactions, as defined by ERISA; however, these transactions were permitted under the provisions of the Plan and were exempt from the prohibition of party-in-interest transactions under ERISA.

9. Delinquent Participant Contributions

During the period from January 1, 2023 through March 27, 2023, the Company determined that certain employee deferrals and loan repayments aggregating \$21,909 had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allowed. An investigation was held to determine the root cause of the delinquent contributions, and corrective measures were taken. The lost earnings for 2023 contributions, estimated at less than \$100, would be processed and deposited to participant accounts in another qualified plan, that is administered by the Company, during 2024.

10. Subsequent Events

The Plan management has evaluated subsequent events through January 12, 2024, which is the date the financial statements were available to be issued, and had noted no other significant events to be reported.
