### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Austin Medical Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 5, 2023, December 31, 2022, and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 through June 5, 2023 and the years ended December 31, 2022 and 2021, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 5, 2023 and December 31, 2022 and 2021, and for the period from January 1, 2023 through June 5, 2023 and the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

and the Years Ended December 31, 2022 and 2021

### **1. Description of the Plan**

The following description of the Austin Medical Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Mayo Clinic Health System (MCHS) – Austin is the plan sponsor.

#### **General**

The Plan is a defined contribution plan that covered all employees of Austin Medical Center (the Medical Center) prior to December 31, 2014. Prior to December 31, 2014, all employees were eligible to participate in the Plan on the first day of employment, as defined by the Plan. After December 31, 2014, only those employees subject to the MCHS – Austin USW (service group) collective bargaining agreement were eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Mayo Clinic Director of Benefits resolved on September 25, 2014 to freeze the Plan, effective December 31, 2014. Accordingly, no employees were eligible to participate in the Plan, except for service group employees as noted above, and no contributions were allowed to the Plan after December 31, 2014, except for service group employees. All participants affected by the freeze were 100% vested in their account balances at that time. Effective January 1, 2015, the affected employees became participants in the Mayo 403(b) Plan, which is sponsored by the parent company of the Medical Center.

Effective June 30, 2015, the Mayo Clinic Director of Benefits resolved to transfer the assets of terminated participants and those participants no longer able to participate in the Plan into the Mayo 403(b) Plan.

On October 18, 2022, the union members belonging to the service group bargaining unit in Austin voted to decertify from the union, becoming non-union employees. Upon decertification, Mayo Clinic ceased participation in the Plan and transitioned the employees to the standard Mayo Clinic 403(b) Plan. On June 5, 2023, assets totaling \$2,052,068 were transferred to the Mayo 403(b) Plan.

## Austin Medical Center 403(b) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Contributions**

Contributions were made in pretax dollars through payroll deductions and could be started, changed or stopped at any time. Participants were also permitted to make Roth after-tax deferrals to the Plan. Employees could contribute up to 100% of their compensation, as defined by the Plan, up to the Internal Revenue Service (IRS) limits. The IRS limit for 403(b) deferral contributions was \$20,500 in 2022 and \$19,500 in 2021, with an additional catch-up contribution limit of \$6,500 for participants 50 years of age or older. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan also provided an employer matching contribution equal to 50% of a participant's contributions up to \$1,056 for a maximum employer match of \$528.

Contributions were subject to certain limitations.

##### **Participant Accounts**

Each participant's account was credited with the participant's contributions, the Medical Center's contributions, and an allocation of plan earnings and administrative expenses. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

##### **Participant-Directed Investments**

The Plan selected investment options, as described in the Plan's literature, from which participants could select. The funds varied in type of investments, rate of return, and investment risk. Amounts were deposited with Fidelity Management Trust Company (the Custodian) and were credited to the individual participant accounts. Participants self-direct the investments in their account and could allocate their account balance to the various investment options in any combination. Such allocations could be changed at any time during the year.

## Austin Medical Center 403(b) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Vesting**

Participants vested immediately in their contributions plus actual earnings thereon. Vesting in the Medical Center's contributions to participants' accounts, plus actual earnings thereon, was based on years of service. A year of service was defined as one where the participant worked at least 1,000 hours in the Plan year. A participant vested at a rate of 10% per year for the first two years of service, and then at a rate of 20% per year for the next four years of service, and the participant was 100% vested after six years of credited service or at the time of death, normal retirement age or incapacity, as defined by the Plan agreement.

##### **Payment of Benefits**

Upon termination of employment, retirement, death, or becoming permanently disabled, a participant with an account balance of \$1,000 or more was normally paid in the form of a lump-sum distribution or installment payments. If a participant terminated employment and the participant's account balance was never greater than \$1,000, the plan administrator could authorize the benefit payment in a single lump sum, without the participant's consent. During employment, participants were allowed to withdraw account balances upon attainment of age 59½.

##### **Forfeitures**

At December 31, 2022 and 2021, forfeited non-vested accounts totaled approximately \$770 and \$1,400, respectively. The accounts were used to reduce future employer contributions or pay Plan expenses. In 2021, employer contributions were reduced by approximately \$3,500, from the forfeited non-vested accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Presentation**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Mayo Clinic's Investment Subcommittee determines the Plan's valuation policies utilizing information provided by investment advisors, the Custodian, or other third parties. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### **Payment of Benefits**

Benefits payments were recorded upon distribution.

##### **Administrative Expenses**

Plan administration fees paid by the Plan were included in the accompanying financial statements. In addition, the Medical Center paid a portion of the Plan's administrative expenses, which are not included in the Plan's financial statements.

#### **3. Fair Value Measurements**

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the same term of the financial instrument.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The Plan's policy is to recognize transfers in and transfers out as of the actual date of the event or change in the circumstances that caused the transfer. For the period from January 1, 2023 through June 5, 2023 and for the year ended December 31, 2022 and 2021 there were no transfers.

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

#### **Mutual Funds**

Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

##### Variable Annuity

The TIAA CREF variable annuity is valued at the daily unit value published on NASDAQ; however, the fund is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

#### 4. Fully Benefit-Responsive Investment Contracts

The Plan held traditional investment contracts. These contracts met the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

#### **4. Fully Benefit-Responsive Investment Contracts (continued)**

Contract value of the general insurance accounts, were reported to the Plan by the Custodian and represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contracts held by the Plan were guaranteed investment contracts. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The contract could not be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The crediting interest rate for all investment contracts is based on a formula agreed upon with the issuers, and such interest rates are reset monthly, quarterly, semiannually or annually.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction exemption under ERISA, or (5) premature termination of the contracts. The plan administrator did not believe that any events would limit the Plan's ability to transact at contract value with participants are probable.

#### **5. Investments**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 5, 2023 and December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the period from January 1, 2023 through June 5, 2023 and the year ended December 31, 2022 and 2021, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Custodian of the Plan.

#### **6. Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments were managed by Fidelity Management Trust Company. Fidelity Management Trust Company was the Custodian, as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Medical Center has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA and the collective bargaining agreement.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **9. Tax Status**

The underlying prototype plan has not received an opinion letter from the IRS stating that the underlying prototype plan is qualified under Section 403(b) of the Internal Revenue Code (IRC). The plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
