### Note A – Description of Plan

The following description of the Flotech, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all employees of Flotech, Inc. and Hawk Valve, Inc. (collectively, the “Company” or the “Employer”) who have completed 90 days of service and are at least 21 years of age, excluding nonresident aliens and union employees. Employees are automatically enrolled in the Plan with deferral set at 4% of compensation unless they opt-out, and eligibility changed from one year service to 90 days. The Plan was established effective June 1, 2011 and most recently restated effective November 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective September 2, 2022, the Plan was terminated and all assets and liabilities disbursed as of December 29, 2022.

#### Administration

The accounting records are held and managed by Empower Trust Company, LLC (the “Custodian”). The record-keeper and third party administrator is Empower. Contributions are held by the Custodian, who invest cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Contributions

Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the period from January 1, 2022 to December 29, 2022 was \$20,500. A participant who has attained the age of 50 may also make catch up contributions, subject to Internal Revenue Service limitations of \$6,500 for the period from January 1, 2022 to December 29, 2022. Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. Participants also have the option to make Roth contributions.

The Employer may elect to make a discretionary matching contribution each year. During 2022, the Company elected to match 50% of participant deferrals up to a maximum of 3% of eligible compensation. The Employer may also make discretionary profit-sharing contributions to the Plan during the year. No profit-sharing contributions were made for the period from January 1, 2022 to December 29, 2022.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Employer’s profit sharing or matching contribution amounts, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant’s account. Allocations of Plan earnings or losses are based on each participant’s investment fund balance in proportion to the total investment fund balance.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions and related earnings is based on years of continuous service. Participants must work at least 1,000 hours during the year to be credited with a year of service.

A participant is 100% vested upon death, disability, retirement age, or after five years of credited service as follows:

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's vested account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loan terms have a minimum of one year and may not exceed five years, unless the loan is used for the purchase of a primary residence. No more than three loans may be outstanding at a time for a participant and loans may not be consolidated or refinanced. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan Administrator shall consider a loan in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. In the event of a death, the entire outstanding principal and accrued interest shall be immediately due and payable. Upon determination that the loan has been defaulted, the loaned funds will be treated as a taxable distribution from the Plan.

#### Distribution of Benefits

On termination of services for any reason, a participant (or beneficiary) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals or annual installments. Other than termination, participants may not withdraw their contributions until they attain age 59½, or prove a financial hardship under specific circumstances. In the event of a financial hardship withdrawal, a participant is precluded from making contributions to the Plan for six months following the distribution.

#### Forfeitures

Non-vested benefits of terminated participants are forfeited on the date the participant receives a complete distribution of vested benefits. For the period from January 1, 2022 to December 29, 2022, forfeitures of approximately \$39,000 were utilized by the Plan to reduce Employer contributions and Plan expenses. As of December 29, 2022 and December 31, 2021, forfeited non-vested accounts totaled approximately \$0 and \$4,000, respectively.

##### Plan Termination

As described in the General section, the Company amended the Plan effective September 2, 2022 to terminate the Plan and distribute its assets in accordance with the provisions provided by ERISA. The Plan has determined that the liquidation basis presentation of the assets for the Plan period ended December 29, 2022, the date all assets were distributed from the Plan, and for the period from January 1, 2022 to December 29, 2022 approximate or equal fair market value. No significant changes were required to present the financial statements on a liquidation basis. As of September 2, 2022, in accordance with the Plan adoption agreement, all participants' balances became fully vested in all types of contributions received in the Plan. All appropriate accounting provisions of the Plan continued to apply until the accounts of all participants had been distributed.

#### Note B – Summary of Significant Account Policies

##### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

##### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

##### Valuation of Investments

The Plan's investments in mutual funds are stated at fair value, which is based on quoted market prices at year-end as reported by the Custodian. See discussion at Note F on valuation of the fixed income annuity contract, which meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

##### Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the period from January 1, 2022 to December 29, 2022 and the year ended December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 29, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022 to December 29, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution. As of December 29, 2022 and December 31, 2021 and for the period from January 1, 2022 to December 29, 2022, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The Plan has received a determination letter from the IRS dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2020.

### Note E – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. The Fixed Income Annuity Contract is managed by the Custodian. Transactions related to this investment qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$34,000 during the period from January 1, 2022 to December 29, 2022.

The Plan invests in a fully benefit-responsive investment group fixed income annuity contract (the "Fund"). The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. As described in Note B, because the fixed income annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed income annuity contract. The investments are included in the financial statements at contract value as reported to the Plan by the Fund. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The fixed income annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

#### **Note F – Fully Benefit-Responsive Investment Contracts (continued)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. Effective September 2, 2022 the Plan terminated and as of December 29, 2022 the Plan had no fully benefit-responsive investment contracts.
