Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bio-Techne Corporation and Affiliates Stock Bonus Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 3, 2023 and June 30, 2022, and the related statement of changes in net assets available for benefits for the period ended March 3, 2023, and the related notes to the financial statements.

Basis for Opinion

Note 1 - Description of Plan

The following brief description of the Bio-Techne Corporation and Affiliates Stock Bonus Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering qualified employees of Bio-Techne Corporation (the Company) and its wholly owned subsidiaries. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees were responsible for oversight of the Plan.

The Investment Committee determined the appropriateness of the Plan's investment offerings, and monitored investment performance and reported to the Plan's Board of Trustees.

The Plan was administered by a benefits committee (the Investment Committee). The Investment Committee had the power to carry out provisions of the Plan, including the administration of Plan, and determined the appropriateness of the Plan's investment offerings and monitored performance.

As noted in Note 10, the Plan merged into the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan.

Eligibility

Employees were eligible to participate in the Plan if they had completed one year of service. A year of service for purposes of eligibility was a consecutive 12-month period during which the employee had 750 or more hours of service.

Entry Date

Employees entered the Plan on the first day of January or July coinciding with or following the date they satisfied the Plan's eligibility requirements.

Contributions

Employer contributions were determined annually at the discretion of the Company and was approved by the Board of Directors. Contributions were subject to certain Internal Revenue Code (IRC) limitations. The Plan did not allow participants to contribute amounts representing distributions from other qualified plans (rollovers). The Company intended to make contributions in the form of common stock of the Company, but contributions may have been made in the form of cash or other property. To receive an employer contribution, an eligible participant must have been an active employee on the last day of the Plan year and had worked at least 750 hours during the Plan year. An eligible participant also shared in the stock bonus contribution for the Plan year in which termination occurred as a result of death, disability, or retirement at or after the early retirement age (age 55) or normal retirement age (age 65), regardless of whether a year of service was completed. The Company did not make discretionary employer contributions for the period ended March 3, 2023.

Participant Accounts

Each participant's account was credited with an allocation of the employer's contributions, if applicable, Plan earnings/losses, and forfeitures. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

A participant's share of the stock bonus contribution or forfeiture allocation was equal to the ratio the participant's compensation bears to the sum of the compensation of all participants eligible to share in the allocation.

Investment Options

Upon enrollment to the Plan, a participant could direct the investment of cash dividends received on shares of the Company stock in any of the funds offered by the Plan. Participants could change their investment options daily.

Vesting

A participant became fully vested in employer contributions upon reaching early or normal retirement age, death, becoming disabled, or, absent those events, according to the following schedule, based on the number of years in which the participant had worked at least 750 hours:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2 years	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

Payment of Benefits

Participants could elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated participant with a balance of less than \$1,000 could be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 could still be automatically paid out if their balance was rolled into a qualified Individual Retirement Account. Distributions could be made at the participant's election prior to termination upon attainment of age 59½.

The Plan permitted distributions in the form of Bio-Techne Corporation stock or cash. The Plan did not permit participants to borrow from their accounts. The Plan did not allow hardship distributions. Distributions in the form of stock were recorded at market value at the date of distribution.

Once a participant had been credited with three years of vested service, a participant was allowed to diversify out of the employer securities into other investment options by transferring all or a portion of their account into the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan, which was also administered by the Company.

Plan Termination

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would have become 100% vested in their employer contributions. As noted in Note 10, the Plan merged into the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan sponsor has evaluated subsequent events through January 15, 2024, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 3, 2023 and June 30, 2022.

Company common stock – Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements, including investments held at March 3, 2023 and June 30, 2022 and net depreciation in fair value of investments, interest, and dividends, for the period ended March 3, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the trustee of the Plan).

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated February 12, 2014, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of this determination letter, the Plan was amended. However, the Company and Plan management believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan was qualified and the related trust continued to be tax-exempt until the merger.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Related Party and Party-in-Interest Transactions

Certain Plan investments as of June 30, 2022, and during the period ended March 3, 2023, consist of mutual funds and Plan sponsor common stock managed by Matrix Trust Company, the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities, including common stock of the Company. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Investment Diversification Transfer

Effective July 1, 2007, the Plan was amended to comply with the diversification of employer securities requirements of the Pension Protection Act of 2006. Once a participant has been credited with three years of vested service, a participant is allowed to diversify out of the employer securities into other investment options by transferring all or a portion of their account into the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan, which is also administered by the Company. During the period ended March 3, 2023, \$272,100 was transferred out of the Plan to the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan as a diversification.

Note 10 - Transfer to Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan

The Bio-Techne Corporation and Affiliates Stock Bonus Plan merged into the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan on March 3, 2023. The amount that was transferred into the Bio-Techne Corporation and Affiliates Profit Sharing and Savings Plan as a result of the merger was \$63,824,762.
