Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Inform Diagnostics, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 2, 2023, December 31, 2022, and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 through March 2, 2023, and the year ended December 31, 2022, and the related notes to the financial statements.

1. Description of the Plan

General

The Inform Diagnostics, Inc. 401(k) Plan (the Plan), originally established December 1, 1998 and amended and restated January 1, 2022, due to a new favorable determination letter from the Internal Revenue Service (IRS). The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is sponsored by Inform Diagnostics, Inc. (the Company or Plan Administrator) and adopted by related entities, Metroplex Pathology Associates, formally known as Caris Pathology and Therapath Partners, LLC (collectively, Adopting Employers). Charles Schwab Trust Bank serves as the Trustee and Schwab Retirement Plan Services, Inc. the recordkeeper for the Plan. The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective January 1, 2023, the Plan merged into the Fulgent Therapeutics LLC 401(k) Profit Sharing Plan and Trust (the Affiliated Plan) and transferred all assets as of March 2, 2023. This has been recorded as a Transfer out to Affiliated Plan of \$54,517,651 in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2023 through March 2, 2023.

Eligibility and Participant Accounts

Employees of the Company and Adopting Employers, as defined by the plan document, become eligible for participation upon completing one month of service, except employees covered by a collective bargaining agreement, nonresident aliens, and Puerto Rican employees. Subject to certain limitations on annual additions, each participant's account is credited with employee elective deferrals, Company safe harbor matching, and discretionary nonelective contributions, and an allocation of Plan earnings or losses and charged with certain administrative expenses.

Contributions

The Plan is funded through participant elective deferrals, Company safe harbor matching contributions, Company safe harbor discretionary matching contributions, and Company discretionary nonelective contributions. A participant may elect to contribute a portion of his or her pre-tax or after-tax (Roth) compensation from 1% to 80%, subject to certain maximum limitations imposed by the Internal Revenue Code (IRC) (\$22,500 for 2023 and \$20,500 for 2022). Employees who are eligible to make elective deferrals under the Plan and who have attained the age of fifty before the close of the Plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC (\$7,500 for 2023 and \$6,500 for 2022). Rollover contributions representing distributions from other qualified defined benefit or defined contribution plans are permitted by the Plan.

For the year ended December 31, 2022, the Company made safe harbor matching contributions in the amount of 100% up to 3%, and 50% up to 5% of the participant's elective deferrals. No Company safe harbor discretionary matching contributions or Company discretionary nonelective contributions were made for the year ended December 31, 2022. No Company safe harbor matching contributions, Company safe harbor discretionary matching contributions, or Company discretionary nonelective contributions were made for the period from January 1, 2023 through March 2, 2023.

Investment Options

The Plan provides for contributions to be invested by the Trustees among a variety of investment options, including mutual funds of registered investment companies, common collective trusts, and a self-directed brokerage account in accordance with participant investment elections and the provisions of the trust agreement. Participants should refer to the plan website for additional fund information.

Benefits Paid to Participants

Participants withdrawing amounts from their account during the year for reasons of disability, retirement, death (withdrawn by participant's estate), or termination are entitled to their vested account balance. Participants may also make hardship withdrawals on the balance of their account related to their elective deferral matching, and discretionary nonelective contributions. For vested account balances greater than \$5,000, participants may elect a distribution in the form of rollovers, lump sums, in partial withdrawals, or installment payments. Upon termination, vested account balances less than \$5,000 may be distributed to the applicable terminated participant within a reasonable time after terminating employment.

Vesting

Participants are immediately vested in elective deferrals, Company qualified nonelective contributions, Company safe harbor matching contributions, Company safe harbor discretionary matching contributions, or Company discretionary nonelective contributions, plus any actual earnings, thereon.

Forfeitures

Forfeitures of terminated participants' nonvested accounts may be used to reduce Company contributions, pay plan expenses or reallocated to participants. These amounts are reported as a component of net assets available for benefits. At March 2, 2023, December 31, 2022, and December 31, 2021, there were forfeitures of \$0, \$760, and \$136 available for use, respectively. These amounts were reported as a component of net assets available for benefits. During 2023 and 2022, \$11 and \$0 of forfeitures were used to pay plan expenses, respectively. No forfeitures were used to reduce Company matching contributions. During 2023, \$751 of forfeitures were transferred to the Affiliated Plan.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to 50% of their vested account balance, not to exceed \$50,000. Note terms range from one to five years or, in the case of a loan to acquire or construct the primary residence of a participant, a period not to exceed fifteen years. The notes receivable from participants are secured by the balance in the participant's account and bear a reasonable rate of interest. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections. On February 1, 2023, the notes receivable balance of \$604,980 was transferred out of the Plan to the Affiliated Plan. At December 31, 2022, maturity dates on existing notes receivable from participants ranged from January 2023 through October 2036, and notes receivable had interest rates from 4.25% to 8.50%. At December 31, 2021, maturity dates on existing notes receivable from participants ranged from February 2022 through October 2036, and notes receivable had interest rates from 4.25% to 6.50%.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees paid related to benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

SECURE 2.0 Act

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3, Fair Value Measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The income or loss earned on participant accounts is allocated on a daily basis using the previous day's ending account balance. Net appreciation (depreciation) of fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value. Delinquent notes receivable from participants are reclassified as distributions based upon terms of the plan document or note policy of the Plan. Notes receivable are valued at amortized cost, which approximates fair value. No allowance for credit losses has been recorded as of March 2, 2023, December 31, 2022, or December 31, 2021.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Significant observable inputs other than quoted prices in active markets for which inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds of registered investment companies are valued at the net asset value (NAV) or quoted market prices of shares held by the Plan at year-end.

Common collective trusts are valued at the NAV of shares held by the Plan at year-end, as determined by the Trustee. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trusts, the Trustee reserves the right to temporarily delay withdrawals from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage funds include investments in cash and short-term interest-bearing investments, mutual funds of registered investment companies, common stock, and unit investment trusts, with initial maturities of three months or less. The cash and short-term interest-bearing investment amounts are recorded at cost, plus accrued interest. The mutual funds of registered investment companies, common stock, and unit investments within the self-directed brokerage account are valued at the NAV of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants; even so, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan is based on a non-standardized pre-approved profit sharing/money purchase/CODA plan, developed by Schwab Retirement Plan Services, which received a favorable advisory letter dated September 21, 2020, from the IRS stating that the non-standardized pre-approved profit sharing/CODA plan, constitutes as a qualified plan under Section 401 of the IRC. The Plan Administrator believes the Plan, as adopted and amended, is operating within the guidelines of the IRC, and continues to be tax-exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, concentration, and credit risks. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
