Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Blacksmith Applications, Inc. 401(k) Plan (the "Plan") ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the period January 1, 2022 to December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As further discussed in Note 1 to the financial statements, the Board of Directors of TELUS Agriculture Holdings (US) Inc. authorized the merger of all assets of the Plan into the Telus Agriculture (US) Retirement Plan (“Telus Plan”) with an effective date of December 31, 2022, and accordingly, all plan assets were transferred to the Telus Plan on December 31, 2022. This Plan will terminate upon the merger into the Telus Plan. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the Blacksmith Applications, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan that was most recently amended and restated on January 1, 2022, is sponsored by Blacksmith Applications, Inc. (the “Company”) for the benefit of its full-time employees age 21 or older once they have reached 90 days of employment. Employees covered by a collective bargaining agreement are not eligible to participate in the Plan as well as interns, non-resident aliens, and residents of Puerto Rico. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments were participant-directed.

Plan Mergers and Termination

The Board of Directors of TELUS Agriculture Holdings (US) Inc. authorized the merger of all assets of the Plan to the TELUS Agriculture (US) Retirement Plan (“Telus Plan”) with an effective date of December 31, 2022, and accordingly, all plan assets were transferred to the Telus Plan on December 31, 2022. Upon the merger, the Plan will terminate.

Effective January 1, 2022 the Tabs Group Inc 401k Profit Sharing Plan and Trust (“Tabs Plan”) was merged into the Plan. As a result, investments of approximately \$6,356,823 and an employer match due to Tabs employees of \$94,292 were transferred into the Plan on January 3, 2022.

Participant Contributions

Participants were able to defer a percentage (up to 100%) of their eligible annual compensation, as defined by the Plan, subject to dollar limits set by Federal law. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

Employer Contributions

Effective January 1, 2022, the Plan was amended to provide for a safe harbor matching contribution of 100% of a participant’s contribution to the Plan on a pay period basis, up to a maximum of 4% of the participant’s deferral percentage. The Plan also allows for non-elective contributions and discretionary matching contributions, which were not made during the year ended December 31, 2022.

Note 1 - Description of Plan (Continued)

Participant Accounts

Each participant's account was credited with the Participant's contributions and allocations of the Employer's contributions Plan earnings, and reduced by direct loan fees and benefit disbursement processing fees. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Vesting

Participants were immediately vested in all deferral contributions plus actual earnings thereon. Participants become fully vested in Employer contributions after six years of service, as defined by the Plan. Employees hired prior to January 1, 2020 were subject to the prior 2 year cliff vesting schedule and participants who are employed by Tabs Group, Inc. are 100% immediately vested.

Participants also became fully vested upon death, disability or attainment of retirement age.

Payment of Benefits

In-service withdrawals were permitted from all vested accounts upon the attainment of age 59½. In-service withdrawals were also permitted due to financial hardship. Participants were entitled to their total vested account balance upon death, disability, retirement or termination of employment. A participant may elect to receive a lump-sum amount equal to the value of his or her accounts or an annuity. If a participant's vested account is less than \$5,000, the Plan administrator, after notification, may distribute the entire non-forfeited account balance to the Participant.

Notes Receivable from Participants

Participants were able to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their employee elective contribution accounts. Participants could not have more than one loan outstanding at any one time. Loans ranged from one to five years (or longer for the purchase of a primary residence). The loans were secured by the vested balance in the Participant's account and bear interest based on the Federal Reserve Board Bank prime rate plus one percent. Principal and interest are either paid directly to the custodian by the Participant or ratably through payroll deductions.

Forfeitures

At December 31, 2021, forfeited amounts totaled \$0. As part of the merger on December 31, 2022, \$9,235 of forfeitures were transferred to the Telus Plan. Forfeitures were used to offset Plan expenses and to reduce Employer contributions and consist of funds from over funding of contributions. No forfeitures were used in 2022.

Plan Administration

The Employer was the Plan administrator and had the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts were charged directly for loan fees and benefit disbursement processing fees, if applicable. General operational expenses were charged to the Plan and all other expenses incurred in the administration of the Plan are paid by the Employer.

Administrative Expenses

Certain expenses of maintaining the Plan may be paid by the Employer at its discretion and may be excluded from the financial statements.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting which is in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments other than fully benefit-responsive investment contracts (valued at contract value) were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities were recorded on a trade-date basis. Interest was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses was has been recorded as of December 31, 2021.

Benefits Paid

Benefits were recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Subsequent Events

The Employer has evaluated subsequent events through December 6, 2023, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Voya, an Insurance Company

Plan investments were held by Voya Retirement Insurance and Annuity Company (“Voya”), the custodian of the Plan. Voya has certified to the fair and contract value of investments as of December 31, 2021 and investment transactions for the year ended December 31, 2022. Investment transactions included interest and dividends and net depreciation in fair value of investments. Notes receivable from participants as of December 31, 2021 has also been derived from information certified by the custodian.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled separate accounts: Valued at the NAV of units of the separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The pooled separate account investments held by the Plan as of December 31, 2021 amounted to \$9,877,698, and based on the fair value hierarchy, were measured at NAV (a) as of December 31, 2021.

(a) In accordance with Accounting Standards Codification ("ASC") Subtopic 820-10, "Fair Value Measurements", certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified within the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy amounts to amounts presented in the Statements of Net Assets Available for Benefits.

Notes to Financial Statements

Note 5 - Fully Benefit-Responsive Investment Contract

Following is a description of the investments and valuation methodologies for fully benefit-responsive investment contracts:

Fixed Account

The Plan had a fully benefit-responsive group annuity contract with Voya. Voya maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. A crediting rate is established for amounts invested in the fixed account. The crediting interest rate for December 31, 2021 was 1.00%. Participants were allowed to direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represented contributions plus credited interest less participant withdrawal and fees. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The contract value of the Plan's fully benefit-responsive fixed account contract at 2021 was \$648,570.

Note 6 - Plan Termination

As noted in Note 1, all contributions into the Plan were frozen and the Plan was merged into the Telus Plan effective December 31, 2022.

Note 7 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as an international conflict that could impact the value of investment securities.

Note 8 - Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are units in pooled separate investment accounts and a guaranteed interest account managed by Voya, the insurance company as defined by the Plan, and, therefore, these transactions qualify as party-in-interest. For the year ended December 31, 2022, fees paid to Voya amounted to \$24,745.

Note 9 - Tax Status

The Plan has adopted the Angell Pension Group Inc Volume Submitter Profit Sharing Plan document. The Internal Revenue Service (“IRS”) has determined and informed the Plan, by letter dated June 30, 2020, that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the Internal Revenue Code (the “Code”). The Plan has been amended since that date, however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes is included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Prohibited Transactions

Under U.S. Department of Labor Regulation Section 2510.3-102, Plan related salary deferrals and loan repayments withheld from employees’ paychecks must be deposited into the Plan as soon as reasonably possible. When this regulation is not satisfied, the Plan Sponsor has engaged in a prohibited transaction. While the Plan Sponsor remitted substantially all employee contributions to the Plan, employee contributions of \$65,082 were not remitted within the required time period for the year ended December 31, 2021. During 2021, \$17,129 along with lost earnings were remitted to the Plan. The remaining \$47,953 was remitted during the year ended December 31, 2022 along with lost earnings.
