To the Trustees and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1: Description of Plan

The following description of the Lasher Auto Group 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan terminated effect December 1, 2022 and was liquidated as of March 31, 2023.

General. The Plan is a defined contribution plan covering all full-time employees of the participating companies except collective bargaining employees and nonresident aliens who do not receive United States source income, who have six months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The participating companies are all members of the Lasher Automotive Group ("the Company"): Elk Grove Dodge, Elk Grove Volkswagen, Elk Grove Acura, Elk Grove Audi, Elk Grove Subaru, and Lasher Volkswagen.

Administration. The Plan has contracted with Capital Bank and Trust Company to serve as directed trustee, and The American Funds Plan Premier ("American Funds") to serve as the plan's administrator to manage certain operations of the plan and to process and maintain certain participant records.

Contributions. Each year, participants may contribute 1-100% of their compensation, as defined in the Plan, and subject to IRS annual limits. The Company may make matching contributions equal to a discretionary percentage of the participant's salary deferral. The Company did not make any matching contributions for the 2017 plan year. The Company may also make a discretionary profit sharing contribution that is allocated based on each participant's compensation as compared to total compensation of all participants.

Participant Accounts. Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each mutual fund investment includes internal expense ratios ranging from approximately .33%-.70%. These expenses are reflected in each fund's investment return and participants' accounts are not charged separately. Participants should refer to the mutual funds' prospectuses and the Plan's "Participant Fee Disclosure" for details of these fees.

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of service.

Forfeitures and Fee Credits. The total non-vested portion of terminated employees account balances are used by the plan sponsor to offset expenses, or as either additional employer matching contributions or additional employer discretionary contributions, or to reduce employer contributions, depending on the original source of the employer contribution. There were no forfeitures generated or forfeitures used in the short plan year ending March 31, 2023. As of March 31, 2023 there were no remaining unused forfeitures available.

Investment Options. Upon enrollment in the Plan, a participant may direct employee contributions in various increments to the investments administered by American Funds. Participants may change their investments daily and can choose from several available mutual funds in the American Funds portfolio of investment options.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. All investments available in the plan allow for daily redemptions with no redemption notice period required.

Note 1: Description of Plan (continued)

Notes Receivable from Participant. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan balances may be paid over a reasonable period of time not to exceed five years, except in the case that the proceeds of the loan are used to acquire a dwelling to be used as the Participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at the rate of the prime rate published in The Wall Street Journal on the first business day of each month, plus 1%.

Amendments. There were no amendments to the plan during the short plan year ending March 31, 2023.

Note 2: Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting. Assets and liabilities are stated at liquidation value as of March 31, and December 31, 2022, which is substantially equivalent to fair value for the assets held in the Plan. There is no effect on the comparability of the 2023 plan year, and the 2022 plan year. There are no accrued costs or income related to the Plan's liquidation.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Risks and Uncertainties - The Plan provides for various investment options which are exposed to a variety of risks, including interest rate, market fluctuations, valuation, and credit risks. Due to the level of risk associated with certain investments, it is possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Plan management has evaluated subsequent events through January 12, 2024, the date the financial statements were available to be issued.

Note 3: Information Certified by Trustee

Capital Bank and Trust, the trustee of the Plan, has certified as to the completeness and accuracy of all investments and participant notes receivable reflected on the accompanying Statements of Net Assets Available for Benefits as of March 31, 2023 and December 31, 2022, the investment income and interest from participant notes reflected on the Statement of Changes in Net Assets Available for Benefits for the short year ended March 31, 2023, and all investment information reflected in the supplemental Schedule of Investments Held (at End of Year) as of March 31, 2023, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. This information has been certified as complete and accurate.

Note 4: Fair Value Measurements

Financial Accounting Standards Board ASC 820-10 (formerly FASB Statement No. 157, Fair Value Measurements), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds: Valued at the net asset value ('NAV') of shares held by the plan at year end as reported by Capital Bank and Trust Company, the trustee of the Plan, based on quoted market prices.

Note 4: Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Plan Termination

On October 25, 2022, the plan sponsor terminated the plan effective December 1, 2022. The Company's assets were sold to another company. As a result of the plan's termination, all participants became 100% vested in any employer contributions in the plan. During the first quarter of the 2023 plan year, all plan assets were either distributed to terminating employees, or transferred to the acquiring company's 401(k) plan for participants remaining with the acquiring company.

Note 6: Tax Status

The Plan uses the prototype plan document Defined Contribution Pre-Approved Plan, sponsored by Capital Group Retirement Plan Services who received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administration has analyzed the tax positions taken by the plan, and has concluded that as of March 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 7: Administrative Expenses

The plan paid additional record keeping and advisor fees in the fourth quarter of 2023 when plan termination was imminent; therefore there were no administrative fees for the short plan year ended March 31, 2023. Each mutual fund investment also includes internal expense ratios ranging from approximately .33% - .70%.

Note 8: Reconciliation of Financial Statements to Schedule H of Form 5500

The Plan's Form 5500 is prepared on a cash basis of accounting while these financial statements are on the accrual basis. The following is a reconciliation of differences in certain amounts per the financial statements and amounts reported on Schedule H of Form 5500:

Due to the cash vs. accrual differences detailed above, the net decrease in assets in liquidation available for benefits is \$1,413 greater than what is reported on schedule H of form 5500.

Note 9: Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan's investments are mutual funds managed by American Funds, the Plan's Record Keeper. American Funds is the investment advisor for these investments, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to American Funds for investment management services of these underlying mutual funds is included as a reduction of the return on each fund. Notes receivable from participants also reflect party-in-interest transactions.

Note 10: Prohibited Transactions - Delinquent Participant Contributions

During the prior plan year ending December 31, 2022, the Plan sponsor inadvertently failed to deposit \$26,364 of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions.
