### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Quincy Medical Group Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 1, 2023, December 31, 2022 and 2021, the related statements of changes in net assets available for the period January 1, 2023 through May 1, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of May 1, 2023 and December 31, 2022, and for the period January 1, 2023 through May 1, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter-Plan Merger**

As discussed in Note 1 to the financial statements, the Board of Directors of Quincy Physicians & Surgeons Clinic S.C., the Plan's sponsor, voted on April 28, 2023, to merge the Plan into the Duly Health and Care Profit Sharing/401(k) Plan effective May 1, 2023. All plan assets were transferred to the Duly Health and Care Profit Sharing/401(k) Plan, on May 1, 2023.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Description of the Plan

The following description of the Quincy Medical Group Retirement Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Plan merger:** On May 1, 2023, the Plan was merged into the Duly Health and Care Profit Sharing/401(k) Plan (Duly Plan). As a result, net assets of \$164,579,626 were transferred to the control of the Duly Plan on May 1, 2023. The merger does not impact participant benefits as the benefit provisions were incorporated in the Duly Plan. Concurrent with the merger the Duly Plan's name was changed to Duly Health and Care 401(k) Plan.

**Financial statement presentation:** These financial statements include the year ended December 31, 2022, and the period January 1, 2023 through May 1, 2023. The Plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2022 as permitted by 29 CFR 2520.104-50, since the following plan year ended May 1, 2023, is a short year of seven months or less. Accordingly, the Plan has included statements of net assets available for benefits as of May 1, 2023, December 31, 2022 and 2021, the related statements of changes in net assets available for the period January 1, 2023 through May 1, 2023 and the year ended December 31, 2022, as required by DOL regulations when such election is made.

**General:** The Plan is a defined contribution and salary deferral plan covering employees of Quincy Physicians & Surgeons Clinic S.C. d/b/a Quincy Medical Group (the Clinic). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions:** A participant may make voluntary 401(k) contributions to the Plan through salary reductions, up to a maximum dollar amount established each year by the Internal Revenue Service (\$22,500 for 2023 and \$20,500 for 2022). Participants who have attained age 50 before the end of the plan year are eligible to make additional catch-up contributions (\$7,500 for 2023 and \$6,500 for 2022). Participants also have the ability to make after-tax Roth contributions. Employees are immediately eligible to make salary deferrals under the Plan. For 2022, the Clinic matched 50% of the aggregate of the participant's elective deferrals, not to exceed the first 6% of the participant's compensation. Employees who have completed one year of service for which 1,000 hours of service have been incurred within the year are eligible for matching contributions. The Plan utilizes the 3% of compensation nonelective contribution safe harbor available to 401(k) plans. The 3% of compensation nonelective contribution will be made for each plan year for which a notice of contribution is issued. The contribution will be made to all participants that meet the requirements of the Plan. The Plan also allows for a discretionary profit sharing contribution. A participant must be employed on the last day of the plan year or must have completed more than 500 hours of service during the plan year to receive the discretionary profit sharing contribution. The discretionary profit sharing contribution totaled approximately \$1,960,000 for the year ended December 31, 2022, and is included in employer contributions receivable in the accompanying statement of net assets available for benefits as of December 31, 2022, and in employer contributions in the accompanying statement of changes in net assets available for benefits. For 2023, the employer may make a discretionary contribution only. There were no employer discretionary contributions for the period of January 1, 2023 through May 1, 2023. Contributions of distributions to participants from another qualified plan are permitted as defined in the Plan and are reported as rollover contributions.

**Participant accounts:** Each participant's account is credited with the participant's elective contributions and, if applicable, rollover contributions, and allocations of: (a) the Clinic's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Note 1. Description of the Plan (Continued)

**Vesting:** Each Plan participant shall immediately have a vested and non-forfeitable right to all contributions.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions to core investment options offered by the Plan. Previously, the Plan allowed for participant elected brokerage accounts not under the control of the trustee. All previously established accounts have been or will be transferred to the trustee. In addition, the Plan also allows participants to set up a participant-directed account with the trustee which consists of participant-directed brokerage accounts that the participant establishes to invest in an expanded range of investments permitted by the Plan's investment policy and in accordance with ERISA. Participants may change their investment options daily.

**Notes receivable from participants:** Participants may borrow from their accounts in accordance with the Plan's prescribed limits. Loan terms range from one to five years or up to a period permitted by commercial lenders for similar loans for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate equal to 0% above the prime rate. Interest rates on outstanding loans as of December 31, 2022, ranged from 3.25% to 7.00%, respectively. Principal and interest payments are paid ratably through payroll deductions.

**Benefit payments:** Participants, upon retirement or other termination, may elect to receive benefits in a lump sum or installments for required minimum distributions only. In-service distributions are permitted after age 59½. Prior to age 59½, an employee can withdraw employee contributions if the employee satisfies certain hardship requirements as defined in the Plan. The benefits paid are limited to the amount necessary to satisfy the immediate financial need of the participant and are only available after the participant has obtained all other benefits and loans available under the Plan. After a hardship withdrawal is processed, the participant is suspended from making salary reduction contributions for a period of six consecutive months beginning on the date the funds were distributed.

#### Note 2. Summary of Significant Accounting Policies

The following are significant accounting policies followed by the Plan:

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting. Adjustments to the cash basis trust reports include contributions withheld by the employee and employer, but not remitted into the Plan until after year-end.

**Investment valuation and income recognition:** The Plan reports investments at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is an estimate of the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian and trustees. The methods used to estimate the fair value of investments are described in Note 4.

Purchases and sales of securities are recorded on a settlement-date basis and are participant-directed. Interest income and dividends are recorded when received. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Administrative expenses:** Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses may be paid by the Clinic or the Plan, at the Clinic's discretion.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Payments of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Note 3. Information Certified by Trustees

The following is a summary of the Plan's asset information as of May 1, 2023, December 31, 2022 and December 31, 2021, included throughout the Plan's financial statements and ERISA required supplemental schedule, obtained by management and agreed to or derived from information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Formerly Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC) (collectively, the trustees) as of May 1, 2023, December 31, 2022 and December 31, 2021. The Plan Administrator has obtained certifications from the trustees that information provided to the Plan Administrator by the trustees related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and the supplemental schedule related to the following assets.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 1, 2023, December 31, 2022 and 2021.

**Shares of registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Participant-directed brokerage accounts:** Participant-directed brokerage accounts consist of the following types of assets:

- *Mutual funds, valued as noted above; common stocks, preferred stock and exchange traded funds:* Valued at the closing price reported on the active market on which the individual securities are traded.
- *Certificates of deposit:* Valued at cost, which approximates fair value due to the short-term nature of the instruments.
- *Bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

- *U.S. government securities:* Valued using pricing models maximizing the use of observable inputs for similar securities.
- *Annuities:* Valued at the estimated unit value based upon the fair value of the underlying investments using market quotations or prices obtained from independent pricing sources. These contracts are included in the fair value hierarchy table as Level 3 investments.

**Changes in fair value of Level 3 assets:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan's management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### Note 5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower) known as the guaranteed investment account. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by Empower. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, charges and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### **Note 5. Investment Contract With Insurance Company (Continued)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$6,398,424 and \$9,425,435 at December 31, 2022 and December 31, 2021, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0.00% under Empower contracts. Such interest rates are reviewed on a quarterly basis for resetting and applied on an annual basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan and (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment account contract can be terminated by providing written notice at least 60 days prior to the requested date of termination.

#### **Note 6. Income Tax Status**

The Plan has adopted a volume submitter profit sharing plan sponsored by Empower Retirement LLC. The volume submitter profit sharing plan has received an opinion letter from the Internal Revenue Service dated November 14, 2022, as to the volume submitter profit sharing plan's qualified status. The volume submitter profit sharing plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### **Note 7. Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate and market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8. Administrative Expenses**

Certain costs of the Plan's administration are paid by the Plan and certain other administrative costs are paid by the Clinic. Participants with self-directed brokerage accounts may have their participant account charged fees direct from custodians or investment providers.

#### Note 9. Related-Party and Party-in-Interest Transactions

The Plan invests in investment securities managed by the Plan trustees and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to parties-in-interest were approximately \$86,000, \$83,000 and \$426,000 for the periods ended May 1, 2023, December 31, 2022 and December 31, 2021.

Fees paid by the Clinic on behalf of the Plan amounted to approximately \$34,000 for the year ended December 31, 2022. The Clinic provides certain additional administrative services to the Plan at no cost.

#### Note 10. Reconciliation Between Financial Statements and Form 5500
