Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of Plan

The following description of The McDevitt Companies Employee 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of McDevitt Trucks, Inc. (the Company) who had three months of service and are age 18 or older. Effective September 15, 2022, there was no service requirement. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On January 13, 2023, the Trustee approved the merger of this Plan into the Advantage Truck Group, LLC 401(k) Plan (Advantage Plan) effective March 15, 2023. As a result, all assets were transferred from this Plan into the Advantage Plan on that date.

Contributions

Each year, participants could contribute up to the maximum amount of their eligible compensation that would not cause the Plan to violate the Actual Deferral Percentage test for the Plan year. The employee deferral could not exceed the maximum dollar amount for the Plan year under Internal Revenue Service (IRS) regulations. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants could also make Roth deferral contributions, which are subject to federal income taxes in the year of deferral. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan also included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Discretionary profit sharing contributions and discretionary matching contributions could have been contributed by the Company at the option of management of the Company. There were no Company contributions during the period from January 1, 2023 through March 15, 2023.

Participant deferrals were funded on a payroll basis, Company match contributions, if applicable, were funded at such times as determined by the Company and Company profit sharing contributions, if applicable, were funded annually. Contributions were subject to certain IRS limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's profit sharing contribution, and (b) plan earnings (losses). Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants were vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after six years of credited service, as defined by the Plan.

Notes Receivable From Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at rates ranging from 4.25% to 7.25%, which were commensurate with local prevailing rates as determined by the plan administrator at the time of the notes origination. Principal and interest were paid ratably through payroll deductions. Loans must be repaid within 5 years.

Payment of Benefits

On termination of service due to anything other than death, a participant could receive a lump sum distribution. If the vested balance is \$5,000 or less, the plan administrator would automatically distribute the balance as a lump sum distribution. If the balance was less than \$5,000 but more than \$1,000, the plan administrator would transfer the balance into an Individual Retirement Account on behalf of the participant, absent participant consent. If the balance was less than \$1,000, the plan administrator could automatically distribute the balance as a cash distribution, absent participant consent. If the vested account balance exceeded \$5,000, the participant could elect to leave the funds in the Plan until retirement or take a distribution at their discretion, subject to applicable withholding taxes. The Plan allowed for additional elections for distributions on account of death. In addition, hardship distributions were permitted if certain criteria were met. The Plan also allowed for in-service distributions upon attaining age 65.

Forfeitures

As of March 15, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$24,649, respectively. These accounts could be used for any permissible method under the terms of the Plan including to reduce Company contributions and pay reasonable Plan expenses. During the period from January 1, 2023 through March 15, 2023, \$26,293 of forfeitures were used to reduce discretionary matching contributions in receivables as of December 31, 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for fully benefit-responsive investments contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees are recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of March 15, 2023 and December 31, 2022. Delinquent participant notes receivable were recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 3: Fair Value Measurements (Continued)

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in methodologies used as of March 15, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2022. There were no investment assets as of March 15, 2023 due to Plan merger (see Note 1). Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan had a FBRIC with Standard Insurance Company (Standard), the Stable Asset Fund II, totaling \$0 and \$433,363 as of March 15, 2023 and December 31, 2022, respectively. The account was credited with earnings and charged for participant withdrawals and administrative expenses.

The contract met the FBRIC criteria and therefore was reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings (losses), less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Stable Asset Fund II is a general account product which provides a guarantee of principal and a guaranteed quarterly interest rate. The methodology for calculating the interest rate is based on the Standard Stable Asset Fund (the SAF) interest rate which is determined and declared quarterly. The interest is credited daily to deposits to the SAF at the daily equivalent of the SAF interest rate. The SAF interest rate will not be less than the Minimum Guaranteed Interest Rate of 1.00% per annum.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The guaranteed investment contract permits the insurance company to terminate the contract with at least 30 days advance written notice to the Companies.

Note 5: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at March 15, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the period from January 1, 2023 through March 15, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Hand Benefits & Trust Company, the Custodian of the Plan.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

The Plan used Benefit Plans Administrative Services LLC for record keeping and administrative services and Granite Financial Partners for investment advisory services. Benefit Plans Administrative Services LLC and Granite Financial Partners were service providers to the Plan and are, therefore, considered parties-in-interest, as defined by ERISA. Transactions with Benefit Plans Administrative Services LLC for record keeping and administrative services amounted to \$3,795 for the period from January 1, 2023 through March 15, 2023. Transactions with Granite Financial Partners for investment advisory services amounted to \$2,600 for the period from January 1, 2023 through March 15, 2023. Fees for investment management services for the period from January 1, 2023 through March 15, 2023, were offset against earnings.

Notes receivable from participants also qualify as party-in-interest transactions, which were exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would have become 100% vested in their Company contributions. As disclosed in Note 1, effective March 15, 2023, the Plan merged into Advantage Truck Group, LLC 401(k) Plan.

Note 8: Tax Status

The Company adopted a non-standardized pre-approved profit sharing plan with an IRS notification letter which states the prototype plan document was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan was amended since receiving the opinion letter; however, the plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Subsequent Events

The Plan has evaluated subsequent events through January 17, 2024, which is the date the financial statements were available to be issued.
