Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements in liquidation of the Frontier Auto Sales 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of May 18, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits in liquidation for the period ended May 18, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of May 18, 2023 and December 31, 2022, and for the period ended May 18, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, Frontier Auto Sales was sold during 2022 and the Plan was terminated on October 31, 2022, and management determined liquidation was imminent. As a result, the Plan used the liquidation basis in presenting the financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

1. Description of Plan

The following description of the Frontier Auto Sales 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering employees of Frontier Auto Sales (“Employer”) who had six months of service and were age twenty-one or older, excluding employees who were members of collective bargaining units or nonresident aliens. Management of the Employer controlled and managed the operation and administration of the Plan. Empower Annuity Insurance Company of America (“Empower”) (formerly Great-West Life & Annuity Insurance Company serves as the custodian of the Plan. Duncan Accounting and Tax Services (“Duncan”) serves as the third-party administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan termination

Frontier Auto Sales was sold during 2022 and the Plan was terminated on October 31, 2022, and management determined liquidation was imminent. As a result, the Plan used the liquidation basis in presenting the financial statements. All participants became fully vested in their accounts maintained under the Plan and all contributions to the Plan ceased. All participant balances were distributed as of May 18, 2023.

Contributions

Each year, participants could contribute pre-tax and/or Roth post-tax compensation, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. The Employer withheld an automatic deferral amount of 5% from eligible employees’ compensation each payroll period as a pre-tax elective deferral unless and until the participant made a contrary election. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans. Employer matching contributions were discretionary. Additional profit-sharing amounts could be contributed at the option of the Employer. Due to Plan termination, there were no contributions made during 2023.

Investment Options

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered various mutual funds and a guaranteed investment contract as investment options.

Participant Accounts

Each participant’s account was credited with the participant’s contributions, Employer’s contributions, and allocations of Plan earnings. The account was charged with benefit payments, transaction fees, and allocations of administrative expenses and Plan losses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts, if any, plus actual earnings thereon was based on years of service. A participant was 20% vested after one year of credited service and vested an additional 20% per year thereafter up to 100% vested after five years of credited service. All participants became fully vested in their accounts upon termination of the Plan.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 less the highest outstanding loan balance in the last twelve months. Loans were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by the plan administrator. At May 18, 2023, there were no outstanding loans due to Plan termination.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59 ½.

Forfeited Accounts

At December 31, 2022, forfeited non-vested accounts totaled \$3,541. In 2023, all available forfeitures were used to offset administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting, consistent with terminated plans, as of May 18, 2023 and December 31, 2022 and for the period ended May 18, 2023, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Investments in the fully benefit-responsive investment contract are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan

attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses were paid by either the Plan or the Employer, as provided by the Plan document. Certain administrative functions were performed by employees of the Employer. No such employees received compensation from the Plan. Expenses relating to participant transactions (notes receivable from participants and benefit payments) were charged directly to the participant's account.

Subsequent Event

The Plan has evaluated subsequent events through January 8, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at May 18, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. There were no Plan assets as of May 18, 2023.

5. Investment Contract with Insurance Company

The Plan held an investment contract with Empower. This contract met the fully benefit-responsive investment contract criteria and therefore is reported at contract value of \$449,702 as of December 31, 2022. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Empower was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment

contracts was dependent on Empower's ability to meet its financial obligations. Their ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of Empower or otherwise. When establishing interest credit rates, Empower considered many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the general account. There was no minimum interest rate. Interest rates were established on the first day of each quarter and applied to all ongoing contributions made to the guaranteed account in that quarter for all group annuity contract holders. The investment contract was liquidated in 2023, related to the termination of the Plan with no significant impact to contract value.

6. Exempt Party-In-Interest Transactions

Certain Plan investments were managed by Empower. Fees paid by the Plan to Empower for administrative services were \$12,072 for the period ended May 18, 2023. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

7. Tax Status

The Plan did not obtain a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan was relying on the IRS approval of the standardized prototype plan that it was utilizing. The IRS has determined and informed Duncan by a letter dated May 27, 2021, that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan has since been amended. However, the plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 18, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
