INDEPENDENT AUDITORS' REPORT

To the Plan Trustee of
ACP Sales West 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of ACP Sales West 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of ACP Sales West 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ACP Sales West 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ACP Sales West 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. We did not audit or review the 2021 financial statement nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the 2021 financial statement.

Note 1 – Description of Plan and Contributions

The following description of the ACP Sales West 401(k) Plan (the "Plan") is provided for general information purposes only. ACP Sales West LLC (the "Company") is the Plan Sponsor. The Plan became effective December 26, 2005 and was designed to encourage employees to save for retirement and stay with the Company until their retirement. Participants should refer to the most recent Plan Documents for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established for the benefit of all employees of the Company. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code ("IRC") and similar state tax laws. Principal Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as of December 31, 2022, amended ("ERISA").

Eligibility: Employees may participate in the Plan after they have reached age 21 and have served the company for at least 30 days. Employees are eligible for employer matching after they have reached age 21 and have worked for the company for 30 days. Participants are enrolled the quarter after they become eligible.

Participant Contributions: Participants may voluntarily contribute to the Plan up to 100% of eligible earnings, subject to limitations of the Internal Revenue Code, as defined by the Plan agreement.

Employer Contributions: Employer may make matching contributions. In 2022, matching contributions were 20% of an eligible employee's deferrals up to the first 5% (maximum of 1% matching). The Company may contribute a discretionary matching contribution to be determined by the employer, of the participant's ratio of pay to total participant pay. Participants become eligible for matching contribution after 30 days of service and being 21 years of age.

Investment Direction: Each participant directs the investment of all assets attributable to their respective account, except employer contributions.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company discretionary and matching contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant becomes eligible for discretionary and matching employer contribution after 30 days of service which are 33% vested if the participant is employed for less than one year, then 66% after one year, then 100% vested after two years of credited service. Notwithstanding the above, a participant is fully vested upon death, or permanent disability.

Forfeitures: Participants' accounts are forfeited if the employer contribution portion has not fully vested at the date of termination. These amounts will be utilized to pay administrative expenses of the Plan or to reduce employer contributions. The forfeiture balance was \$0 at December 31, 2022.

Note 1 – Description of Plan and Contributions (Continued)

Notes Receivable from Participants: The Plan allows loans to participants up to 50% of their vested account balance, up to a maximum of \$50,000. The minimum loan amount is \$1,000. A participant may only have one loan outstanding at any time. Loan repayments are made through payroll deductions and must generally be repaid within five years. Loans to acquire a principal residence may be repaid in excess of five years. Loans are collateralized by the vested balance in the participant's account and bear interest at a rate similar to that of other loans from similar commercial lending institutions.

Note 2 – Summary of Significant Accounting Policies

A summary of the ACP Sales West 401(k) Plan ("the Plan") significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition: The Plan carries its investments at Net Asset Value "NAV", except for investment contracts, which are reported at contract value.

Investment Contracts: The Plan invests in Insurance Company General Guaranteed Interest, which is a guaranteed general-account backed group annuity contract issued by Principal Life Insurance Company. The investment in general account is presented at contract value. The contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Employer initiated events, if material, may affect the underlying economics of investment contracts. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer initiated events could limit the Trust's ability to transact at contract value with plan unitholders. The plan administrator does not believe that any of the events which could limit the Plan's ability to transact at contract value with participants are probable of occurring.

See independent auditors' report.

Note 3 – Income Tax Status

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination would receive distributions of their account balances. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

Note 5 – Information Certified by the Trustee

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

Information related to investments disclosed in the accompanying financial statements and supplementary schedule at December 31, 2022 and net investment income, including dividends, other interest and net depreciation in fair value of investments for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Life Insurance Company.

Note 6 – Fair Value Measurements

FASB Accounting Standards Codification Topic No. 820, *Fair Value Measurements and Disclosures* ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts ("PSA") – Valued at the NAV of units of a pooled separate account maintained by an insurance company held by the Plan at year-end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The primary investment objective of the PSA is to allow participants to achieve the same rate of return as the underlying mutual funds, less fees charged by the insurance company. The PSAs do not have any unfunded commitments relating to its investments, or any significant restrictions on redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

Note 7 – Exempt Party-In-Interest and Related Party Transactions

Certain plan investments are managed by Principal Trust Company, which is also the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the balance in the participant's account. Such transactions are also considered related party transactions. New loans totaling \$2,500 were issued to participants during the year ended December 31, 2022.

Note 8 – Notes Receivable from Participants

Notes receivable from participants bear interest at a range of 5.25% - 9.00% and are receivable in monthly installments over a period of one to five years. Loan balances range from \$1,500 to \$16,928, and the total participant loan balance is \$18,444 at December 31, 2022.

Note 9 – Risk and Uncertainties

The Plan provides for various investment options in which participants can invest. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.
