### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Cooper Tire & Rubber Company Spectrum Investment Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 1, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through June 1, 2023, and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Cooper Tire & Rubber Company Spectrum Investment Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## 1. Description of Plan

The following description of Cooper Tire & Rubber Company Spectrum Investment Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements and summary plan description for a more complete description of the Plan’s provisions.

### General

Effective June 1, 2023, account balances of \$367 million and \$2 million were transferred from the Plan to The Goodyear Tire & Rubber Company Employee Savings Plan for Salaried Employees and The Goodyear Tire & Rubber Company Savings Plan for Retail Employees, respectively, effectively merging the Plan into these plans. These transfers are included in the Statement of Changes in Net Assets Available for Benefits as Net transfers to other plans.

The Plan, as restated and amended on January 1, 2018, was a defined contribution plan covering all salaried employees of the Cooper Tire & Rubber Company LLC (the “Company” or the “Plan Sponsor”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective June 7, 2021, the Plan Sponsor was acquired by The Goodyear Tire & Rubber Company (“Goodyear Acquisition”). Cooper Tire & Rubber Company LLC remained the Plan Sponsor through the plan merger date.

Effective January 1, 2018, the Plan automatically enrolled newly eligible participants into the Plan using the 6% deferral rate. All eligible employees who were active participants as of that date and who were deferring at a percentage below 6% were increased to a 6% deferral rate. If as of January 1, 2018 an active participant was deferring at a percentage that was at least 6% and no higher than 10%, this deferral rate was automatically increased as soon as administratively feasible on or after each first day of the Plan year by 1% up to a maximum automatic elective deferral of 10%. Participants were automatically enrolled into the default Principal Lifetime fund that related most closely to the participant’s expected year of retirement. Participants could elect to opt out of automatic enrollment.

The Plan had established a trust agreement with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the “Trustee”) to act as trustee and recordkeeper of the Plan’s assets. The Trustee administered and invested the Plan’s assets and income for the benefit of the Plan’s participants. The Administrative Committee was responsible for the overall administration of the Plan.

**Plan Amendments**

The Plan had implemented certain requirements from the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the “SECURE Act”), which laws required the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

**Contributions**

Each year, participants could contribute up to 99% of their pretax or after-tax compensation into the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants could direct their contributions to any of the Plan’s investment fund options.

Effective January 1, 2023, Company employees became employees of The Goodyear Tire & Rubber Company (“Goodyear”), at which time their ongoing contributions were made to defined contribution plans sponsored by Goodyear.

Prior to January 1, 2023, the Company made matching contributions equal to 100% of the participant’s elective deferral contributions up to 6% of compensation. All contributions were subject to certain limitations of the Internal Revenue Code (the “Code”).

Additionally, the Company could contribute annually at its discretion as defined in the plan document. Participants could direct employer contributions immediately upon receipt. All contributions made by the Company were invested in the same manner as that of the participant’s elective contributions.

## **1. Description of Plan (continued)**

Effective March 3, 2014, the Plan no longer offered Cooper Tire & Rubber Company stock as an investment option. Existing investments in Company stock could remain in that option, but no further investments were allowed, including the transfer of funds from other investment options into Company stock as of March 3, 2014. As a result of the Goodyear Acquisition, all shares of Cooper Tire & Rubber Company stock in the Plan were exchanged for shares of Goodyear at the exchange ratio specified in the Agreement and Plan of Merger dated as of February 22, 2021.

### **Vesting**

The participants were immediately vested in their contributions plus actual earnings thereon. Participants were 100% vested in the Company's contributions plus actual earnings thereon after two years of service. Effective with the June 1, 2023 merger, Company contributions plus actual earnings thereon at the merger date became 100% vested.

### **Participant Accounts**

Individual accounts were maintained for each participant in the Plan. Each participant's account was credited with the participant's contributions, their allocation of the Company's contributions, and plan earnings. The benefit to which a participant was entitled to was the benefit that could be provided from the participant's vested account.

### **Forfeitures**

Upon termination of employment, participants forfeited their nonvested balances. Forfeiture balances were used to pay plan administrative expenses or reduce future employer contributions. At June 1, 2023, forfeited nonvested account balances totaling \$999,350 were included in transfers to The Goodyear Tire & Rubber Company Employee Savings Plan for Salaried Employees at June 1, 2023. At December 31, 2022, forfeited nonvested accounts held in the Plan totaled \$879.

### **Notes Receivable from Participants**

Under the Plan, participants could have borrowed 50% of the vested value of their account balance up to a maximum of \$50,000. The notes receivable repayment schedule was no longer than 60 months. A participant could not have more than one note receivable outstanding at any point in time and no new loan could be taken until at least 12 months have elapsed since any prior loan was paid off. Principal and interest were paid ratably through payroll deductions. The interest rate was established based on the prime rate. Interest rates as of December 31, 2022 ranged from 3.25% to 7.50%. If a participant terminated employment with the Company, the note receivable automatically was treated as a taxable distribution to the participant.

Pursuant to the CARES Act, Plan participants could request a delay of note repayments for repayments that occurred between March 27, 2020 and December 31, 2020 for one year. The participant's note was re-amortized and included any interest accrued during the period of delay.

**Participant Withdrawals**

In the event of retirement, death, termination, permanent disability, or other separation from service, participants were entitled to receive an amount equal to the value of the vested interest in their accounts. Payments of benefits were taken in a lump-sum distribution. Under the Plan agreements, the participants who were entitled to a benefit for the reasons outlined above had their vested balance automatically distributed if their vested balance was less than \$1,000 and rolled over to an IRA account administered by the Trustee if their vested balance was greater than \$1,000, but less than \$5,000.

In the event of hardship, as defined by the Plan agreements, participants could make a partial or full distribution of their accounts, subject to certain tax withholdings. Hardship withdrawals were strictly regulated by the Internal Revenue Service (IRS) and a participant must have exhausted all available notes receivable options and available distributions prior to requesting a hardship withdrawal.

**Company Stock Account**

The Plan allowed for investing in common stock of the Company through its Company Stock Account for participant and employer contributions prior to March 3, 2014. A dividend pass-through election had been implemented for the participants who elected this investment type. During 2018, the Plan was amended to prohibit stock dividends and required that cash dividends from the Company Stock Account paid before January 1, 2019 be either added to the balance of the participant account and reinvested in Company Stock or paid to the participant, beneficiary or alternate payee if so elected. Cash dividends paid on or after January 1, 2019 would be invested at the participants direction, excluding investment into the Company Stock Account.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that were recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded when it was earned. No allowance for credit losses had been recorded as of December 31, 2022 or June 1, 2023. If a participant ceased to make note receivable repayments and the Plan Administrator deemed the note receivable from the participant to be a distribution, the note receivable from participant balance was reduced and a benefit payment was recorded.

### **Payment of Benefits**

Benefits were recorded when paid.

### **Administrative Expenses**

Administrative expenses of the Plan were paid for by current year forfeitures first. Any remaining expenses not covered by these forfeitures were paid for by the Plan.

### **Investment Valuation and Income Recognition**

Investments held by the Plan were stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurement.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States required management to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from those estimates.

### **Subsequent Events**

The Plan had evaluated subsequent events through the date of issuance of the financial statements. There were no subsequent events which required recognition or disclosure in the financial statements.

### **3. Investments**

Certain investment information disclosed in the accompanying financial statements, including investments held and notes receivable from participants at June 1, 2023 and December 31, 2022, and net realized and unrealized depreciation in fair value of investments, and dividends for the period from January 1, 2023 through June 1, 2023, were obtained or derived from information supplied to the Plan Sponsor and certified by the Trustee as complete and accurate in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information has not been examined by independent auditors.

### **4. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Financial assets and liabilities whose fair values are based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.

Level 2 – Financial assets and liabilities whose fair values are based on quoted prices in markets that are not active or model inputs that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in non-active markets;
- c. Pricing models whose inputs are observable for substantially the full term of the asset or liability; and
- d. Pricing models whose inputs are derived principally from or corroborated by observable market data through correlation or other means for substantially the full term of the asset or liability.

Level 3 – Financial assets and liabilities whose fair values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs reflect management’s own judgment about the assumptions that a market participant would use in pricing the asset or liability and are based on the best available information, some of which may be internally developed.

The Plan's investment of \$6,109,637 in the Principal U.S. Property Pooled Separate Account at June 1, 2023 was measured at net asset value.

*Pooled Separate Accounts and Common/Collective Trust Fund* – The fair value of the investments in these categories was estimated using the net asset value (NAV) per unit provided by the administrator of the fund as a practical expedient. The NAV is not a publicly quoted price in an active market. There were no redemption restrictions on these investments for participants.

*Common Stock* – Valued at the closing price reported on the active market on which the individual security is traded.

*Mutual Funds* – valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers of Plan investments between Levels 1 and 2 during the period from January 1, 2023 through June 1, 2023.

The fair value of the pooled separate accounts and common/collective trust fund, that were measured at NAV (or its equivalents), is \$6,019,637 and \$428,804,853 at June 1, 2023 and December 31, 2022, respectively. The Principal U.S. Property Pooled Separate Account has a withdrawal limitation effective after market close on July 1, 2022, which will be lifted when the account has sufficient liquidity, but no longer than three years from the effective date. The remaining pooled separate accounts and common/collective trust fund have no unfunded commitments, have a daily redemption frequency and require a one day redemption period.

**5. Income Tax Status**

The Plan received a determination letter from the IRS dated March 31, 2017, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Subsequent to this determination by the IRS, the Plan was restated and amended. The Plan Administrator believes the Plan, as restated and amended, was operated in material compliance with the applicable requirements of the Code and, therefore, believes the Plan was qualified and the related trust was tax exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Related-Party Transactions**

The Plan held units of pooled separate accounts and a common/collective trust fund managed by the Trustee of the Plan. The Plan also invested in the common stock of The Goodyear Tire & Rubber Company, the 100% owner of the Plan Sponsor. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances in the respective plans into which the account balances were merged.
