## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Pulmonary and Critical Care Associates of Baltimore, P.A. Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Pulmonary and Critical Care Associates of Baltimore, P.A. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets in liquidation available for benefits as of June 7, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation available for benefits for the period from January 1, 2023 to June 7, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pulmonary and Critical Care Associates of Baltimore, P.A. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 7, 2023 and December 31, 2022, and for the period from January 1, 2023 to June 7, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1: DESCRIPTION OF PLAN**

The following description of Pulmonary and Critical Care Associates of Baltimore, P.A. Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan, established January 1, 2003, restated January 1, 2022, covering all employees of Pulmonary and Critical Care Associates of Baltimore, P.A. (the Employer) who have completed one year of service and are at least twenty-one years of age. The Plan excludes any leased employee, any union employee whose retirement benefits were negotiated via a collective bargaining agreement which did not include a provision for eligibility into this Plan, and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of the Employer's contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their voluntary contributions and safe harbor match contribution, plus actual earnings thereon. Vesting in the Employer's discretionary contribution accounts is based on years of service. A participant is 100% vested after six years of credited service; however, a participant shall become fully vested upon retirement, death, or disability (as defined by the Plan). Effective July 1, 2022, Pulmonary and Critical Care of Baltimore, P.A. was sold. On December 15, 2022, the governing body of the Employer approved a plan of liquidation effective December 31, 2022. As a result of the plan termination, all accumulated benefits of all participants became fully vested.

**Investment Options**

The Plan invests participant directed contributions in a number of mutual funds and a pooled separate account. Each participant's elective contribution will be invested into those funds selected by the participant. The Employer's contribution will be invested into the same funds as the elective contributions.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear interest. Principal and interest is paid ratably through payroll deductions.

**Forfeitures**

Non-vested amounts will be forfeited by participants upon termination, and may be used in accordance with Plan provisions. The amount of unallocated forfeitures at December 31, 2022 was \$4,492. For the period from January 1, 2023 to June 7, 2023, the forfeitures were allocated to participants.

**Payment of Benefits**

Upon termination of service, death, or long-term disability, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Vested account balances that do not exceed \$5,000 are paid out in a lump sum amount. Vested account balances that exceed \$5,000 are paid out either in a lump sum amount or in installments over time. In-service withdrawals are also permitted upon meeting certain requirements as defined by the Plan.

**Expenses**

Certain Plan expenses are assumed by the Employer, and are not reflected in the accompanying financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Tax Status**

The Plan has been recognized by the Internal Revenue Service (IRS) as a qualified non-standardized pre-approved profit sharing plan under the Internal Revenue Code (IRC) Section 401(a) and 401(k) and is exempt from federal income taxes under the provisions of IRC Section 501(a). A determination letter has been obtained for the qualified non-standardized pre-approved profit sharing plan; however, no application has been made for a determination letter for this specific plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Subsequent Events**

The Plan has evaluated subsequent events through January 19, 2024, which is the date the financial statements were available to be issued.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants (loans) are reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2022, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Payment of Benefits**

Benefits are recorded when paid.

The Plan's independent auditors did not perform procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets in liquidation available for benefits as of December 31, 2022.

The fair value measurement accounting literature provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described as follows:

- Level 1 Fair value is based on observable inputs such as quoted prices for identical assets or liabilities in active markets.
- Level 2 Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Fair value is based on unobservable inputs that reflect management's own assumptions.

In accordance with Accounting Standards Update No. 2015-07 certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets in liquidation available for benefit as of December 31, 2023.

*Mutual Funds*

The fair value of mutual funds is based on quoted net asset values of shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Pooled Separate Account*

The units of the pooled separate account are stated at fair value, as determined by the issuer of the pooled separate account based on the fair value of the underlying investments. All investments in this category can be redeemed daily, have a daily redemption notice period and have no unfunded commitments.

The pooled separate account (and its investment strategy) are as follows:

**New York Life Insurance Anchor IV** – seeks to provide a low risk, stable investment offering competitive yields while maintaining a stable value.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the period from January 1, 2023 to June 7, 2023 are reported in net appreciation in fair value of investments.

**NOTE 5: PLAN TERMINATION**

The Employer was sold in July 2022. The governing body of Pulmonary and Critical Care Associates of Baltimore, P.A. Profit Sharing Plan approved a plan of liquidation in December 2022, and management determined liquidation is imminent. As a result, the Plan has used liquidation basis in presenting the June 7, 2023 and December 31, 2022 financial statements. Upon Plan termination, participants become 100% vested in their account balances.
