## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator,  
Cross City Lumber 401(k) Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of the Cross City Lumber 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule, as listed in the table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We performed a compilation engagement with respect to the 2021 financial statements and our report thereon, dated January 10, 2024, stated that we did not audit or review those financial statements and, accordingly, express no opinion or other form of assurance on them.

(1) **Description of Plan:**

The following description of the Cross City Lumber 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) **General**—The Plan is a defined contribution 401(k) plan that covers substantially all employees of the Cross City Lumber, LLC (the Company) who have attained the age of 18 years and completed 400 hours of service in three months of service on the Plan entrance date, as defined in the Plan agreement. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may contribute matching contributions and discretionary profit sharing contributions to the Plan. The Company fully matches the first 3% of the employee's contribution, and then matches half of the employee's contributions on the next 2% of their salary, with a total maximum match of up to 5% of the employee's salary contributed to the Plan. The Company did not make any discretionary profit sharing contributions to the Plan for the year ended December 31, 2022. Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Contributions are subject to certain limitations.

(c) **Participant accounts**—Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) plan earnings, and (c) is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The Company currently offers 20 mutual funds as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) **Vesting**—Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in the Company's Safe Harbor matching contributions plus earnings thereon. Vesting in the Company's profit sharing contributions, plus earnings thereon, is based on years of service. A participant is 100% vested after six years of credited service.

(e) **Payment of benefits**—Upon termination of service due to death, disability, or retirement, the participant or beneficiary will receive the vested value of his or her account in a lump-sum payment. The method of payout is determined by the participant. An active participant's contributions may be withdrawn after attainment of normal retirement age, as defined by the Plan. In-service withdrawals are allowed upon attainment of age 59 ½. Absent the participant's election to roll distributions into another qualified plan or receive a lump-sum payment, vested balances less than \$1,000 for terminated participants are distributed in a lump-sum payment.

(f) **Administrative costs and plan expenses**—The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Company. Plan administration and investment management fees reduce the participants' account balances. Expenses relating to specific participant transactions (i.e. distribution request, etc.) are charged directly against the appropriate participant's account.

(g) **Forfeited accounts**—At December 31, 2022 and 2021, there were no forfeited non-vested accounts. These accounts will be used to reduce future employer contributions. Any remaining forfeitures may be used to pay administrative expenses of the Plan.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of accounting**—The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

(b) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(c) **Investment valuation and income recognition**—The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Dividend income is recorded when paid. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) **Payment of benefits**—Benefits are recorded when paid.

(e) **Subsequent events**—The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through January 10, 2024, the date the financial statements were available to be issued. No subsequent events requiring recognition or disclosure have been identified.

**(3) Information Certified by the Trustee:**

All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2022 and 2021, and the net depreciation in fair value of investments and dividend income for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company, a qualified institution and trustee of the Plan.

**(4) Investments and Fair Value Measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2022 and 2021, there were no purchases, issues, or transfers in or out of Level 3.

(5) **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(6) **Tax Status:**

The Plan adopted a pre-approved plan that obtained a favorable determination letter from the Internal Revenue Service dated June 30, 2020. A favorable determination letter qualifies the Plan under Section 401(a) of the Internal Revenue Code (IRC), and the Plan is therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain this qualification. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions for the last three years; however, there are currently no audits for any tax periods in progress.

(7) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) **Parties-in-Interest:**

Capital Bank and Trust Company is the trustee of Plan assets (see Note 3), and derived fees based on the asset values, which are included in the investment management fee expense or are netted against the net appreciation/depreciation in fair value of investments. During 2022, Wright Retirement Services, LLC provided recordkeeping and third-party administrative services to the Plan, and they received fees from the Company on behalf of the Plan for these services.
