Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Red Lion Hotels Corporation Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of as of August 19, 2022, and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to August 19, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Opinion

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the period ended August 19, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Plan Description

The following description of the Red Lion Hotels Corporation Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan, which was effective March 1, 1989, is a defined contribution plan that was established by Red Lion Hotels Corporation (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto. The Plan was created for the benefit of substantially all employees of the Company.

Effective January 1, 2022, Red Lion Hotels Corporation Retirement Savings Plan merged into the Sonesta International Hotels Corporation and Subsidiaries 401(k) Plan (the Sonesta Plan), and the Company became an adopting employer of the Sonesta Plan. Plan assets were transferred to the Sonesta Plan during January 2022. Plan participants became subject to the terms and conditions of the Sonesta Plan at the effective date of the merger.

Administration of the Plan

The Company administers the Plan in the form of an Administrative Committee consisting of Company officers or other designated employees. Plan assets are held and invested by Charles Schwab Bank (Schwab), as Trustee, in accordance with a custodial agreement the Administrative Committee. Records of participant account activity are processed and maintained by Randall & Hurley, (Randall Hurley), which performs recordkeeping services for the Plan. The Company's human resource and payroll departments manage the day-to-day operations of the Plan.

Eligibility

Employees who have reached the age of 18 and are employed by Red Lion Hotels Corporation or an affiliate who has adopted the Plan are considered eligible employees. However, employees are not eligible if they are a member of any of the following Ineligible classes of employees for purposes of Elective Deferral Contributions, Matching Contributions and Profit-Sharing Contributions:

- (1) Any employee who is included in a unit of employees covered by a collective bargaining agreement if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in the Plan;
- (2) Any employee who is a non-resident alien who received no earned income from the Company which constitutes income from services performed within the United States; and
- (3) Any leased, temporary or on-call employees.

Contributions

Participating employees can make contributions of up to 100% of their compensation, as defined by the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants may also elect to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. A participant who receives a qualified distribution from another qualified plan may make a rollover contribution to the Plan provided that certain conditions are met, including the approval of the Plan administrator. Participants considered highly compensated are limited to an elective deferral contribution that may not exceed 6% of their compensation, as defined by the Plan. Eligible employees are automatically enrolled in the plan with a pre-tax deferral of 3% of their gross compensation, unless they affirmatively elect not to participate in the Plan.

The Company may make discretionary matching contributions based on a matching formula and eligibility requirements set forth in the Plan document. In addition, the Company may make a discretionary profit-sharing contribution to the Plan on a participant's behalf. A participant will be eligible to receive an allocation of the profit-sharing contribution if they have completed at least 1,000 hours of service during the Plan year and are employed by the Company on the last day of the Plan year. For the period ended August 19, 2022, the Company did not make discretionary contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions and actual earnings thereon are 100% vested. Employer matching and profit-sharing contributions vest at the rate of 33% at the completion of one year of service, followed by an additional 33% for each subsequent year, resulting in 100% vesting after three years.

Forfeitures

Forfeitures resulting from non-vested contributions from terminated employees are typically used to reduce future employer matching contributions or to offset administrative expenses of the Plan. Plan forfeitures as of August 19, 2022, and 2021 were \$0 and \$13,640 respectively. During the period from January 1, 2022 to August 19, 2022, there were no plan forfeitures used to pay administrative expenses or reduce employer matching contributions. Forfeitures in the amount of \$14,715 were transferred to the Sonesta Plan.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have two loan outstanding at any given time. Loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. Periodic principal and interest payments are required to be made via payroll deductions, payable over a period of 5 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

2. Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at quoted market prices in an active market, which represent the NAV of shares held by the Plan at year end, are considered Level 1 investments.

Common collective trust - The fair value of the common/collective trust fund is based on NAV per share, as determined by the trustee at year-end. The NAV is used as the practical expedient to estimate fair value. The NAV is calculated based on the fair value of the underlying investments less liabilities of the fund. There were no unfunded commitments or redemption restrictions as of August 19, 2022 and December 31, 2021. The fund is also a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements the reporting date.

The following table presents the Plan investments that are measured at fair value, on a recurring basis. All Plan investments measured at fair value category Level 1, except for those Plan investments that use NAV as a practical expedient. There have been no changes in the methodologies used at August 19, 2022 and December 31, 2021.

4. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Charles Schwab Bank has certified that the following data included in the accompanying financial statements is complete and accurate.

- Cash and investments, at fair value as shown in the statements of net assets available for benefits as of August 19, 2022 and December 31, 2021.
- Investment loss as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 to August 19, 2022.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Related Party Transactions and Party-in-Interest Transactions

Randall & Hurley is the Plan record-keeper and therefore fees paid qualify as party-in-interest transactions. Plan assets are held and invested by Schwab, the Plan Trustee, and, therefore, these transactions qualify as party-in-interest transactions. Participant distribution processing fees are paid to Randall & Hurley by participants. During the period ended August 19, 2022 the Plan recorded expenses of \$3,489. Administrative expenses of \$3,158 were paid to Randall & Hurley in 2022. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted

under the provisions of the Plan and are specifically exempt from the prohibition of party-in- interest transactions under ERISA.

6. Income Tax Status

The Plan has adopted a Volume Submitter Profit-Sharing Plan, which received a favorable opinion letter from the IRS dated March 31, 2014 stating that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended; however, the Company and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been recorded.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

These transactions constitute prohibited transactions as defined by ERISA. The contributions were remitted in 2021 and 2020, however, the lost earnings were not remitted to the Plan. The lost earnings will be remitted to the Sonesta Plan and allocated to the respective participants.

The Plan has evaluated subsequent events through January 18, 2024, which is the date the financial statements were available to be issued.
