As a result of the Plan Sponsor's bankruptcy, and given my limited role as Bankruptcy Trustee, I cannot confirm the accuracy of all the information contained in the Final 2023 Form 5500 (notwithstanding the fact that I have signed the form).

## Reasonable Cause – Accountant’s Opinion

Due to the Chapter 7 bankruptcy filed by the plan sponsor, information/documentation that would have been provided by the plan sponsor to the auditor was unavailable, so the opinion of an independent qualified public accountant was unable to be obtained for this filing. Additionally, the cost of meeting the requirement to obtain the opinion of an independent qualified public accountant would have been borne by the plan’s participants and would have served only to reduce the amounts available for distribution to those participants.

For the reasons listed above, exemption is requested from the requirement to obtain the opinion of an independent qualified public accountant for this filing.
