Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the MOTION PT Group, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 7, 2023 (in liquidation) and December 31, 2022 (ongoing), and the related statements of changes in net assets available for benefits for the period from January 1, 2023 through July 7, 2023 (in liquidation) and for the year ended December 31, 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended July 7, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). As discussed in Note 1(a) to the financial statements, the Plan Sponsor approved termination of the plan on January 30, 2023. As a result, the Plan changed its basis of accounting from the accrual basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

(1) Description of plan

The following description of the MOTION PT Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on January 1, 1999, and was restated on January 1, 2015, that provided retirement benefits for employees of Cypress Creek Therapy Associates, MOTION PT Group Florida, LLC and Metro Athletic Medicine and Fitness, P.C. ("the Employers"). Effective June 24, 2015, the Plan name was changed from the Metro Athletic Medicine and Fitness, P.C. 401(k) Plan to the MOTION PT Group, Inc. 401(k) Plan. MOTION PT Group, Inc. ("MOTION") became the Plan Sponsor, and Metro became a participating employer in the Plan on June 24, 2015 as well. The Plan covered substantially all employees who were age twenty-one or older and had completed 90 days of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan Sponsor approved termination of the Plan effective January 30, 2023. All account balances were distributed or transferred out of the Plan as of the liquidation date of July 7, 2023. As a result, the Plan changed its basis of accounting from the accrual basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements.

(b) Contributions

Eligible participants were automatically enrolled in the Plan, unless elected otherwise, to make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or could be made after tax in the form of a Roth 401(k) contribution. Participants were automatically enrolled to defer 3% of eligible compensation unless the participant elected a different deferral percentage or opted out of the Plan. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation subject to certain IRC limitations. Effective December 16, 2022, an amendment was adopted to suspend all contributions to the Plan.

The Plan allowed for discretionary contributions as determined annually by the Plan Sponsor. A participant must have been employed on the last day of the Plan year to be eligible for discretionary contributions. The Plan Sponsor did not make discretionary contributions in 2023 or 2022. Plan Sponsor contributions could not exceed the maximum amount deductible for federal income tax purposes.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's contributions, and allocations of Plan Sponsor contributions, investment earnings (losses) and administrative expenses. Allocations were based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their contributions, plus actual earnings (losses) thereon. Vesting in the Plan Sponsor contributions was based on years of continuous service, where participants were 100% vested after three years of service. Effective January 30, 2023, all participants became 100% vested in Plan Sponsor contributions as a result of the Plan termination.

(e) Notes receivable from participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the vested balance in the participant's account and bore interest at a fixed rate (prime rate plus 2%), unless otherwise determined by the plan administrator. Notes receivable terms were for a maximum of 5 years, or longer if used for the purchase of a primary residence. Principal and interest were paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability or retirement, a participant could have elected to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

In the event of a termination of a participant with a vested balance greater than \$1,000 but not exceeding \$5,000, and absent an election by the participant, the Plan paid the distribution as a direct rollover to an individual retirement account designated by the Plan Sponsor. If the participant's vested account balance was less than \$1,000, the account was distributed to the participant as a lump sum distribution.

(g) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures were first used to pay any administrative expenses and then to reduce the Plan Sponsor's contributions to the Plan. There were no forfeited nonvested accounts as of the period ended July 7, 2023 and as of the year ended December 31, 2022.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the Plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to recordkeeping, the administration of notes receivable from participants and transaction expenses were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value or contract value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

As described in Note 1(a), the Plan was terminated effective January 30, 2023. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the plan has changed from accrual basis for year ended December 31, 2022 to the liquidation basis for the period ended July 7, 2023.

(b) Investment valuation and income recognition

The Plan's investments were stated at fair value or contract value as reported by John Hancock Life Insurance Company of New York ("John Hancock"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment values are discussed more fully in Note 4.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes were reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with GAAP required management to make estimates and assumptions that affected the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between July 7, 2023 and December 18, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair value and contract value of investments and notes receivable from participants held at July 7, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value or contract value of investments and interest income (including interest income on notes receivable from participants) for the period ended July 7, 2023, and for the year ended December 31, 2022 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock.

(4) Investment valuation

The Plan held an investment in a fully benefit responsive investment contract in the form of a guaranteed investment contract with John Hancock. The guaranteed investment contract was reported at contract value, and therefore, was not classified in the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification 820, *Fair Value Measurements*. Contract value is based on the amount the Plan Sponsor would receive if they terminated the contract at the reporting date, which is book value less an early withdrawal charge, discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The Plan's investments consisted of pooled separate accounts which were measured at net asset value ("NAV") as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy. The NAV is based on the market value of the underlying investments held by the pooled separate accounts at year end. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the pooled separate accounts, the issuer reserves the right to temporarily delay withdrawal from the pool in order to ensure that securities liquidations will be carried out in an orderly business manner.

The pooled separate accounts available to the Plan include the following significant types of investment strategies:

- Pooled separate accounts that seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named.
- Lifestyle funds including conservative, moderate, balanced, growth and aggressive strategies which seek returns consistent with these investment styles.
- Target date funds that seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date.

(5) Income tax status

The Plan Sponsor adopted a volume submitter plan, which received a favorable opinion letter from the IRS on March 31, 2014, which stated that the volume submitter Plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted volume submitter Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 7, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

Plan investments were pooled separate accounts and a guaranteed investment contract which was managed by affiliates of John Hancock, and therefore these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and held notes receivable from participants which also qualified as party-in-interest transactions.
