SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of Concannon Miller & Co., PC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 28, 2023 and September 30, 2022 (in liquidation), and the related statements of changes in net assets available for benefits for the periods then ended (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Concannon Miller & Co., PC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the periods ended September 28, 2023 and September 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

EMPHASIS OF MATTER – BASIS OF ACCOUNTING ON THE FINANCIAL STATEMENTS

As discussed in Note 7 to the financial statements, the governing body of the Plan approved a merger with CliftonLarsonAllen LLP, and management determined liquidation was imminent. As a result, the Plan has adopted the liquidation basis of accounting in presenting the September 28, 2023 and September 30, 2022 financial statements. Our opinion is not modified with respect to that matter.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE FINANCIAL STATEMENTS

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

SEPTEMBER 28, 2023 AND SEPTEMBER 30, 2022**

NOTE 1 DESCRIPTION OF PLAN

The following description of the Concannon Miller & Co., PC 401(k) Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The plan is defined contribution plan covering substantially all employees of Concannon Miller & Co., PC (company). The plan is subject to all provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of pre-tax or after-tax (Roth 401(k)) eligible compensation, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Additional profit sharing contributions are discretionary and are determined annually by the plan sponsor, subject to certain limitations. A participant must have attained age 21, completed one year of service and be employed on the last day of the plan year to be eligible for profit sharing contributions. Profit sharing contributions for the periods ended September 28, 2023 and September 30, 2022 were \$42,927 and \$650,013, respectively.

Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds and a guaranteed insurance contract as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company's discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

**NOTES TO FINANCIAL STATEMENTS (Continued)

NOTE 1 DESCRIPTION OF PLAN (Continued)

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest. Interest rates are commensurate with local prevailing rates as determined by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Principal and interest is paid ratably through payroll deductions. No allowance for credit losses has been recorded as of September 28, 2023 or September 30, 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Upon the occurrence of a distributable event due to separation from service by termination, death, disability, or retirement, as defined by the Plan Agreement, a participant or designated beneficiary, as applicable, may elect to receive a lump sum cash distribution equal to the value of the participant's vested interest in his or her account. Hardship and in-service withdrawals, as defined in the Plan Agreement, are also permitted from a participant's account.

Forfeited Accounts

As of September 28, 2023 and September 30, 2022, forfeited nonvested accounts totaled \$0 and \$33,612, respectively. These accounts will be used to reduce plan expenses and employer contributions. For the periods ended September 28, 2023 and September 30, 2022, employer contributions were reduced by \$16,361 and \$0 from forfeited nonvested accounts, respectively.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

For the Plan periods ended September 28, 2023 and September 30, 2022, the financial statements are prepared under the liquidation basis of accounting in accordance with principles generally accepted in the United States of America ("GAAP"). Under this method of accounting, net assets available for benefits are reflected at the estimated value expected to be disbursed as of September 28, 2023 and September 30, 2022 due to termination of the Plan. See Note 7 for additional information.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTES TO FINANCIAL STATEMENTS (Continued)

NOTE 2 SUMMARY OF ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive insurance contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition - Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The company absorbs certain administrative expenses of the plan. Expenses that are paid by the company are excluded from the financial statements. Fees related to participant benefit payments and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 FAIR VALUE MEASUREMENTS - CONTINUED

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at September 28, 2023 and September 30, 2022.

Common stock: Valued at the closing price reported on the active market on which the securities are traded.

Exchange traded funds: Valued at the daily closing price as reported by the fund.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**NOTE 5 GUARANTEED INSURANCE CONTRACT WITH EMPOWER ANNUITY
INSURANCE COMPANY OF AMERICA**

The Key Guaranteed Portfolio is a fully benefit-responsive contract that is backed by the general account of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest credit rate, as stated in the contract, and prevailing market conditions. Interest crediting rates are reset quarterly. Although Plan participants generally may withdraw assets from the contract without restrictions, the contract may impose a hold period in the event of a full or partial discontinuance.

NOTE 6 RELATED-PARTY TRANSACTIONS

Empower Annuity Insurance Company of America (Empower), formerly Great-West Trust Company, LLC is the custodian as defined by the Plan. Transactions with Empower qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and/or transactional items amounted to \$13,332 and \$17,609 for the periods ended September 28, 2023 and September 30, 2022, respectively.

Empower Advisory Group, LLC, formerly Advised Assets Group, LLC, provides investment management services to the Plan. Transactions with Empower Advisory Group, LLC qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$1,756 and \$1,724 for the periods ended September 28, 2023 and September 30, 2022, respectively.

Notes receivable from participants also qualify as party-in-interest transactions according to the Department of Labor guidelines. Total outstanding notes as of September 28, 2023 and September 30, 2022 were \$0 and \$45,178, respectively.

NOTE 7 PLAN TERMINATION

In 2022, Concannon Miller & Co., PC Shareholders approved a merger with CliftonLarsonAllen LLP. Due to this merger, the plan was terminated on September 28, 2023. All participants, other than shareholders of Concannon Miller & Co., PC, were terminated from the Plan effective October 31, 2022, at which time all participants became 100% vested. Participants had the option to elect lump sum payment, individual account rollover (IRA) or a direct transfer into another qualified plan. The plan paid out all participants on or before September 28, 2023.

The plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements considered events through January 9, 2024, the date the financial statements were available to be issued.

NOTE 8 TAX STATUS

The plan adopted a non-standardized prototype plan as designed by Dataair Employer Benefit Systems, Inc. The prototype plan received a determination letter from Internal Revenue Service (IRS) on June 30, 2020, which stated that the plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the plan is qualified and the related trust is tax-exempt.

NOTE 9 RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 PROHIBITED TRANSACTIONS

Participant contributions of \$2,454 were withheld from a participants pay on March 17, 2022. This constituted a loan of \$2,454 from the Plan to the Plan sponsor. The delinquent participant contributions of \$2,454 were remitted to the Plan's trust in 2023.
