### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Visiting Angels 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As discussed in Note 6 to the financial statements, the Board of Directors of Anytime Home Care, Inc. d/b/a Visiting Angels Living Assistance Service, the Plan Sponsor, voted on January 1, 2023 to merge the Plan into the GSP Navigator Pooled Employer Plan effective July 13, 2023. All plan assets were transferred to the GSP Navigator Pooled Employer Plan on July 13, 2023. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ### Notes to Financial Statements

#### **Note 1 - Description of Plan**

The following description of the Visiting Angels 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan is a defined contribution plan covering substantially all employees of Anytime Home Care, Inc. d/b/a Visiting Angels Living Assistance Service (the Company). To be eligible to make salary deferrals and receive employer contributions, employees must complete one year of service and be age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Financial Statement Presentation**

These financial statements include the period January 1, 2023 to July 13, 2023 and the year ended December 31, 2022. The Plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2022, as permitted by 29 CFR 2520.104-50, since the following plan year of January 1, 2023 to July 13, 2023 was a short year of seven months or less. Accordingly, the Plan has included a statement of net assets available for benefits as of July 13, 2023 and December 31, 2022, along with a statement of changes in net assets available for benefits for the period January 1, 2023 to July 13, 2023 and the year ended December 31, 2022, as required by Department of Labor regulations when such election is made.

##### **Contributions**

Each year participants may contribute up to the maximum percentage allowable by law of pre-tax annual compensation and, post-tax (Roth) annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company provides a safe harbor matching contribution equal to 100% of the first 3% of eligible wages and 50% of the next 2% of eligible wages. In addition, the Company may make a discretionary contribution, which would be allocated per the plan document. Participants must be employed on the last day of the plan year to receive the employer discretionary contributions. No discretionary contributions were made for the period January 1, 2023 to July 31, 2023 or the year ended December 31, 2022. Contributions are subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after six years of credited service, based on the following vesting schedule:

The Plan permits retirement upon reaching the latter of age 65 or completion of five years of credited service. Regardless of the number of years of service, a participant's account becomes fully vested when a participant becomes permanently disabled or dies.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account in accordance with the provisions of the Plan. A partial or installment distribution is permitted for required minimum distributions.

#### Forfeited Accounts

Forfeited nonvested accounts, if any, will first be used to pay the Plan's administrative expenses. Any remaining amounts will be used to reduce future employer contributions. Forfeited nonvested accounts at December 31, 2022 were immaterial. There were no forfeited nonvested accounts at July 13, 2023 as a result of the plan merger (see Note 6).

### Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the distribution of benefit payments are charged directly to the participants account and are included in administrative expenses.

### **Note 3 - Information Certified and Provided by a Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at July 31, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments for the period January 1, 2023 to July 31, 2023 and year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (formerly, Great-West Life & Annuity Insurance Company), as power of attorney for Talcott Resolution Life Insurance Company, the custodian of the Plan, as of and for the period January 1, 2023 to July 31, 2023 and year ended December 31, 2022.

### **Note 4 - Fair Value Measurements**

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at July 13, 2023 and December 31, 2022.

Pooled separate accounts are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by PA Retirement Solutions, Inc. The non-standardized pre-approved profit sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the non-standardized pre-approved profit sharing plan is qualified under the appropriate section of the Internal Revenue Code (IRC). The non-standardized pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state, or local tax authorities for years before 2020.

#### Note 6 - Plan Termination

The Board of Directors of the Company approved a resolution to merge the Plan into the GSP Navigator Pooled Employer Plan. All plan assets were liquidated and transferred to the GSP Navigator Pooled Employer Plan on July 13, 2023. The net assets transferred on July 13, 2023 represent investments at fair value of \$2,315,730.

#### Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of pooled separate accounts managed by Empower Annuity Insurance Company of America, as power of attorney for Talcott Resolution Life Insurance Company. Empower Annuity Insurance Company of America is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services are not material.

#### Note 9 - Reconciliation of Financial Statements to Form 5500

The Plan invests in various pooled separate accounts (PSAs) that do not file a Form 5500 as a Direct Filing Entity. Accordingly, on the Form 5500 filed by the Plan, the percentage of the interest in the underlying assets of the PSAs, which are registered investment companies, must be reported in the appropriate categories on the asset and liability statement of the Form 5500 for the Plan.

The excise tax payments were made from the plan sponsor's assets and not from assets of the Plan.

Plan management has evaluated subsequent events through January 18, 2024. This date is the date the financial statements were available to be issued. No material events subsequent to July 13, 2023 were noted.
