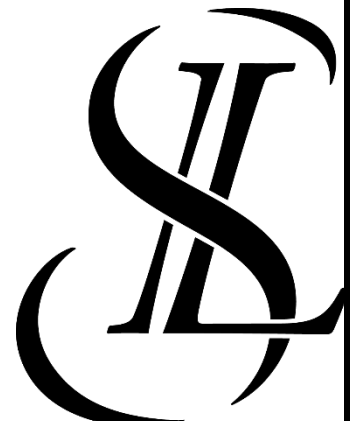

### 1. Description of the Plan

The following brief description of the Summit School Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

Effective March 1, 2023, Summit School, Inc. (the “Institution” or “Employer”) elected to adopt and participate in the Independent School Collaborative Multiple Employee Plan (“ISC MEP”) resulting in a merger of the Plan and transfer out of approximately \$30,272,000 to the ISC MEP.

#### **General**

The Plan is a defined contribution 403(b) plan available to qualifying employees of Institution who normally work 20 hours per week (except adjunct faculty and bus drivers). Employees may begin participation as of the first of the month coinciding with or following the date on which they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Participants may elect to contribute a percentage of their pre-tax or after-tax annual compensation, as defined, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Institution’s discretionary matching contribution was 100% of participant contributions up to the first 5% of eligible compensation for 2023 and 2022.

#### **Participant Accounts**

Participants may direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time. Each participant’s account is credited with the participant’s and Institution’s contributions and an allocation of plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

#### **Vesting**

Participants are immediately vested in both their contributions and the Institution’s contributions plus actual earnings thereon.

#### **Benefit Payments**

Upon termination of service, a participant or beneficiary can elect to receive an amount equal to the value of the participant’s account in the form of a lump-sum or installment distributions or certain annuity options. In-service distributions may be made from the Plan to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

#### **Notes Receivable from Participants**

Participants may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are generally up to five years and only one note may be outstanding at a time. The notes are secured by the vested account balance in the participant’s account and bear interest at the prime rate plus 1% at the date of application. Principal and interest are paid directly to the Plan. However, no notes receivable from participants were outstanding at June 30, 2023 or 2022.

### 1. Description of the Plan (Concluded)

#### **Administrative Expenses**

The Institution absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Investment fees are paid by the Plan.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan have been prepared on a liquidation basis, in accordance with accounting principles generally accepted in the United States of America ("GAAP"). This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. As a result of the Plan's adoption and merger into the Independent School Collaborative Multiple Employee Plan ("ISC MEP") described in Note 1, the Plan's financial statements as of and for the year ended June 30, 2023, have been prepared on the liquidation basis and the June 30, 2022 financial statements have been prepared on a going concern basis in accordance with GAAP. There were no material changes to the 2023 financial statements as a result of the change to liquidation basis of accounting.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. However, no notes receivable from participants were outstanding at June 30, 2023 or 2022, and thus no allowance for credit losses has been recorded. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Valuation of Investments and Income Recognition**

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year. The Plan's investment in the TIAA Traditional Annuity is stated at contract value which equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals, and net of any transfers.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through January 17, 2024, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements, including investments held at June 30, 2023 and 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended June 30, 2023 and 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF.

### 4. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Institution has adopted a prototype plan document sponsored by TIAA within the meaning of the Internal Revenue Code ("IRC") Section 403. The IRS has determined and informed TIAA by a letter dated August 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

As a result of the Plan merger discussed in Note 1, the Plan terminated during 2023. All participants remained fully vested in their existing account balances.

### 7. Party-in-Interest Transactions

Certain investments of the Plan are managed by TIAA-CREF, which also serves as the recordkeeper of the Plan. Investment and other fees paid by the Plan to TIAA-CREF and bundled service providers were \$73,556 and \$123,291 in 2023 and 2022.

Fees paid by the Plan to CBIZ Investment Advisory Services for investment advisory services were \$1,380 and \$5,764 in 2023 and 2022.

Fees paid by the Plan to Smith Leonard PLLC for audit and accounting services were \$2,750 and \$10,000 in 2023 and 2022.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

***Basis of Fair Value Measurements***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and 2022.

*Registered investment companies:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV is generally valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investment including matrix pricing. Each unit value is determined daily and is classified within Level 1 of the valuation hierarchy.

*TIAA Real Estate Account:* This investment is an insurance company separate account of TIAA investing mainly in real estate and real estate-related investments. Its value is derived from the market value of the underlying holdings that are valued principally using external appraisals, which are estimates of property values based on a professional’s opinion. The account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Each unit value is determined daily and is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 9. Investments at Contract Value

Investments at contract value are comprised of the TIAA Traditional Annuity, which is a fixed rate annuity contract that is fully and unconditionally guaranteed and backed by the claims-paying ability of TIAA. The TIAA Traditional Annuity provides a guarantee of principal plus a guaranteed minimum rate of interest as declared quarterly. The current declared interest rate was 5.25% at June 30, 2022.

When the investment is converted to an annuity based upon life expectancy, the present value of the stream of payments is equal to the balance at conversion. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange and is stated at contract value which equals the accumulated cash contributions, interest credited to the Plan's contracts, less any withdrawals, and net of any transfers.
