We are the Court Appointed Accountants for the Chapter 7 Trustee of Moon Group Inc. ("MGI"), which filed for protection under Chapter 11 of the United States Bankruptcy Code on August 12, 2021 and was subsequently converted to Chapter 7 on February 11, 2022. Don A. Beskrone Esq. was appointed as the Trustee on February 16, 2022. All operations and payroll ceased as of the Chapter 7 filing.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(11), the Trustee is responsible for the liquidation of the Plan Assets of the MGI 401(K) Plan ("the Plan").

The 2023 annual informational return was prepared from the best information available; that is, data provided by the Plan's Record Keeper and Plan Asset Custodian, Empower Retirement ("Empower"). Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

During 2023, as part of the termination and liquidation process, all of the Plan's funds were distributed to Participants, and this return is therefore being filed as a Final return. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

Neither the Trustee, nor the Trustee's Court Appointed Accountants have any direct knowledge of the transactions recorded by the Debtor and Empower as reported on this return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor or Empower.

The Trustee, by his signature on the face of this informational return, has relied on our expertise in preparing the return from the available records, which were limited due to the entity's cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
