### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter – Plan Termination and Liquidation Basis**

As discussed in Note 5 to the financial statements, the Board of Directors of Centric Bank, the Plan's sponsor, voted on January 30, 2023, to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the December 31, 2022, financial statements to the liquidation basis of accounting used in presenting the July 18, 2023, financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due, or which may become due, to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance, and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Centric Bank 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a contributory defined contribution plan covering the employees of Centric Bank (the “Bank”) who have attained the age of 18 and have completed 90 days of service. The Plan includes a 401(k) before-tax savings feature, which permits participants to defer compensation under Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan. The 401(k) Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Directors.

Merger and Plan Termination

Centric Financial Corporation, the holding company for the Bank, entered into an agreement and plan of merger dated August 22, 2022, with First Commonwealth Financial Corporation (the “Merger”). The Merger closed on January 31, 2023. On January 30, 2023, the Bank’s Board of Directors adopted a resolution to terminate the Plan effective January 30, 2023. The final distributions were issued by July 18, 2023. Additional details are included in Note 5.

Participation

An employee becomes a participant in the Plan on the first day of the calendar quarter coinciding with or next following the date eligibility requirements are met.

Service Rules

Employees are credited with one year of service for each Plan year during which they have at least 1,000 hours of service.

Contributions

There are several types of contributions that can be added to a participant’s account: an employee salary deferral contribution, an employee rollover contribution, an employer discretionary matching contribution, and an employer discretionary profit sharing contribution. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

Participants may contribute up to 100 percent of their annual pretax compensation by way of a salary deferral contribution each period, to the maximum amount permitted by the IRC. Participants may change their deferral election at any time throughout the year, as defined in the Plan Document.

## NOTE 1 – DESCRIPTION OF PLAN (Continued)

### Contributions (continued)

For 2023, the employer contributed an amount equal to 50 percent of the participant's salary deferral contributions, up to a maximum of 6 percent of the participant's compensation in the form of a matching contribution. Each year, the employer, at the sole discretion of its Board of Directors, determines the amount of the employer profit sharing to be made. There was no profit sharing contribution made by the Bank during the year.

The participants may direct their accounts into various investment options. Employees must meet certain requirements to receive an allocation of the employer matching and profit sharing contributions. Contributions are subject to certain limitations.

### Participants' Accounts

Each participant's account is credited with an allocation of various contributions and Plan earnings (including realized and unrealized appreciation or depreciation of Plan assets) and charged with an allocation of administrative expenses. Allocations of the employer-qualified nonelective and profit sharing contributions are based on participants' compensation, while allocations of Plan earnings are based on participants' account balances. Loan and disbursement processing fees are charged to the respective participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### Vesting

A participant is 100 percent vested at all times in the participant's salary deferral account and rollover account plus actual earnings thereon, regardless of the number of years of service. If participants cease participation, other than by retirement, disability, or death, the vested interest in the remainder of their accounts is dependent upon the years of credited service, as follows:

As a result of the decision to terminate the Plan, all participants became fully vested in their account balances.

### Payment of Benefits

Pursuant to the Plan termination, participants had the opportunity to elect to receive a distribution of their vested account balance as single cash payment either (i) directly to the participant, subject to mandatory federal and state tax withholdings, or (ii) as a direct rollover by the Plan's trustee into another eligible retirement account or an Individual Retirement Account (IRA). In the event the participant did not provide an election by June 30, 2023, the vested account balance was rolled over directly to an IRA on behalf of the participant established by the Plan Sponsor.

As a result of the Plan termination, all balances were distributed to participants in the Plan by July of 2023.

## NOTE 1 – DESCRIPTION OF PLAN (Continued)

### Notes Receivable from Participants

Loans are available to participants of the Plan and are subject to approval by the Plan Administrator. The minimum loan amount is \$1,000. Loans may not exceed the lesser of \$50,000 or one-half of a participant's vested account balance. Loans bear interest on the unpaid principal and must be repaid within five years, unless the loan is used to acquire a principal residence. Interest is payable at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through monthly payroll deductions.

### Administrative Expenses

Administrative expenses of the Plan relating to investment management and recordkeeping fees are paid by the Plan. Fees relating to accounting and miscellaneous administrative expenses are paid by the Plan Sponsor.

### Forfeited Accounts

As of July 18, 2023, unallocated forfeitures totaled \$0. As of December 31, 2022, unallocated forfeitures totaled \$11. Forfeitures of employer matching nonvested accounts are used to reduce the employer's matching contribution or to offset Plan administrative expenses. During the short plan year ended July 18, 2023, there were \$16,505 in forfeitures used to reduce the employer's matching contribution and \$694 used to reduce Plan administrative expenses.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

Due to the decision to terminate the Plan during 2023, the Plan's financial statements as of July 18, 2023, and for the period ended July 18, 2023, have been prepared on the liquidation basis of accounting, in accordance with GAAP.

The financial statements of the Plan have been prepared on a liquidation basis, in accordance with accounting principles generally accepted in the United States of America (GAAP). This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value, and liabilities are stated at their anticipated settlement amounts.

### Valuation of Investments and Income Recognition

There were no investments remaining at July 18, 2023. As of December 31, 2022, the Plan's investments were stated at fair value except for its benefit-responsive investment contracts, which were valued at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value of investments includes the gains and losses on investments purchased, sold, and held during the year. The Plan Administrator determines the Plan's valuation policies, utilizing information by the investment advisers, custodians, and insurance company.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Excess Contribution Payable

Amount payable to participants for contributions in excess of amounts allowed by the IRS is recorded as a liability with a corresponding reduction to contributions. The Plan had \$0 in excess contributions as of July 18, 2023, and \$2,897 as of December 31, 2022.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of July 18, 2023, and December 31, 2022.

### Investment Fees

Net investment returns reflect certain fees paid by the investments' funds to their affiliated investment advisers, transfer agents, and others, as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and, thus, are not separately identifiable as an expense. Investment-related expenses are included in net appreciation of fair value of investments.

### Payment of Benefits

Benefit payments to participants are recorded when paid.

### Estimates

The preparation of financial statements is in conformity with U.S. GAAP and requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 3 – INVESTMENTS

The following is a summary of the investment information as of and for the short plan year ended July 18, 2023, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by Empower Retirement (Trustee) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL)’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator elected to have an ERISA Section 103(a)(3)(c) audit and instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule, related to the following investments:

Empower Retirement also certified to the completeness and accuracy of \$400,838 of net appreciation in fair value of investments and \$16,348 of interest and dividends related to the aforementioned investments and participant loans for the short plan year ended July 18, 2023.

#### NOTE 4 – GUARANTEED INVESTMENT CONTRACTS WITH GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY

The Plan entered into benefit-responsive guaranteed investment contracts with Great-West Life & Annuity Insurance Company. Great-West Life & Annuity Insurance Company maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the Statement of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### NOTE 5 – PLAN TERMINATION

On January 30, 2023, the Plan Sponsor's Board of Directors adopted a resolution to terminate the Plan effective January 30, 2023. As a result, management determined that liquidation was imminent.

In April 2023, a Notice of Plan Termination was distributed to Plan participants. The Notice of Plan Termination provided Plan participants or beneficiaries their available options to receive their vested account balances. As a result of the resolution to terminate the Plan, each participant with an account balance under the Plan had the option to receive his or her account balance distributed in a single cash payment either (i) directly to the participant, subject to mandatory federal and state tax withholdings, or (ii) as a direct rollover by the Plan's trustee into another eligible retirement account or an IRA. In the event the participant did not provide an election by June 30, 2023, the vested account balance was rolled over directly to an IRA on behalf of the participant established by the Plan Sponsor.

## NOTE 6 – TAX STATUS

The Plan is operating under a volume submitter 401(k) profit sharing plan prepared by PA Retirement Solutions, Inc. The Plan obtained its latest determination letter on September 30, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator and the Plan’s advisers believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 18, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

## NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments, such as mutual funds, collective trust funds, and guaranteed investment contracts, are managed by the Trustee of the Plan. In addition, the Plan issues loans to participants that are secured by the balances in participants’ accounts. Therefore, related transactions qualify as party-in-interest transactions.

The Plan’s sponsor absorbs fees related to accounting and miscellaneous administrative expenses, which are considered party-in-interest transactions. Such costs amounted to \$41,339 for the short plan year ended July 18, 2023.

## NOTE 8 – FAIR VALUE MEASUREMENTS

The following disclosures show the three broad levels of hierarchal disclosure framework associated with the level of pricing observations utilized in measuring assets and liabilities at fair value.

- Level I: Quoted prices are available in active markets for identical assets or liabilities as of the reported date.
- Level II: Pricing inputs are other than quoted prices in active markets that are either directly or indirectly observable as of the reported date. The nature of these assets and liabilities includes items for which quoted prices are available but traded less frequently, and items that are fair-valued using other financial instruments, the parameters of which can be directly observed.
- Level III: Valuations are derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

This hierarchy requires the use of observable market data, when available.

The following is a description of the valuation methodologies used for assets measured at fair value:

### Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and these investments are classified as Level I.

NOTE 8 – FAIR VALUE MEASUREMENTS (Continued)

Common and Collective Trust

Common trusts are valued at the NAV of shares held by the Plan at year-end adjusted for any cash held for liquidity purposes and any fees imposed by the fund. The NAV per unit is determined by dividing the net assets by the number of units outstanding on the day of valuation. In accordance with the terms of the Plan of Trust, the NAV of the fund is determined daily. Units are issued and redeemed daily, at the daily NAV. Also, the net investment income and realized and unrealized gains on investment are not distributed.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present the assets reported on the Statement of Net Assets Available for Benefits at their fair value as of July 18, 2023, and December 31, 2022, by level within the fair value hierarchy. Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

#### NOTE 9 – FAIR VALUE OF FINANCIAL INSTRUMENTS

Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract that creates an obligation or right to receive cash from or deliver cash or another financial instrument to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the fair value would be calculated based upon the market price per trading unit of the instrument.

Cash, mutual funds, common and collective trusts, and notes receivable from participants would be considered financial instruments. At July 18, 2023, and December 31, 2022, the carrying amounts of these financial instruments approximate fair value.

#### NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

#### NOTE 11 – SUBSEQUENT EVENTS

Management has reviewed events occurring through January 16, 2024, the date the financial statements were issued, and no subsequent events occurred requiring accrual or disclosure.
