Subject: Reasonable Cause for Late Filing of Form 5500 – SS for Year 2022

Dear Sir/Madam,

I am writing to explain the circumstances surrounding the late filing of Form 5500 – SS for the year 2022 & 2023 for Global Planners, INC. I understand the seriousness of this matter and wish to provide a detailed account of the events that led to this unfortunate situation.

Global Planners, INC. was founded in the year 2000 and has been diligently providing retirement benefits to its employees since 2002. Throughout our 21 years of operation, we have maintained a consistent record of compliance and have never missed a filing deadline. However, the unforeseen challenges brought about by the COVID-19 pandemic significantly impacted our operations.

As the owner of the company, I experienced a substantial downturn in business, which led to a drastic reduction in staff from 20+ employees to a single employee, my self during the years 2020 and 2021. Due to the circumstances, my attention was largely diverted towards sustaining the business and ensuring its survival. Consequently, I relied on our third-party payroll company to handle the necessary filings, as I had done in previous years.

I was under the impression that our third-party payroll company was managing the filing process, as I received email notifications indicating that the forms were being completed. Unfortunately, I was unaware that the forms needed to be filed electronically, leading to my inadvertent failure to meet the deadline.

Upon realizing the oversight, I promptly attempted to rectify the situation by submitting the forms directly to the IRS, based on the advice provided by our third-party payroll provider. However, the forms were returned to me by the IRS in December 2023, resulting in further delay.

Subsequently, I received a letter from the compliance officer of the US Department of Labor, prompting me to thoroughly research the appropriate protocol and make the necessary corrections. I am committed to resolving this matter and ensuring full compliance with all regulatory requirements.

I must emphasize that the financial impact of the COVID-19 pandemic has been devastating for both myself and the company. Global Planners, INC. has since been dissolved, and I find myself in a precarious financial position. As such, I humbly request your understanding and ask for your consideration in recognizing that the late filing was due to my lack of knowledge in the electronic filing process, compounded by the extraordinary circumstances the company faced.

I sincerely hope that you will take into account the exceptional circumstances outlined above and refrain from imposing penalties on me for the late filing. I assure you that I am fully committed to resolving this matter and will take all necessary steps to ensure compliance in the future.
