REPORT OF INDEPENDENT PUBLIC ACCOUNTANTS

To the Participants, Plan Administrator, and Retirement Plan Committee of the Retirement Plan for Employees of All Children's Health System, Inc.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Retirement Plan for Employees of All Children's Health System, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period of January 1, 2023 to April 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 30, 2023 and December 31, 2022, and for the 4-month period ended April 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As disclosed in Note 1, effective December 31, 2022, the Board of Trustees voted to terminate the Plan. All assets of the Plan were liquidated as of April 30, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one



resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal controls. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal controls-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following brief description of the Retirement Plan for Employees of All Children's Health System, Inc. (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a non-participant-directed defined contribution plan established on January 1, 1989, which covered substantially all the employees of All Children's Health System, Inc. (the System or Employer). Effective January 1, 2021, the Adoption Agreement of the Plan was amended to permit participant-directed investments. To be eligible for the Plan, an employee must be age 21 or older and have completed 1,000 hours of service during the consecutive 12-month period beginning on the employee's hire date. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee (the Committee) was responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Effective December 31, 2022, the Board of Trustees voted to terminate the Plan. All assets of the Plan were liquidated on April 30, 2023. Upon termination, all participants became 100% vested in their accounts.

Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act was enacted in December 2019, and became effective January 1, 2020. The SECURE Act was designed to encourage investing for retirement by increasing the required minimum distribution age, allowing part-time employee enrollment, and offering annuity options for certain tax-qualified retirement plans.

The Plan incorporated the SECURE Act changes in its Plan document during the year ended December 31, 2022. SECURE Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with similar retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans.

The Plan's management and those charged with governance had a policy to incorporate legislative changes in its Plan document by the prescribed deadlines.

1. DESCRIPTION OF THE PLAN (continued)

Contributions

Contributions to the Plan by the System were discretionary and were determined on an annual basis by the System's Board of Directors. Participants must be employed on the last day of the Plan year to be eligible to receive the annual contribution unless termination is due to normal or early retirement, death, or disability.

There were no provisions for participant pretax or after-tax contributions. Participants could also rollover distributions from other qualified defined benefit or defined contribution plans. There were no System contributions approved by the Board of Directors for the 4-month period of January 1, 2023 to April, 30, 2023.

Participant Accounts

Each participant's account was credited with the allocations of the System's contributions and adjusted for investment earnings (losses) on Plan's assets. Participants' accounts may be charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The participant was entitled to a benefit that cannot exceed the participant's vested account.

Vesting was based on the number of years of service. Participants were vested according to the following schedule:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

Payment of Benefits

Upon termination of service, a participant could elect to receive the value of the participant's vested account balance as provided for in the Plan agreement.

Forfeitures

Forfeitures were used to first reduce future System contributions and then pay administrative expenses of the Plan. As of April 30, 2023 and December 31, 2022, the unallocated forfeitures balance was \$0 and \$15,294, respectively.

Basis of Accounting

The accompanying financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were stated at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The System's management determined the Plan's valuation utilizing information provided by its investment advisers and custodians. See Note 4 for discussion of fair value measurements. See Note 5 for discussion on the fully benefit-responsive investment contract.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions were recorded in the period that the System's Board of Directors approved the annual contribution.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the System. Expenses that were paid by the System are excluded from these financial statements. Investment related expenses were included in net appreciation of fair value of investments.

Revenue sharing payments were reported as administrative fee reimbursements in the statement of changes in net assets available for benefits.

The Plan had an administrative budget account. On a periodic basis, certain revenue sharing payments (e.g., 12b-1 fees, etc.) received from certain of the Plan's investment options were deposited into a dedicated administrative budget account in the Plan.

Expenses (continued)

Amounts deposited in the administrative budget account were used to pay ongoing administrative expenses of the Plan in accordance with ERISA and guidance issued by the U.S. Department of Labor. During the year ended April 30, 2023, \$8,144 was deposited into the dedicated account and \$14,565 was used to pay for administrative expenses during the year. As of April 30, 2023 and December 31, 2022, the dedicated account balance was \$0 and \$6,362, respectively.

Subsequent Events

The Plan's management evaluated subsequent events and transactions through January 26, 2024, the date these financial statements were available for issue, and has determined that no material subsequent events have occurred that would affect the information presented or require additional disclosure.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of April 30, 2023 and December 31, 2022, and net appreciation/(depreciation) in fair value of investments and interest and dividends for the 4-month period of January 1, 2023 to April 30, 2023, was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (State Street), the Trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the entity has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of April 30, 2023 and December 31, 2022.

Mutual funds, collective trusts and money market fund: valued at a daily calculated net asset value (NAV) and is traded at a quoted price through the National Securities Clearing Corporation. The mutual funds held by the Plan are deemed to be actively traded and are reported at Level 1.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan held a traditional investment contract with Metropolitan Life Insurance Company (MetLife). This contract met the fully benefit-responsive investment contract criteria, and therefore, was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment, as reported to the Plan. The contract value of the unallocated contract as of April 30, 2023 and December 31, 2022, was \$0 and \$2,585,755, respectively.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (continued)

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.27 percent. The crediting rate is reviewed on a periodic basis for resetting. The contract cannot be terminated before the scheduled maturity date.

6. RELATED-PARTY TRANSACTIONS AND PARTY-IN- INTEREST TRANSACTIONS

Certain Plan investments were managed by Transamerica Retirement Solutions, LLC. Transamerica Retirement Solutions, LLC was also the record-keeper for the Plan, and therefore, these transactions qualified as party in interest transactions.

7. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

8. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the System by a letter, dated March 28, 2012, that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan was qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.
