We have performed audits of the financial statements of Northern Architectural Systems, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As a result of the termination of Northern Architectural Systems, Inc. 401(K) Plan, the liquidation basis of accounting was used in presenting the financial statements for the period from January 1, 2023 to January 31, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Northern Architectural Systems, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO THE FINANCIAL STATEMENTS FOR THE PERIOD FROM JANUARY 1, 2023 TO JANUARY 31, 2023 AND YEAR ENDED DECEMBER 31, 2022

1. DESCRIPTION OF PLAN

General --- The following description of the Northern Architectural Systems, Inc. 401(K) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees who satisfy eligibility requirements of Northern Architectural Systems, Inc. (the "Company"). The Plan was established on January 1, 2018, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the administrator of the Plan. Nationwide Trust Company, FSB serves as the custodian for the Plan.

Effective January 1, 2023, the trustees approved a change in their employee benefit plan from a defined contribution plan to a pooled employer plan. The new plan is an open multiple employer plan that pools the 401(k) assets of multiple unrelated employers. As a result, the Plan terminated and liquidated on January 17, 2023. The Plan transferred all of its assets in the amount of \$535,041 from Nationwide Trust Company, FSB, to Newport Trust Company. The liquidation basis of accounting was used in presenting the financial statements for the period from January 1, 2023 to January 31, 2023.

Eligibility --- All employees of the Company are eligible to make salary reduction contributions, including designated Roth contributions, except employees covered by a collective bargaining agreement and non-resident aliens with no U.S. source income. Prior to August 7, 2020, employees enter the Plan on the first day of the month coinciding with or immediately following their date of hire. Effective August 7, 2020, the Plan was amended to allow employees to enter the Plan on the first day of the month coinciding with completion of one year of service.

Contributions --- Each year, participants may voluntarily contribute both pre-tax and/or Roth contributions to the maximum allowable amount as mandated under the Internal Revenue Service (the lesser of 100% of eligible compensation or \$22,500, as defined in the Plan). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. At its sole discretion, the Company may contribute and allocate to each eligible Participant's account, a percentage of the Participant's elective deferrals. Employer matching contributions, if any, shall be determined as of the end of the Plan year. Contributions are subject to certain limitations. Employer contributions made for the period from January 1, 2023 to January 31, 2023 and the year ended December 31, 2022 were \$-0-, respectively.

Participant accounts --- Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants --- Prior to August 7, 2020, participants may borrow from their fund accounts up to the maximum amount that may be borrowed from a qualified plan without being subject to income tax (currently, \$50,000 or, if less, 50% of the value of a participant's vested account balance). This amount may be further limited by the provisions of the contract or if participants have other loans under this plan. The loans are secured by the balance in the participant's account and bear interest at rates which is commensurate with local prevailing rates as determined by the plan administrator. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest is paid ratably through monthly payroll deductions. Repayment should be made through after-tax payroll deductions; however, if repayment is not made by payroll deduction, a loan shall be repaid in accordance with procedures provided by the Plan Administrator. Effective August 7, 2020 the Plan was amended and the Plan no longer allows employees to borrow from their fund accounts. There are no outstanding loan balances as of January 31, 2023 and December 31, 2022, respectively.

Payment of benefits --- On termination of service due to death, disability, or retirement, a participant may elect to receive either in a single lump sum or installment amounts equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts ---- At January 31, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$-0- for both periods. These accounts are used to reduce future employer contributions.

Hardship withdrawals --- Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed by the employee may be withdrawn for a hardship purpose. Any amounts distributed due to a hardship must be distributed in a lump-sum amount. Distributions are subject to the applicable provisions of the Plan agreement.

Cares and Secure Act --- The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. The optional features within these acts are currently being assessed but have not been implemented to date. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT.)

Basis of accounting --- The financial statements of the Plan are prepared on the liquidation basis of accounting for the period ending January 31, 2023 and accrual basis of accounting for the year ended December 31, 2022.

Use of estimates --- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results can differ from those estimates.

Investment valuation and income recognition --- Investments are reported at fair value, (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits --- Benefit payments are recorded when paid.

Expenses --- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

inputs that are derived principally from or corroborated by observable market data by correlation or other means.

3. FAIR VALUE MEASUREMENTS (CONT.)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2023 and December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit responsive guaranteed investment contract with Nationwide Institutional Company ("Nationwide") totaling \$-0- and \$40,236 at January 31, 2023 and December 31, 2022, respectively. Nationwide maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan issuer.

4. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT (CONT.)

The crediting rate is reviewed on a quarterly basis for the crediting rate is based on a formula established by the contract resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit responsive investment contracts criteria and therefore is reported at contract value for the year ended December 31, 2022. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the Plan by Nationwide, represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan's sponsor or their Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at the contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such event includes (1) uncured violation of the Plan's investment guideline (2) a breach of material obligation under the contract (3) a material misrepresentation, (4) a material amendment to the agreement with the consent of the issuer.

5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Plan investments are shares of mutual funds managed by Nationwide Trust Company, FSB, a related entity of Nationwide Investments Institutional. Nationwide Trust Company, FSB is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these funds are open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA and applicable exemptions promulgated thereunder.

6. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of a Plan termination, participants become 100% vested in their employer contributions.

7. TAX STATUS

The Internal Revenue Service has determined and informed the Trustees by a letter dated June 30, 2020, that the Plan and related trust are designed and are currently being operated in accordance with applicable requirements of the Internal Revenue Code (IRC).

Although the Plan has been amended since the Internal Revenue Service determination, the Plan administrator and the Plan's tax counsel believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations generally three years from its latest filing.

8. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 as of January 31, 2023 and December 31, 2022. Accordingly, Nationwide Trust Company, FSB, the custodian of the Plan, has certified to the completeness and accuracy of all investment information reported on the accompanying statements of net assets available for benefits as of January 31, 2023 and December 31, 2022 and the related investment income reflected in the statements of changes in net assets available for benefits for the period from January 1, 2023 to January 31, 2023 and year ended December 31, 2022.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS – SELF CORRECTION PROGRAM

For the year ended December 31, 2021, the audits disclosed that contributions were not remitted timely to the Plan. The 2021 lost earnings on late employee contributions were not remitted and remained outstanding at January 31, 2023 and December 31, 2022. During December 31, 2021, the lost earnings on the late employee contributions amounted to \$196, which were trivial to the Plan in the aggregate. The receivable of \$196 is included in the employer contributions on the Statements of Net Assets Available for Benefits as of January 31, 2023 and December 31, 2022.
