## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
The Infosoft Group Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of The Infosoft Group Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 6, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended September 6, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the period ended September 6, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis-of-Matter**

As discussed in Note 4 to the financial statements, the plan sponsor determined liquidation was imminent as a resolution to terminate the plan was executed effective June 30, 2023. As a result, in accordance with GAAP, the plan changed its basis of accounting from the ongoing basis to the liquidation basis effective January 1, 2023. The change did not have any effect on these financial statements as fair value and liquidation value were substantially the same. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, no such opinion is expressed.

- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - Due to The Infosoft Group Retirement Plan ("the plan") executing a resolution to terminate the plan effective June 30, 2023 (see Note 4), the accompanying financial statements are prepared on the liquidation basis of accounting, effective January 1, 2023. Prior to January 1, 2023, the plan followed the accrual method of accounting wherein additions and deductions were reflected in the period earned or incurred.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to September 6, 2023 through January 23, 2024, which is the date the financial statements were available to be issued.

**Key parties of the plan** - Prior to liquidation, Infosoft Group LLC was the plan administrator, sponsor and employer. Three officers of the employer were the trustees of the plan. Sikich, LLP was the third-party administrator and performed various compliance tests as tax counsel. Denali Wealth Management was the plan's investment advisor. Empower Trust Company, LLC held custody of the plan's mutual fund investments. Empower Annuity Insurance Company of America ("Empower Insurance") held custody of the plan's guaranteed portfolio investment. Empower Retirement, LLC maintained participant records and is the brand name which refers to the products and services provided by the Empower entities discussed above, collectively referred to as "Empower".

**Investments** - The plan administrator determined the investments available to plan participants. The participants allocated their contributions and transferred existing balances among the available investment options. Earnings on investments bought, sold and held during the period/year are reflected in the accompanying statements of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the fund. The mutual funds held by the plan were registered with the U.S. Securities and Exchange Commission, were required to publish their daily net asset value and were deemed to be actively traded.

The plan administrator determined by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

**Investment at contract value** - The plan invested in the Key Guaranteed Portfolio Fund, a general account product of Empower Insurance. The investment was a fully benefit-responsive guaranteed portfolio investment through a group fixed annuity contract issued by Empower Insurance. As a general account product, participants' principal and interest amounts were fully guaranteed by the general assets of Empower Insurance. The methodology for calculating the interest crediting rate was based on prevailing market conditions and earnings of medium-long investments compared to a minimum interest crediting rate, as more fully described in the plan's contract with Empower Insurance. The interest crediting rate was reset quarterly. The average yield earned by the fund was approximately 1% for the period ended September 6, 2023 and the year ended December 31, 2022.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. In connection with the plan termination, participants directed the withdrawal or transfer of the investment at contract value.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General** - The plan was established on January 1, 2003 as a defined contribution plan with a 401(k) salary deferral arrangement. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees were eligible to make elective deferral contributions and receive employer matching contributions once they completed one month of employment and reached age 21. An employee could enter the plan on the first day of the month following completion of the eligibility requirements.

**Contributions** - Contributions to the plan were made in the following ways:

- a. Participants could contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permitted Roth elective deferrals. New employees were automatically enrolled in the plan after reaching eligibility and had 6% of their compensation withheld as deferral contributions (auto-enroll). Such participants had the option to increase, decrease, or stop the deferral by completing the necessary documentation.
- b. Rollover contributions were accepted by the plan from other qualified plans.
- c. Employer matching contributions were made at the employer's discretion. The discretionary percentage in 2023 and 2022 was 50% of the first 6% of employee compensation contributed to the plan as elective deferral contributions, funded bi-weekly to coincide with the employer's payroll.
- d. Employer profit sharing or additional non-elective contributions could be made at the employer's discretion. No such contributions were made in 2023 or 2022.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), were allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account was credited with the participant's elective deferral contributions and rollover contributions and an allocation of employer contributions, if any. Participants were allowed to transfer funds between the various investment options daily and change their deferral percentage on a quarterly basis.

**Vesting** - Participants were always 100% vested in their elective deferral contributions, rollover contributions and related earnings. Participants became 100% vested in the employer contributions and related earnings after completion of their second year of service. Upon death, disability or attainment of normal retirement age (defined as age 65), participants became 100% vested. Upon plan termination (see Note 4), participants became 100% vested in the employer contributions and related earnings.

**Payment of benefits** - In connection with the termination of the plan (see Note 4), all plan assets were distributed to participants at their direction or automatically rolled over to Individual Retirement Accounts under the related participants names by September 6, 2023. Prior to plan termination, benefit payments could commence upon termination of employment, death, disability or attainment of normal retirement age. Participants generally received their distribution in the form of a single lump sum payment. In-service withdrawals could commence upon attaining the age of 59 1/2. Hardship withdrawals were also permitted under certain circumstances.

**Administrative expenses** - Certain administrative expenses of the plan were paid by the employer. Certain other administrative fees were paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses included participant directed charges for distribution and loan processing service fees and non-participant directed fees for administrative and advisory services. Non-participant directed fees were allocated to participants on an account value basis.

**Forfeitures** - Forfeited non-vested employer contributions could be used to pay certain plan administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions were \$6,000 in 2023 and \$14,000 in 2022. Forfeitures used to pay plan administrative expenses were \$10,000 in 2023 and insignificant in 2022. Unapplied forfeitures that were reallocated to eligible participants upon termination of the plan in 2023 were insignificant. Unapplied forfeitures were \$9,000 as of December 31, 2022.

**Notes receivable from participants** - Participants could take out loans against their accounts with the approval of the plan administrator. The minimum loan amount was \$1,000 and the maximum amount was the lesser of one-half of the participant's vested account balance, or \$50,000. Participants could only have one loan outstanding at any given time. The repayment term generally could not exceed five years except when the loan was for the purchase of a principal residence. The note receivable from participant was valued at the unpaid principal balance plus any accrued but unpaid interest, which approximated fair value.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The plan's guaranteed portfolio investment was managed by Empower Insurance. Empower Insurance was the custodian of the plan's guaranteed portfolio investment and, therefore, any transactions between the plan, plan sponsor and Empower Insurance qualified as party-in-interest transactions.

The plan had a service agreement with Empower in which Empower provided certain administrative services to the plan. Direct fees paid to Empower, recorded as a component of administrative expenses, were \$34,000 in 2023 and \$10,000 2022. Empower also received indirect compensation from the plan's mutual fund investment providers for services that Empower provided to the funds. This revenue was used to offset certain amounts owed to Empower for its administrative services to the plan.

Activity related to notes receivable from participants also qualified as party-in-interest transactions.

All of the above party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

## 4. TERMINATION OF PLAN

In April 2023, the plan sponsor was acquired by a third party. In June 2023, the new employer notified the participants that the plan was terminated and that it was in the process of closing the plan. At that time, all participants became 100% vested. In accordance with GAAP, the plan changed its basis of accounting used to value plan assets from the ongoing basis to the liquidation basis effective January 1, 2023. Given the types of investments the plan held (see Note 1), the change did not have a material impact on the plan financial statements, as the liquidation values of the plan's investments were substantially the same as their fair values.

## 5. INCOME TAX STATUS

The plan had adopted the Sikich LLP Prototype Non-standardized Pre-Approved Profit Sharing Plan. The prototype plan received its most recent favorable opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). As a result, the plan administrator did not obtain a separate Internal Revenue Service opinion letter for the plan. The plan administrator and tax counsel believe that the plan was designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of September 6, 2023 and December 31, 2022. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
