We have performed audits of the financial statements of Lifeline Systems Company 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 1, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the periods from January 1, 2022 through July 1, 2022 and from July 1, 2021 through December 31, 2021, and the related notes to the financial statements.

### ***Emphasis of Matter - Plan Merger***

We draw attention to Note 6 of the financial statements, which describes the Lifeline Systems Company 401(K) Plan's merger with the ConnectAmerica.com 401(k) Savings Plan. On July 1, 2022, the plan assets of the Lifeline Systems Company 401(K) Plan were fully merged into the ConnectAmerica.com 401(k) Savings Plan, and the Lifeline Systems Company 401(K) Plan no longer existed after that date.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### Note 1: Description of Plan

The following description of the Lifeline Systems Company 401(K) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Lifeline Systems Company (the "Company") who have completed six months of service and are age 18 or older. Additionally, retained, eligible employees of Philips Electronics North America Corporation as of July 1, 2021, had the service requirement waived. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan was created as a partial spin-off from the Philips Electronics North America Corporation Employee Savings Plan on July 1, 2021. Lifeline Systems Company employees had the option to rollover their balances from the Philips Electronics North America Corporation Employee Savings Plan.

Effective July 1, 2022, the Lifeline Systems Company 401(k) Savings Plan merged into the ConnectAmerica.com 401(k) Savings Plan (see Note 6).

#### Contributions

Each year, participants may contribute to the Plan up to 100% of eligible compensation, as defined by the plan document, on a pre-tax or Roth basis, up to the maximum amount allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Newly eligible participants are automatically enrolled in the Plan at a pre-tax deferral rate of 3% upon their entry date, unless they make an alternate election. Automatically enrolled participants have their contributions invested in a designated fund until changed by the participants. The Company may make discretionary matching contributions to the Plan. For 2022 and 2021, the Company made discretionary matching contributions equal to 150% of deferrals up to 4% of eligible compensation that a participant contributed to the Plan plus 50% of deferrals on the next 2% of eligible compensation that a participant contributed to the Plan resulting in total discretionary matching contributions of \$1,077,854 and \$1,038,652, respectively. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of plan earnings (losses). Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1: Description of Plan (Continued)**

#### **Vesting**

Participants are immediately vested in their voluntary contributions and any rollover contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of service. Participants vest at a rate of 25% per year and become fully vested after four years of service. For vesting purposes, years of service with Philips Electronics North America Corporation count. A participant also becomes 100% vested upon occurrence of death or total and permanent disability prior to termination of service with the Company.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 6.50% during both periods, which are commensurate with local prevailing rates as determined under the plan document. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Benefits are payable to participants, their beneficiaries, or their estates upon termination of employment, normal retirement (age 65), total and permanent disability, or death. Benefits are also payable for in-service distributions from a participant's fully vested accounts upon attaining age 59 1/2, or upon a financial hardship, if certain criteria are met. Benefits are payable in the form of a lump-sum distribution or partial withdrawals. Additionally, participants are entitled to receive a distribution of their rollover accounts at any time. Account balances less than \$5,000 may be automatically rolled into a qualified retirement account upon termination of a participant's employment.

#### **Forfeitures**

At July 1, 2022 and December 31, 2021, forfeited nonvested accounts were \$0 and \$10, respectively. Forfeited nonvested accounts can be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the periods ended July 1, 2022 and December 31, 2021, Company contributions were reduced by \$39,586 and \$4,267 from forfeited nonvested accounts, respectively.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of July 1, 2022 and December 31, 2021. Delinquent participant notes receivable are reclassified as benefit payments on the basis of the terms of the plan document.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and totaled \$- and \$47,089, respectively at July 1, 2022 and December 31, 2021.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of withdrawals and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

#### Subsequent Events

The Company has evaluated subsequent events through January 11, 2024, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

### Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 1, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Fair value of the common/collective trust fund is based on the quoted NAV of the underlying investments held by the common/collective trust fund. The common/collective trust fund invests in a fully benefit-responsive guaranteed investment contract whose underlying investments are pooled separate accounts that invest in funds that are actively traded and must publish their daily NAV and transact at that price.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of July 1, 2022 and December 31, 2021. ### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 1, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the periods from January 1, 2022 through July 1, 2022 and from July 1, 2021 through December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

### **Note 5: Party-In-Interest Transactions**

The Plan incurred fees from ADP, Inc. related to services performed as the Plan's third-party administrator and recordkeeper. Fees for these services are considered party-in interest transactions and were \$22,476 and \$4,613, respectively for the periods ended July 1, 2022 and December 31, 2021.

In addition, certain investment-related fees incurred by the Plan are included in net depreciation in fair value of investments, since they are paid through revenue sharing rather than direct payment.

Notes receivable from participants also qualify as party-in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

On July 1, 2022, plan assets of \$30,429,428 were transferred out of the Plan into the ConnectAmerica.com 401(k) Savings Plan, whose plan sponsor had acquired the Company. After this transfer, the Plan did not have any remaining plan assets, and the Plan no longer existed.

### **Note 7: Tax Status**

The Company adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
