### ***Management's Responsibility for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

### ***Auditor's Responsibility***

Our responsibility is to express an opinion on these financial statements based on conducting the audits in accordance with auditing standards generally accepted in the United States of America. Because of the matter described in the Basis for Disclaimer of Opinion paragraph, however, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion.

### ***Basis for Disclaimer of Opinion***

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 4, which was certified by John Hancock Life Insurance Company, the trustee of the Plan, except for comparing the information with the related information included in the financial statements. We have been informed by the plan administrator that the trustee holds the Plan's investment assets and executes investment transactions. The plan administrator has obtained a certification from the trustee as of and for the years ended December 31, 2020 and 2019, that the information provided to the plan administrator by the trustee is complete and accurate.



***Disclaimer of Opinion***

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on these financial statements.

***Emphasis of Matter***

As described in Note 7 to the financial statements, the governing body of WICAP 401(k) Plan approved a plan of liquidation on November 24, 2020, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2019 financial statements to the liquidation basis used in presenting the 2020 financial statements. Our opinion is not modified with respect to that matter.

***Other Matter – Supplemental Schedules***

The supplemental schedules of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions as of December 31, 2020, are required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 and are presented for the purpose of additional analysis and are not a required part of the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, we do not express an opinion on the supplemental schedules referred to above.

**NOTES TO THE FINANCIAL STATEMENTS**  
**December 31, 2020 (in Liquidation) and 2019 (Ongoing)**

**NOTE 1 Description of Plan**

The following description of WICAP 401(k) Plan (the Plan) provides only general information. Readers should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of Western Idaho Community Action Partnership, Inc. (Organization), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is the Plan's sponsor and serves as Plan administrator.

**Eligibility** – All employees are eligible to participate in the Plan beginning the first day of the month following the completion of ninety days of services provided, that they have attained age 18, with the exception of employees covered by a collective bargaining agreement, part time or seasonal employees, and nonresident aliens.

**Contributions** – Participants may elect to defer up to 100% of their eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also allows the Organization to make discretionary matching contributions. Participants are eligible to receive discretionary matching contributions after completing twelve months of service during which the employee must work at least 1,000 hours. Employees meeting these requirements will become eligible for the employer contributions on the next monthly entry date. No employer matching contributions were made during the years ended December 31, 2020 and 2019.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's deferral contribution and employer matching contributions if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested. Allocations are based upon the participant's eligible compensation or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Notes receivable from participants** – Notes receivable from participants are not provided for by the Plan.

## **NOTE 1 Description of Plan (Continued)**

**Vesting** – Participants are immediately vested in their deferral contributions plus earnings thereon. Participants vest in employer matching contributions and related earnings, or losses based upon years of service with 100% vesting occurring after six years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is terminated, participants become 100% vested in all account balances.

**Forfeitures** – If an employee terminates before his or her employer matching contribution account has become fully vested, such portion of the account is forfeited. Participant forfeitures of employer matching contribution accounts maybe used to reduce administrative expenses of the Plan, reduce future matching contribution, or be used to provide participants with an additional matching contribution as defined by the Plan Agreement. At December 31, 2020 and 2019, there was \$0 and \$0 of available forfeitures, respectively.

**Payment of benefits** – Upon termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account as a lump sum payment. However, if a participant’s vested balance does not exceed \$5,000, the Plan may distribute funds without the consent of the participant. Withdrawals of a participant’s vested account balance while employed are limited to those requested due to events of financial hardship as defined by the Plan Agreement or attainment of age 65.

## **NOTE 2 Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the liquidation basis of accounting for the year ended December 31, 2020 and the accrual method of accounting for the year ended December 31, 2019.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Expenses** – General Plan administrative expenses may be paid out of the forfeiture account or paid by the Organization. Investment management and distribution transaction fees are paid by the Plan participants.

**Investment valuation** – The investments are stated at fair value. If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the “exit price”) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

## **NOTE 2      Summary of Significant Accounting Policies (Continued)**

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation (depreciation) in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Payment of benefits** – Benefits are recorded when paid.

**Subsequent events** – Subsequent events are events or transactions that occur after the Statements of Net Assets Available for Benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the Statements of Net Assets Available for Benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the Statements of Net Assets Available for Benefits but arose after the Statements of Net Assets Available for Benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through December 22, 2023, which is the date the financial statements were available to be issued. The Plan has determined that no material subsequent events have occurred.

## **NOTE 3      Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1**      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
  
- Level 2**      Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3**      Inputs to the valuation methodology are unobservable and significant to the fair value measure

### NOTE 3 Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020.

**Pooled separate accounts** – Units held in pooled separate accounts (PSAs) are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

**Common /collective trust** – Units held in collective trusts (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

#### **NOTE 4 Information Certified by the Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The John Hancock Life Insurance Company, the current trustee of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2020 (in Liquidation) and 2019 (Ongoing).
- Net appreciation in fair value of investments reflected on the accompanying Statement of Changes in Net Assets Available for Benefits in Liquidation for the year ended December 31, 2020.
- Investments reflected on the Schedule of Assets (Held at End of Year).

#### **NOTE 5 Party in Interest Transactions**

Plan investments include units of pooled separate accounts and common collective trusts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee of the Plan and therefore, transactions with these entities qualify as exempt party in interest transactions.

#### **NOTE 6 Tax Status**

The Plan adoption agreement establishes a retirement plan and trust under the DWC ERISA Consultants, LLC Defined Contribution Volume Submitter Plan and Trust. The terms of the Plan have been prepared to conform to sample language provided by the IRS. In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 7 Plan Termination**

On November 24, 2020, the trustees approved a resolution to terminate the Plan as the cost of maintaining the plan outweighed the benefit to employees. The Plan was terminated effective November 30, 2020. As of the termination date the Plan was frozen with respect to eligibility, entry, participant, and contribution/benefit accruals as of the termination date. As of the termination date all non-forfeited participant accounts were 100% vested, benefits were distributed to participants as soon as administratively feasible.

**NOTE 8      Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

**NOTE 9      Non-exempt Party in Interest Transactions**

For the Plan year 2020, the Plan Sponsor had not remitted certain participant contributions to the Trustee in a timely manner as required under the Department of Labor Regulation Section 2510.3-102. During the Plan year 2020, the Organization corrected these fully under VFCP and participant accounts were credited with amounts that would have been necessary had the participant contributions been remitted on a timely basis.
