## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Galen Healthcare Solutions, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 4, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to May 4, 2023, and the related notes to the financial statements.

**1. Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of Galen Healthcare Solutions, Inc. 401(k) Plan are prepared under the accrual method of accounting.

Investments – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022.

Payment of Benefits – Benefits to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses in the amount of \$150 are shown on the statement of changes in net assets available for benefits. This amount represents administrative costs paid to T. Rowe Price for recordkeeping services. The employer absorbs substantially all other costs of the Plan. Expenses that are paid by the employer are excluded from these financial statements.

Subsequent Events – The Plan has evaluated events and transactions that occurred through January 18, 2024, which is the date the financial statements were available for issue.

**2. Plan Description**

The following description of Galen Healthcare Solutions, Inc. 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – Effective January 1, 2006, Galen Healthcare Solutions, Inc. (the Employer) adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective January 1, 2023 (date of merger), the trustees of the Plan approved the merger and subsequent transfer of plan assets, into the RL Datix 401(k) Plan, the surviving plan. See Note 7.

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as Employer contributions. The Plan is a safe harbor 401(k) Plan, and thus, the Employer makes a matching contribution equal to 100% of each participant's elective deferrals up to a maximum of 4% of the participant's compensation. Employees participating in the Plan may contribute up to 100% of their total pay up to the limit in effect for the year. Participants aged 50 or older may make an additional "catch-up" contribution. There were no participant or Employer contributions for the period from January 1, 2023 to May 4, 2023.

Eligibility – Substantially all employees of the Employer are eligible to participate in the Plan beginning on the first of the month coinciding with, or following, their employment commencement date.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the (a) Employer's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Participants' accounts are self-directed within a limited number of funds.

Vesting – Participants are immediately vested in all contribution types plus actual earnings thereon, except for participants terminated prior to January 1, 2013. For these participants, vesting in the portion of their accounts funded by the Employer's regular matching contributions plus earnings thereon is based on years of continuous service according to the following schedule:

Forfeitures – At December 31, 2022, there were no forfeited non-vested amounts.

Payment of Benefits – Participants or their beneficiaries may receive distributions of their account balances in a lump sum upon the earlier of reaching age 59 1/2, disability, death, or termination of service, as defined in the Plan. Further, the Trustee may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's account balance.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**3. Related Party and Party-In-Interest Transactions**

Certain Plan investments are managed by Reliance Trust Company, the trustee, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative costs incurred by the Plan are paid by the plan sponsor. The Plan uses the staff, resources, and facilities of the plan sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions. Participant notes receivable are classified as both related party and party-in-interest transactions.

**4. Tax Status**

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**5. Certification of Financial Information**

The following information included in the accompanying financial statements as of May 4, 2023 and December 31, 2022 and for the period from January 1, 2023 to May 4, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan: investments at fair value, notes receivable from participants, interest and dividends, and net appreciation or depreciation in fair value of investments.

**6. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable input (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trusts:* The fair value of participation units held in collective trust funds are based upon their net asset values as reported by the managers of the collective trust funds and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

On July 25, 2022, Galen Healthcare Solutions, Inc. was sold. Effective January 1, 2023, the Plan was amended, restated, and merged with and into the RL Datix 401(k) Plan sponsored by Datix USA, Inc. Each participant of the Galen Plan as of January 1, 2023, became a member of the RL Datix 401(k) Plan, if not already a member. There was no payroll through Galen Healthcare Solutions, Inc. in 2023, and a blackout period began on May 1, 2023 in preparation for the transfer of plan assets. All assets transferred out of the Plan on May 4, 2023.
