Independent Auditors' Report

To the Participants and Plan Administrators of
The Mills College at Northeastern Defined Contribution Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Mills College at Northeastern Defined Contribution Retirement Plan (formerly known as the Mills College Defined Contribution Retirement Plan) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of March 8, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period from January 1, 2023 to March 8, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of March 8, 2023 and December 31, 2022 and for the period from January 1, 2023 to March 8, 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger and Termination

As further discussed in Note 1 to the financial statements, by way of Plan amendment on January 3, 2023, this Plan was merged into the Northeastern University 403(b) Plan, and all assets were transferred to the control of the Northeastern University Retirement Plan on March 8, 2023. As a result, this Plan was terminated. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Mills College at Northeastern Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

General, Plan Merger and Termination

The Plan was a 403(b) defined contribution retirement plan covering substantially all full-time employees of Mills College (the "College") and is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The College was the Plan's sponsor and served as Plan Administrator.

Since January 1, 2013, participant deferral contributions to the Plan were limited to Fidelity Management Trust Company ("Fidelity"). Assets held by Teachers Insurance and Annuity Association ("TIAA") and College Retirement Equities Fund ("CREF") remained, but no additional contributions were made by participants. Participants had the option to transfer all or a portion of their account balance from TIAA or CREF to Fidelity.

On June 30, 2022, Mills College completed a combination with Northeastern University. In connection with the combination between Mills College and Northeastern University, the Plan merged with the Northeastern University 403(b) Plan on January 1, 2023 and all plan assets were transferred to the control of the Northeastern University Retirement Plan on March 8, 2023. As a result of the Plan merger, this Plan terminated.

Effective January 1, 2023, employees of Mills College became eligible to contribute into the Northeastern University 403(b) Plan, and, since that date, no further contributions were made to this Plan.

Eligibility

Prior to the merger, all eligible employees were able to participate on a voluntary, salary reduction basis, and make elective deferrals under the Plan effective as of the first day of any month following the employee's date of employment. All eligible employees, except adjunct faculty, per course faculty, temporary and on-call employees, employees that normally work less than 20 hours per week, and faculty instructing less than 0.5 course load were eligible to receive employer contributions following fulfillment of six consecutive months of continuous employment. For purposes of eligibility for participation, credited service with an eligible employer (any public or private not-for-profit organization) during the period immediately preceding the eligible employees' date of employment with the College was counted.

Contributions

Participant contributions – Each year, participants were able to contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer match and nonelective Employer contributions – Prior to the merger, the College could elect to make discretionary matching and discretionary nonelective contributions. Nonelective contributions were allocated to participants in the same proportion as a participants' compensation bore to the total of all participants' compensation. For the period ended March 8, 2023, there was no Employer contribution.

Participant Accounts

Each participant's account was credited with the participant's contributions and Employer contributions, if any, as well as allocations of plan earnings/losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit provided from the participant's vested account.

Participant Investment Account Options

Participants directed their contributions and the College's contributions to their accounts into various investment options offered by the Plan. The Plan offered a variety of different investment options plus Target Date Funds, which included mutual funds, variable annuities, a pooled separate account and TIAA Traditional Annuity ("TIAA TA"). Participants had access to direct their contributions into additional mutual funds through a Self-Directed Brokerage Account option within the Plan, if they choose.

Vesting

Participants became vested immediately in their contributions, plus actual earning thereon. Employees became fully vested in Employer contributions after one year of service.

Forfeitures

The nonvested portion of a terminated participant's account balance was forfeited in the year the forfeitures occurred. Forfeitures were retained by the Plan and used to reduce Employer contributions or pay plan expenses. As of December 31, 2022, forfeited nonvested accounts totaled approximately \$7,900. No forfeitures were used to pay for plan administrative expenses or reduce Employer contributions for the period ended March 8, 2023.

Notes Receivable from Participants

Prior to the merger, participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participants' account. All loans had to be repaid within a period of five years or up to ten years for the purchase of a principal residence. Participants were allowed to have up to two loans outstanding. Under the terms of the Plan Agreement, plan loans bore interest at prime plus 2%. Principal and interest were paid ratably directly to Fidelity. As of December 31, 2022, the rates of interest on outstanding loans ranged from 4.25%-7.50%.

Plan Loans

Loans to participants were promissory note agreements executed by the participant and TIAA and CREF. Participants were required to transfer an amount from their account balance equal to 110% of their outstanding loan balances from their fund accounts to the TIAA TA to be held in collateral of the loans. This collateral remained invested in the Plan and the participants continued to earn TIAA TA contractual interest and additional amounts as declared by TIAA's Board of Trustees. If participants default on their loans, TIAA and CREF removed the portion of the collateral held in the TIAA TA equal to the participants' outstanding loan balances plus any unpaid accrued interest to pay off the defaulted loans. Participants had the ability to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the participant's vested account balance. Loan terms ranged from one to five years or up to ten years for the purchase of a primary residence. Loan interest rates were determined by TIAA and CREF and ranged from 4.31%-6.64% in 2022. Principal and interest were paid by the participant directly to TIAA and CREF. The outstanding loan balance due to TIAA and CREF as of December 31, 2022 was \$15,037.

Payment of Benefits

On termination of service, a participant could have elected to receive a lump-sum amount equal to the value of the participant's vested account balance, or annual installments over a period of time, as permitted by the participant's fund vehicles. The Plan Administrator was able to enforce a mandatory distribution following termination of employment if the participant's account balance is below a certain threshold.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Prior to the merger, investments were reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment custodian. See Note 3 for discussions of fair value measurements.

Net appreciation includes realized gains and losses on investments sold and the change in the investments held during the period. The cost of investments was determined using the average cost basis in calculating realized gains or losses.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date.

Notes Receivable from Participants

Prior to the merger, notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and expensed when incurred. No allowances for credit losses was recorded at December 31, 2022.

Unit Values

Individual participant accounts for the pooled separate and variable annuity investment accounts were maintained on a unit value basis. Participants did not have beneficial ownership in the specific underlying securities or other assets in the funds but did have an interest therein represented by units which are valued daily. The funds earned dividends and interest, which were automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund were converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts were charged or credited with the number of units properly attributable to each participant.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Contributions

Participant and College contributions were recorded in the period in which the College makes payroll deductions from the participants' wages.

Payment of Benefits

Benefits were recorded upon distribution.

Administrative Expenses

General plan administrative expenses may have been paid out of the forfeiture account or paid by the College. Investment management, distribution, and loan transaction fees were paid by the Plan participants.

Risks and Uncertainties

The Plan invested in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 3 Valuations using unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the investments and valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2022.

Mutual Funds and Self-Directed Brokerage Accounts

Mutual funds and self-directed brokerage accounts (100% mutual funds) are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end. Fidelity's mutual fund offerings are redeemable on a daily basis. Mutual funds offered by TIAA and CREF are generally redeemable every 30 days. However, some of TIAA and CREF's mutual fund offerings incur a 2% fee if redeemed in less than 60 days from purchase. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Variable Annuities

The accounts invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. The fair values of accumulation units held by the Plan in CREF Variable Annuity accounts are based on each account's daily NAV, which is considered by Plan management to be the best approximation of fair value. Data for NAVs are available daily to Plan management and client investors on TIAA and CREF's website and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. There are no unfunded commitments from participants in the Plan who invest in these accounts. The variable annuities are measured at net asset value and are redeemable daily with one day's notice.

Pooled Separate Account - TIAA and CREF Real Estate Account

The account generally invests in real estate properties and real estate-related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on a professional's opinion. The account sometimes holds securities as well, and these securities are generally priced using values obtained from independent pricing sources.

The fair value of the Plan's interest in the TIAA Real Estate Account (a pooled separate account) is based on the fund's daily NAV, which is considered by Plan management to be the best approximation of fair value. The unit value of the fund is calculated daily and available to Plan management and client investors on TIAA and CREF's website. There are no unfunded commitments from participants in the Plan who invest in this account. The Pooled Separate Account may be redeemed quarterly with one day's notice.

TIAA Traditional Annuity ("TIAA TA")

The TIAA TA is a fixed annuity unallocated insurance contract fully and unconditionally guaranteed by TIAA. Contributions to TIAA TA buy a contractual or guaranteed amount of future benefits for the employee. TIAA TA contracts issued by TIAA are unconditionally guaranteed by its general account. The Traditional Annuity is offered through a variety of contract types. Only Retirement Annuities (RA) contracts are offered by the Plan. RA contracts are non benefit-responsive investment contracts. The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claim-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

Investments in the TIAA TA were not allowed to be immediately withdrawn or transferred to other plan assets. Withdrawals and transfers are restricted to ensure account performance. Requested withdrawals or transfers (transfer payout annuity assets) are paid out over a ten-year period in equal increments per year.

The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over ten annual installments. When a participant's accumulation in the TIAA TA is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the Statement of Changes in Net Assets Available for Benefits. Operating expenses are deducted from TIAA TA earnings.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2022 was \$22,832,859. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates are periodically reviewed for resetting.

Certain events limit the ability of the Plan to transact at fair value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The preceding methods described may have reduced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value at the reporting date.

The categorization of an investment within the fair value hierarchy was based upon the pricing transparency of the investment and does not necessarily correspond to Plan management's perceived risk of that investment.

During the period ended March 8, 2023 and for the year ended December 31, 2022, there were no Level 3 investment purchases made.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The significance of transfers between levels is evaluated based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the period ended March 8, 2023 and the year ended December 31, 2022, there were no transfers in or out of Level 3.

Quantitative Information about Significant Unobservable Inputs Used in Level 3 Fair Value Measurements for the Non Benefit-Responsive Contracts (RA)

The fair value of non benefit-responsive traditional investment contracts at December 31, 2022 totaled \$22,832,858 with the discounted cash flow using a risk adjusted discount rate used as the principal valuation technique.

The crediting interest rate for RA contracts for the period ended March 8, 2023 was 6.125%. The crediting interest rate for 2022 for RA contracts was 5.68%.

4. Guaranteed Investment Contracts with Insurance Companies

The Plan held two fully benefit-responsive traditional guaranteed investment contracts with TIAA and New York Life Insurance Company (New York Life) that are reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

The value of fully benefit-responsive investment contracts was \$2,951,646 and \$2,444,735 for TIAA Traditional Benefit Responsive and New York Life Insurance Company, respectively, for the year ended December 31, 2022.

TIAA maintained the contributions in its general account and guarantees the Plan a return of principal and interest under the terms of the contract. The crediting interest rate is updated annually based upon contract provisions, and it may not be less than 3%. TIAA's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no conditions specified in the TIAA contract under which participant withdrawals and transfers would be restricted or made at a value other than contract value or the annuity or lump-sum benefit, as defined in the contract. The contract does not provide any provisions that would allow TIAA to terminate the contract between TIAA and the participants.

New York Life maintained the contributions in its general account. The crediting interest rate is updated semi-annually based on contract provisions and may not be less than the lesser of 3.00% or 1.00% plus the six-month average of the five-year constant maturity treasury rate as reported by the Federal Reserve, less 1.25%.

The New York Life investment contract specified certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the College, and certain other College initiated events that may have a potential adverse financial, legal or administrative impact on New York Life. Either the College or New York Life may terminate the contract with at least 30 days written notice prior to the termination date, with termination payments made at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact at less than contract value is not probable.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments were shares of mutual funds and other investment products which were managed by Fidelity, TIAA and CREF and TIAA as agent for TIAA FSB. Fidelity, TIAA and CREF and TIAA as agent for TIAA FSB were the Plan Custodians and, as such, these transactions are considered as party-in-interest transactions. During the period ended March 8, 2023, the Plan received revenue credits of \$11,641 and \$0, from Fidelity and TIAA, respectively. The Plan used \$9,213 of these credits to offset Plan expenses from Fidelity. The Plan allocated net credits of \$2,428 to participants from Fidelity, which are reported as other income on the Statement of Changes in Net Assets Available for Benefits.

6. Tax Status

The Plan adopted the Fidelity Workplace Services LLC Volume Submitter 403(b) Plan that received an IRS opinion letter on August 7, 2017 which stated that the Plan is acceptable under Section 403(b) of the Internal Revenue Code (the "Code") for use by eligible Employers for the benefit of their employees. The Plan Administrator believes that the Plan was designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Subsequent Events

Management has evaluated the impact of subsequent events through February 6, 2024, the date the financial statements were available for issuance. There were no significant matters identified for disclosure during the evaluation.

8. Certified Financial Information

Plan investments were held by the Plan's custodians, Fidelity Management Trust Company, TIAA and CREF and TIAA as agent for TIAA FSB. The fair and contract values of investments as of December 31, 2022, and all investment transactions for the period ended March 8, 2023, including interest and dividends and net appreciation in fair values were reported to the Plan and certified as complete and accurate by the custodians.

The following is a summary of Plan investment information and data certified by the Plan's Custodians as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

All information presented below and in Note 3 was certified as complete and accurate by the Custodians.
